BURLINGTON COUNTY NJ POLICE EXPERIENCE SURVEY NAACP

The Southern Burlington County, Willingboro & Vicinity and Greater Delaware Valley Branches of the NAACP are collaborating on a Police

Experience Survey. This survey will provide an up-to-date account of the relations between residents and their police departments.

Marcus Sibley, president of the Southern Burlington County Branch said So many people speak about issues with police, but now there's an anonymous survey where everyone can let their voice be heard.

Will Weston, first vice president of the Willingboro and Vicinity Branch, said he hopes the combined effort of the three organizations can get people to respond and make a great impact.

Rhonda Sessions, Greater Delaware Valley's first vice president said, We are advocating for adequate funding for the recruitment of more diverse police departments. With the help and unanimous support of all the NAACP Burlington County branches, this survey provides a way for the voices of the black and brown communities to be heard loud and clear.

The survey comes on the heels of the police response to the arrest of Mount Laurel hate-crime suspect Edward Cagney Mathews in July. Numerous African American neighbors said Mathews had allegedly harassed them for years and police took little action until a video of him on social media went viral.


