



READING NOOK



It's hard to nail down one single fix for issues of gender violence from the pages of "Believing." Dive in, dig around, surface for air, and dive in again – truth is, the whole entire book is one long roadmap,

with dozens of possible patches.

And yet, you may ask yourself if what author Anita Hill quietly suggests is enough. Takeaways from the stories she shares are that gender violence and sexual harassment can be like a long game of Whack-a-Mole: once an incident is dealt with, another will pop up somewhere else, relentlessly, endlessly. Using the Thomas hearings as scaffolding here, she seems to show that while politics absolutely plays a part in the presence of harassment and gender violence in America, the prevalence can be found everywhere and costs us more than just psychologically.


Discouraging? Yes, and even Hill admits that such information can be triggering if you've been a victim, so read "Believing" with caution and deep-breathing room. It's powerful, deep, and raw but it's also highly informative. If you want to know where we're heading on this subject, it's the book to grab.

Booster Shots

Now Available for Everyone 12 and Older



12- through 15-year-olds are now eligible for a Pfizer COVID-19 booster shot. In addition, the Center for Disease Control now recommends that everyone ages 12 and older get a booster shot at five months after their two-dose series instead of after six months.

Studies show that after getting vaccinated against COVID-19, protection against the virus and the ability to prevent infection with variants may decrease over time. Booster doses provide necessary protection against waning immunity.

The recent emergence of the Omicron variant further emphasizes the importance of vaccination, boosters, and prevention efforts needed to protect against COVID-19.

Booster shots are available to everyone 12 and older:

- Two months after their one-dose Johnson & Johnson shot, or
- Five months after their last Pfizer shot or Moderna shot

Civil Rights Icons Remembered



Sidney Poitier's roles put civil rights issues on the big screen and Desmond Tutu, was a man committed to justice and peace.

U.S. President Barack Obama presented the Medal of Freedom to veteran actor Sidney Poitier and Anglican Archbishop Desmond Tutu of South Africa during a ceremony at

the White House in Washington Aug. 12, 2009. Archbishop Tutu died at age 90 on Dec. 26, 2021 and Sidney Poitier died at age 94 on Jan. 5, 2022.
