WAIVER, RELEASE, INDEMNIFICATION

THIS IS A WAIVER OF RIGHTS, AGREEMENT NOT TO SUE **AND INDEMNIFICATION AGREEMENT**. YOU ARE GIVING UP LEGAL RIGHTS BY SIGNING THIS DOCUMENT. THE EXECUTION OF THIS DOCUMENT IS A CONDITION TO ENTERING THE **HEARST RANCH** AND PARTICIPATING IN THE HORSEBACK RIDING AND ALL VAQUEROS DEL DESIERTO ACTIVITIES.

1. Vaqueros Del Desierto is a non-profit social organization whose members have joined together to promote their mutual interest in trail riding. Each Club event is organized by members who donate their time and property to the Club without compensation.

2. I acknowledge that trail rides, horse sports, and other activities associated with Vaqueros Del Desierto **2024 HEARST RANCH TREK** (Activities), are dangerous activities, and that participation in the Activities as a participant, individual contractor, or volunteer (collectively "Participant") exposes the Participant to a substantial and serious risk of property damage, personal injury or death.

3. I acknowledge that participation in the Activities will involve such hazards. I hereby agree to assume those risks and to release and to **indemnify and** hold harmless all the persons or entities mentioned herein from any and all costs and expenses (**including, but not limited to attorney fees, expert fees, if any**) arising out of or in connection with the Activities.

4. Being fully aware that participation in the Activities will expose me to substantial and serious risk of property damage and/or personal injury or death, and in consideration for having been given permission to enter upon that real property commonly known as the **HEARST RANCH**, I release Vaqueros Del Desierto and the **HEARST RANCH LANDS**, and the owners, or any successors-in-interest and their respective officers, directors, employees, **members, partners, trustees**, attorneys and agents of each entity which I may have, or which may hereafter accrue to me or my heirs as a result of my participation in the Activities which may be sustained, including any claims that are known and unknown, foreseen and unforeseen, future and contingent.

5. I shall not now or at any time in the future, directly or indirectly, commence or prosecute an action, suit or other proceeding against **all the persons or entities mentioned herein**, arising out of or related to the **Activities**, actions, causes of action, claims and demands hereby waived, released, or discharged by me. This release shall be binding upon me and my spouse, legal representatives, heirs, successors and assigns.

REPRESENTATION OF RIDERS

As a further consideration for having been given the permission to enter upon the real property commonly known as the **HEARST RANCH** and to participate in all events and activities associated with the **2024 JUNE TREK** ("The Ride"), I represent to the Vaqueros Del Desierto and to the **HEARST RANCH LANDS and their respective owners, successors and assigns** that:

1. I currently have comprehensive liability policies providing:

a. Medical coverage: and

b. Liability coverage for property (at least \$10,000 coverage) and bodily injury claims (coverage of at least \$100,000 per person and \$300, 000 per occurrence).

2. These insurance policies will remain in effect during all activities associated with the **2024 HEARST RANCH TREK**.

3. Participant confirms and agrees Participant has sole responsibility for knowing the range of the ability of Participant to manage, care for, and control his horse and to act within the limits of Participant's ability to maintain control of any equine at all times, to heed posted warnings, and to refrain from acting in a manner that might cause or contribute to the injury, damage, or death to property or the persons or entities named herein, and other Participants in the Ride, arising out of or in connection with the Activities.
