302.2 CARPET. CARPET OR CARPET TILE SHALL BE SECURELY ATTACHED AND SHALL HAVE A FIRM CUSHION, PAD, OR BACKING OR NO CUSHION OR PAD. 




FIGURE 308.2.2 OBSTRUCTED HIGH FORWARD REACH







FIGURE 404.2.4.1 MANEUVERING CLEARANCES AT MANUAL SWING DOORS AND GATES




FIGURE 404.2.6 DOORS IN SERIES AND GATES IN SERIES





FIGURE 604.7 DISPENSER OUTLET LOCATION







FIGURE 607.4.2 GRAB BARS FOR BATHTUBS WITH REMOVABLE IN-TUB SEATS **607.4.2 BATHTUBS WITHOUT PERMANENT SEATS.** FOR BATHTUBS WITHOUT PERMANENT SEATS, GRAB BARS SHALL COMPLY WITH




FIGURE 904.3.2 CHECK-OUT




ENLARGED PLAN - 114 - RESTROOM
