- Item 3. Public Comment.

Item 9. The Executive Committee reconvened in Open Session. Judge Williamson presented for consideration approval for the ATCOG Executive Director to proceed with acquiring property for a Paris Metro/TRAX Transportation office in Paris, Texas.

Motion to approve was made by Mayor Sellers and seconded by Judge Brian Lee. It was approved.

Item 10. Mary Beth Rudel, Deputy Director, presented for consideration approval of the appointment of a new officer to the Ark-Tex Urban Transit, Inc. (ATUT) Board of Directors.

Judge Williamson asked Ms. Rudel if approval of the appointment would remove Owetta Walton, Director and Secretary/Treasurer, from the ATUT Board of Directors. Ms. Rudel answered yes, that approval of Item 10 would remove Ms. Walton from the ATUT Board of Directors.

Motion to approve was made by Marc Reiter, Mayor Pro Tem, City of Hooks, and seconded by Judge Brian Lee. It was approved.

Item 11. Mae Lewis, Housing Director, presented for consideration approval of amending the Ark-Tex Council of Governments Housing Choice Voucher Program Annual and 5-year Plan effective October 1, 2020.

Item 13. Ms. Haley presented for consideration approval of the Regional Criminal Justice Advisory Committee (RCJAC) grant application scoring instrument to be used for Commercially Sexually Exploited Youth (CSEY) applications.

Item 14. Mark Compton, Transportation Director, presented for consideration approval of the purchase of 45 Aeroclave Vehicle Decontamination Systems for the TRAX Transportation transit fleet.

Judge Brian Lee asked Mr. Compton if the Aeroclave Vehicle Decontamination Systems would be used following the COVID-19 pandemic. Mr. Compton answered yes, the decontamination systems would be used permanently following the COVID-19 pandemic. Mr. Compton added that the Aeroclave Vehicle Decontamination Systems would replace manual decontamination, and would be capable of decontaminating TRAX buses within 5 minutes.

Mayor Ransom asked Mr. Compton if the Aeroclave Vehicle Contamination Systems would be purchased through a local vendor, and if there was competitive bidding for the purchase. Mr. Compton answered that the decontamination systems would be purchased utilizing the Oklahoma Transit Contract through Creative Bus Sales, which is where TRAX buses are purchased from.

Motion to approve was made by Judge Newsom and seconded by Judge Howell. It was approved.

Item 15. Brianna O'Shaughnessy, Development Specialist, presented the Development Newsletter.

Ms. O'Shaughnessy shared that this quarter's newsletter will include information on regional development, economic development and local resources. She added that the goal of the Development Newsletter is to provide comprehensive information to community members and businesses at least once a quarter. The Development Newsletter will be sent at the end of each quarter beginning in March 2021.

Mr. Brown added that he will contact the county judges and city mayors on scheduling the meeting.

Mr. Brown shared that ATCOG's Area Agency on Aging has been successful in assisting seniors with registering to receive the COVID-19 vaccine. He asked that Executive Committee members please advise additional seniors in the region to contact the Area Agency on Aging if they need assistance with registration.

# **MINUTES**

The meeting of the Ark-Tex Council of Governments Homeland Security Advisory Committee was called to order by **Whitney Fezell** at 10:04 a.m., March 18, 2021, via conference call.

Whitney Fezell provided the minutes from December 18, 2020 meeting, Andy Endsly made the motion to approve the minutes, seconded by Jason Ricketson.

Whitney Fezell provided the committee with a homeland security update. The committee was informed with FY2020 project expenditures, as well as grants that needed to be closed. The committee was notified of the recent THIRA feedback scores. Whitney Fezell informed the committee of cybersecurity funds available for training. The committee was also informed of the online active shooter training opportunities. Whitney Fezell updated the committee regarding the changes to the OOG and Fema funding. The committee was informed that the region will receive a allocation as they have in previous year. The committee was also informed of the states 4% decrease in funding.

The first voting item on the agenda was chair and vice chair elections. The committee was advised of the current chair and vice chair as well as past officers. Danny Richard made to motion to elect Becky Wilbanks as chair and Andy Endsley as Vice Chair. Motion seconded by Jason Ricketson and approved by majority.

The next voting item on the agenda was to discuss and approve date and logistics of the Annual Communication Exercise. Whitney Fezell advised the committee that we did not complete the annual communication exercise last year and that it would be beneficial to go through with the exercise this year. Dates were proposed for March 18- June 30. No vote was taken.

The last voting item is to prioritize FY2021 State Homeland Security Program funding projects via ballot. Whitney Fezell gave the committee voting instruction and discuss components of the ballots/ Risk Methodology/ scoring process. Whitney Fezell proposed that each attending member complete their ballot and submit it back via email at the end of the meeting. Scores will be calculated by ATCOG (including risk score and bonus points) and prioritization listing will be sent out once all ballots are verified and scores calculated. Jason Ricketson made a motion to accept the ballots submitted as the prioritization, motion seconded by Danny Richard and approved by majority.

Becky Wilbanks opened the floor for questions and discussion.

# MINUTES

The Ark-Tex Council of Governments (ATCOG) Regional Criminal Justice Advisory Committee (RCJAC) met April 6, 2021 1:00 p.m., by teleconference via ZOOM.

Patricia Haley welcomed everyone on the call and allowed extra time for others to join before calling the meeting to order.

Darrell Bruce, Chairman, called the meeting to order at 1:06 p.m.

Patricia Haley performed a roll call to record those present on the teleconference. First, a roll card of RCJAC members was performed, followed by applicants and then other visitors. There were a total of 40 present on the teleconference. A quorum was confirmed.

Darrell Bruce introduced and welcomed Mark Buhman as a new member on the committee.

The minutes from the February 11, 2021 meeting were reviewed and a motion was made by Sherry Edwards and seconded by Bob Hundley to approve the minutes as presented. The motion carried.

Patricia Haley gave an update of CJD's funding allocations for the ATCOG region, according to each fund source. An explanation was given regarding the separate fund sources for the Juvenile Justice and Truancy Prevention categories. The CSEY scoring category (only 1 application) was explained as a new funding category with a different scoring sheet and scoring instructions.

Patricia Haley emphasized the step-by-step instructions previously sent to RCJAC members regarding how to complete, save, compress score sheet files to a zip folder, and then how to send them to her by email. Also reviewed were the maximum points allowed for each question, the local priorities, conflict of interest policy, and the fact that there were no applicants on vendor hold. It was also mentioned that if recommending a different funding amount from the original amount requested by the applicant, that RCJAC member would need to enter the amount on the second page of the score sheet with their explanation, and any RCJAC member recommending a different amount must present that amount for discussion/review and it must be approved by a consensus vote of those RCJAC members present. She also gave a reminder for each RCJAC member to review the verification statement located above the signature space on each score sheet and include their name/electronic signature on each score sheet. Ms. Haley also

emphasized for the RCJAC members to electronically submit their score sheets as soon as possible after meeting, and if anyone had any issues with submitting electronically, please call Ms. Haley as soon as possible and a solution would be found to get their score sheets submitted successfully.

Darrell Bruce announced that each presenter would have a maximum of 5 minutes to speak about their project, followed by an opportunity for RCJAC members to ask questions about their project. There would be a pause between applicant presenters to allow the committee members time to complete each score sheet. All applicants were present and spoke about their project(s) in the following categories:

Violent Crimes Against Women Criminal Justice & Training Projects (VAWA) (2) were presented as listed on the attached page.

General Victim Assistance – Direct Services Programs (VOCA) (3) were presented as listed on the attached page.

Juvenile Justice & Truancy Prevention Programs (3) was presented as listed on the attached page.

Justice Assistance Grant Program (JAG) (12) were presented as listed on the attached page.

Residential & Community Based Services for Victims of Commercial Sexual Exploitation of Youth Grant Program (CSEY) (1) was presented as listed on the attached page.

Darrell Bruce, Chairman, asked Patricia Haley if any notarized letters with absentee scores were submitted prior to the meeting, and Ms. Haley said there were no absentee scores submitted.

Patricia Haley announced that she hoped to have the scores/rankings available to the grant applicants by the end of the following day, but would have them sent within 2 days.

Patricia Haley asked if there was anyone else on the call who was not recorded during the original roll call and there were no additional responses.

# Environmental Quarterly Report January – March 2021

- Illegal Dumping Surveillance Camera Loan Program 10 camera systems and 20 "No Dumping Signs have been loaned out in Bowie County, and are deployed in the cities of Nash, DeKalb, Simms and in rural areas of the county. ATCOG currently has 14 camera systems and 65 signs are available for illegal dumping enforcement.
- FY21 Solid Waste Grant Funds, in the amount of \$40,500.00, are being equally divided between each of the nine counties within the ATCOG region for illegal dumping cleanup / community collection events, including tire collection events. Each county has access to \$4,500.00, once memorandums of understanding are signed and executed. ATCOG is also in the process of updating the 20 Year Regional Solid Waste Management Plan and has contracted with Texas State University to provide the updates. This plan is due to TCEQ by 2022 for review and approval.
- FY 21 Water Quality Grant Funds, in the amount of \$13,475.00, are being utilized to conduct non-point source pollution activities within the ATCOG region. Activities include: Providing educational materials to the public relating to water pollution and conservation practices, composting and gardening techniques, proper lawn care methods and pet waste disposal. Compost bins have been provided to local Master Gardener Associations within the region to help promote the utilization of natural fertilizers, and 2,000 disposable nitrile gloves have been distributed to local volunteer water quality monitors associated with the Texas Stream Team. These volunteers monitor the condition of local waterbodies including creeks, rivers and lakes on a weekly basis, utilizing chemical test kits and electronic meters. The results are provided to Meadows Center for Water and the Environment at Texas State University, to be complied and presented to TCEQ on an annual basis.
- ATCOG has joined the Texarkana Brownfields Regional Environmental Coalition which submitted an application to the Environmental Protection Agency for a Hazardous Substances and Petroleum Assessment Grant in the amount of \$600,000.00 to be utilized at various sites located within Bowie County, Texas and Miller County, Arkansas. Coalition members include ATCOG, TexAmericas Center, the City of Texarkana, AR and the applicant, the City of Texarkana, TX. This funding, if awarded, will help boost redevelopment activities at key locations which are currently underutilized due to perceived or actual environmental contamination. Awards are expected to be announced in April or May.
- ATCOG has been selected to administer the Region 2 Lower Red-Sulphur-Cypress Regional Flood Planning Group grant program funded by the Texas Water Development Board. Funding, in the amount of 910,400.00, will be utilized to develop a flood plan in a region comprised of 20 counties located in northeast Texas. The plan is due to the TWDB in January of 2023 and is required to be updated every 5 years.

**Project Description:** The City of Winfield has applied to the Texas Commission on Environmental Quality (TCEQ) for renewal of Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0012146001, to authorize the discharge of treated wastewater at a volume not to exceed a daily average flow of 84,000 gallons per day. The domestic wastewater treatment facility is located approximately 400 feet north of IH-30 access road and 1,500 feet west of FM 1734 in the City of Winfield, Titus County, Texas. The discharge route is from the plant site to an unnamed tributary of Smith Creek; thence to Smith Creek; thence to Lake Monticello; thence to Lake Bob Sandlin.

# PROJECT/EA REVIEW:

Area to be served: Winfield, Titus County, Texas.

**Does the project comply or furnish reasonable assurances of compliance with applicable federal, state, and local laws, regulations, and ordinances?** Yes. The TCEQ executive director has completed the technical review of the application and prepared a draft permit.

Is the project consistent with state, area wide, and/or local planning or does it contribute toward goals or objectives identified at one or more of governmental levels? Yes. This permit application meets all statutory and regulatory requirements.

Has this project been coordinated through the Texas Commission on Environmental Quality? Yes, coordination is in progress.

**Does the project address a clearly defined need and does the project take into account preservation of the environment?** There is a clearly defined need for the renewal of this TPDES Permit to allow the continued operation of the domestic wastewater treatment facility. This facility serves the needs of all residents living within the City of Winfield. All guidelines required by TCEQ to protect the environment are being followed, thus minimal disruption of the environment is expected.

**Is the project likely to produce any significant adverse effects on the environment?** No. The renewal of this permit will not authorize an increase in the number gallons of treated wastewater that can be discharged into the environment. This facility is in good operational condition. Before being discharged, the water passes through particulate filters and is then piped to a sedimentation pond located at this facility.

#### BACKGROUND:

Each year, applications are submitted to CJD through eGrants by agencies/organizations in the ATCOG region. After the applications have been submitted, CJD requires ATCOG to distribute the applications to the RCJAC to be reviewed and scored.

#### DISCUSSION:

The Regional Criminal Justice Advisory Committee (RCJAC) met by teleconference on April 6, 2021 and applicants gave a brief presentation about their project. RCJAC members then had an opportunity to ask questions to each presenter regarding their application/project. Applications were scored by the 18 RCJAC members present, using the previously approved scoring instruments and those scores were averaged and ranked.

#### **RECOMMENDATION:**

Staff recommends approval of the priorities/recommendations of the VAWA/VOCA/JJTP/JAG categories as presented, based on the scores and rankings of the Regional Criminal Justice Advisory Committee (RCJAC), and also recommends approval of the RCJAC's priorities/recommendations of the CSEY based on the CJD/CSEY core elements presented by the CSEY applicant and the 1-5 scoring scale required by the OOG/CJD. Upon approval, these priorities/recommendations will be submitted to the Office of the Governor, Criminal Justice Division (CJD), and OOG/CJD will evaluate the projects for funding consideration.

#### ITEM 12:

Review and consider approval of the submission of an Older Adult Home Modification Program application to the U.S. Department of Housing and Urban Development.

#### BACKGROUND:

The U. S. Department of Housing and Urban Development (HUD) has issued a Notice of Funding Availability to invite applications for the Older Adult Home Modification Program. The goal of the home modification program is to enable low-income elderly persons to remain in their homes through low-cost, low barrier, high impact home modifications to reduce older adults' risk of falling, improve general safety, increase accessibility and to improve their function abilities in their home. This will enable older adults to remain in their homes, that is, to "age in place," rather than moving to nursing homes or other assisted care facilities.

#### DISCUSSION:

ATCOG's goal is to utilize the funding for home modifications for homeowners who are lowincome, to enable the homeowners to live in the home for as long as possible, safely. The Area Agency on Aging and the Housing Department staff will work together on this project. The application amount is \$500,000, and the funding will allow the AAA to provide home modification services that have not been allowed by State funding. There is a cap of \$5,000 per household, unless approved by HUD. The entire ATCOG region will be eligible for this service.

#### **RECOMMENDATION:**

Staff recommends approval of the submission of the HUD Older Adult Home Modification Program application.

perating under the umbrella of the Ark-Tex Council of Governments, with its headquarters in Texarkana, TX, TRAX Rural Public Transportation services a nine-county area in northeastern Texas.

The Ark-Tex Council of Governments is a voluntary association of local governments established under state law to promote intergovernmental cooperation and strengthen units of local government. Its primary goal is to improve the quality of life for all citizens of the region by providing resources, programs, and services (including public transportation) and coordinating funding.

"TRAX's service region encompasses about 6,400 square miles," said Bobby Williams, TRAX operations coordinator, during a recent interview with Busline Magazine.

To put the agency's service region in perspective, 6,400 square miles is larger than, or nearly as large, as six states - Massachusetts, 7,838 square miles; New Jersey, 7,419 square miles; Hawaii, 6,423 square miles; Connecticut, 4,845 square miles; Delaware, 1,955 square miles; and Rhode Island, 1,034 square miles.

TRAX provides low-cost transportation for Bowie, Cass, Delta, Franklin, Hopkins, Lamar, Morris, Red River, and Titus counties from passengers' homes or other designated pickup points.

Texarkana is located in the far northeastern corner of Texas. The city straddles the Texas/Arkansas state line. TRAX's service region lies to the west, southwest, and northwest of Texarkana and

"Many of the counties in the region don't have hospitals or other service providers," Williams said. "TRAX is the only public transportation agency in the region that provides demand/response service."

TRAX vehicles travel a yearly average of about 104,000 miles. The average annual ridership is 114,000 trips, Williams said.

While not limited to, TRAX's primary ridership demographic is people 60 years old and older. Rural transportation's primary mission is to transport people to grocery shopping, pay bills, doctor appointments, dialysis centers, to the bank, to the beauty shop, to and from work, wherever riders need to go, Williams said.

"The majority of our riders are seniors," Williams said. "However, in Titus County, there is a large chicken processing plant. So, in that area, we take a lot of people to and from work. We go as far as taking people to the movies."

A separate agency, the T-Line Bus System, also operating under the Ark-Tex Council of Governments, provides fixed-route service in Texarkana.

In 2016, TRAX introduced the Paris Metro Service, located in Paris, TX, about 94 miles west of Texarkana, which operates four fixed-routes and paratransit service.

For its fixed-routes, Paris Metro daily operates four Freedom bus models from ARBOC Specialty Vehicles, with one Freedom bus in reserve, Williams said.

"In October 2019, **Mark Compton** and I were invited to visit ARBOC's manufacturing facility in Middlebury, IN," Williams said. "ARBOC representatives introduced us to the Freedom model. We liked the vehicles, and, not only that, we were impressed by the professionalism displayed by ARBOC's sales reps and managers."

In addition to the ARBOC buses currently in use in Paris, TRAX has four more buses on order, making nine Freedom buses in TRAX's fleet. The new buses are expected to arrive by the end of May or early June.

"We recently finished a route study for Paris. Also, we are in the process of purchasing a new transit facility in that location. Hopefully, we will have that transaction finished by April or May, and, after that, we are going to look at expanding service," Williams said. THE STORM AND COVID

In mid-February, an unprecedented winter storm hit Texas and many other states. The storm caused the deaths of at least 26 people in Texas, according to *cnn.com*. Millions of people lost their power, forcing families to huddle over a fireplace, scavenge for firewood or spend nights in their car trying to stay warm. Others spent hours searching for food as shelves emptied and weather conditions led to food supply chain problems. The frigid temperatures caused pipes to burst, leading to water disruptions for roughly half the state's population.

COVID-19 relief efforts, including food banks, were shuttered. Vaccine shipments were delayed, and many canceled appointments, the CNN report said.

Ultimately, the catastrophic weather event caused TRAX and the T-Line Bus System in Texarkana to pull their vehicles off the road.

"We heard on the news it was going to be pretty bad, but we didn't think it was going to be as bad as it was," Williams said. "Fortunately, our supervisors sprang into action right away. We contacted operators to inform them of what we might be facing and let them know we would pull them off the road if conditions worsened.

"It got worse, and we pulled them off the road for a week. Our employees are very valuable. We didn't want to endanger our operators' lives by having them on the road.

"On Monday, Feb. 22, at about 4:30 a.m., our supervisors checked service areas to make sure the bridges and overpasses were safe. Based on their reports, we gave the OK to put our vehicles back in service by 6:30 a.m.

"All office workers are continuing to work from home. Before the storm, the majority

of us were already working from home because of COVID. We conducted all meetings via Zoom."

The winter storm crisis was a double whammy, as it occurred on top of the state's ongoing battle with the COVID-19 pandemic.

Indeed, as of March 5, there have been at least 2,683,840 cases and 44,920 deaths in Texas, since the beginning of the pandemic, according to a *New York Times* database.

Similar to the storm, as the COVID-19 crisis began to ramp up, TRAX officials did not think the pandemic would become as serious as it did.


"We listened to reports saying COVID was not as bad in the U.S., as it was in other countries," Williams said. "When it hit us hard, a lot of things changed dramatically all over the country.

"In response to COVID-19, we had to step up cleaning and disinfecting procedures significantly. We had to spend money to install sanitizers in our stations. We followed CDC guidelines for social distancing and enforcing limited seating.

"We had to make some moves immediately because we still had passengers, especially those on dialysis, who needed to get to doctor's appointments. People also desperately needed to go to the grocery store.

"We provided protective equipment supplies to all of our operators. We ordered supplies before some other agencies even thought about it.

"Our transit director has a military background, and he insisted we



had to act immediately, while, in the back of my mind, I was thinking, 'It hasn't even hit us that hard yet.'

"I am thankful for him, as it wasn't long before other agencies were running out of protective items. It wasn't good. People couldn't buy gloves and masks anywhere. However, we had enough supplies that we could give other agencies a few cases of gloves and masks. We were prepared and well stocked because (Compton) took action immediately."

In the ensuing weeks and months, as the pandemic continued to ravage the country, TRAX officials decided to ramp up their efforts in combating the virus.

"We really wanted to make sure our operation was safe. We purchased fiberglass barriers to protect operators. For our ARBOC city buses in Paris, we purchased ProAir HEPA-3 air filter systems, which filter the air for COVID, or any other type of virus," Williams said. "It is a wonderful product, and I'm

hoping other agencies purchase them with the available funding.

"Also, we recently were approved to purchase AeroClave decontamination foggers to be placed in all of our vehicles. At the end of the day, when the operator gets ready to go home, he/she will turn on the fogger for five minutes, and it will decontaminate the entire vehicle. It is a really good system. It is expensive, but our operators and passengers are worth it."

In addition, every other seat in our Metro buses was blocked to

accomplish social distancing. To make up for the buses' limited capacity, supervisors in other vehicles do what the agency calls "following." That is, the supervisor will follow behind the city bus and pick up any overflow passengers at a bus stop.

Williams lauded the dedication and courage of TRAX operators as they service the riding public.

"There are undoubtably passengers who are contagious, putting our operators' lives in danger every day," Williams said. "We decided to



give drivers an additional \$3 an hour essential pay that we receive from CARE funding, just to show how much we appreciate them."


As more and more people become eligible for COVID-19 vaccine shots, TRAX is working on ramping up to run a "vaccine" route.

"There will be many more people who will want to be vaccinated. We are trying to hire enough part-time operators to start a vaccine route, so we can pick up people and take them to where they can be vaccinated," Williams said. "Right now, it is kind of slow, but once they finish vaccinating seniors, I think it is going to explode, and people are going to need transportation more than ever.

"Ridership has decreased a lot because of COVID. There are many people who are afraid. I'm afraid. I was hospitalized with COVID for five days. I think once the pandemic starts dying down, people are going to want to start getting out, and I want us to be prepared. I hope we can regain the passengers we have lost during the pandemic."


#### CUSTOMER-CENTERED SERVICE – A SAFE, COMFORTABLE RIDE

RAX's customer service philosophy is anchored in supplying the service riders want, while providing information and assistance to make reaching their destinations less complex, Williams said.

"We have very professional drivers. We work hard to satisfy our passengers," Williams said. "In fact, during training, we have the following posted on the wall — 'We acknowledge that passengers are our business and that each person who contacts our organization is necessary. We treat them as guests, listen to their questions



and provide them with excellent customer service. We understand that our mission is to provide safe, reliable and on-time service. We acknowledge that while the passenger may not always be right, (he/she) still deserves dignity and respect.'

"When we conduct training, we have our operators learn that message. Furthermore, at times, we drill them on that message. Our operators are highly trained to make sure passengers are safe and comfortable."

While many public transit agencies find public meetings are a good marketing tool to help grow ridership, Williams has found just conducting public meetings has not been particularly effective for TRAX. Indeed, in the agency's large service area, it can be difficult for people, especially senior citizens, to travel to meetings.

"We visit senior centers and talk with people about public transportation," Williams said. "The majority of riders using our demand and response service are elderly."

Another successful strategy has been to develop close relationships with community leaders. Once a year, in Texarkana, area min-

isters gather for a large meeting. "I like to attend those meetings and talk about public transportation, TRAX routing and other related topics," Williams said. "Then,

at church, the ministers can help explain to their members what we do and what we offer, which has been a very successful undertaking. One result of building relationships with community leaders is, in Cass County, ridership has grown from 80 to 115 trips a month to 500 to 600 trips monthly.

"I think other transportation agencies would benefit greatly by what I call 'mingling' with community leaders who know everybody, especially in small cities and towns, such as the ones we service. We go to the main source, who are people who know people."

#### SENSITIVITY AND UNDERSTANDING

s TRAX services many elderly riders, some of whom also have medical and physical challenges, the foundation of an operator's training is based on "sensitivity" and "understanding," Williams said.

"One result of building relationships with community leaders is, in Cass County, ridership has grown from 80 to 115 trips a month to 500 to 600 trips monthly." — Bobby Williams, TRAX operations coordinator

"Other agencies might focus their operator training on other topics, but the most important part of our training revolves around sensitivity and understanding," Williams said. "We service an area that is very family oriented, so we try to make sure people are happy. We could give riders quality service and still have operators with bad attitudes, but that is not what we want."

TRAX goes to great lengths in its operator training efforts to find



and cultivate people who are able to exhibit sensitivity and understanding, especially with its elderly riders.

"Sensitivity and understanding are the main aspects of our driver training because operators must be sensitive to, and understand, their passengers' needs and disabilities," Williams said. "If an operator doesn't understand what being disabled is, whether people have mental disabilities, or mobility issues, or whatever, how can he/she be a good driver?"

New drivers at TRAX begin their training in "as-needed" positions. The idea is to give drivers the "feel" of public transportation before they are put out on their own, Williams explained. After being on as-needed status for awhile, the driver trainee will move into a full-time position as one becomes available.

> "I personally conduct a lot of the training. I've been in the business almost 23 years as a trainer," Williams said.

hly." Williams explained, "I worked as an operator for seven years. After that, I worked in the maintenance department for three years. I left the maintenance department and became a dispatcher, and now I am the operations coordinator."

Once a driver finishes initial training, he/she goes out into the field, where a supervisor rides along for four or five days, after which, the driver will be on his/her own, Williams said. After three months, Williams will ride along with new drivers to make sure they are properly servicing passengers who are using wheelchairs.

"I will make sure the wheelchair passenger is secured the right way, and that the driver displays sensitivity and

understanding while doing so," Williams said.

Once a year, TRAX has a special day-long driver-appreciation event, which includes recertification sessions in the morning. After a luncheon, award ceremonies are conducted.

"We have a really good time," Williams said. "Our employees look forward to the appreciation meeting each year."

In addition to operators, TRAX employs dispatchers, office personnel, supervisors and managers.

"We have offices in Paris and Texarkana," Williams said. "In Paris, we have three dispatchers, and there are dispatchers at our Texarkana facility, as well.

"In addition, we operate a maintenance facility in Mount Pleasant, located in the central part of our region."

#### WHAT MIGHT THE FUTURE BRING?

ny discussion about the future of public transportation will likely include the subject of how autonomous vehicles can be best utilized.

"I know, sooner or later, autonomous vehicles will be looked at by TRAX," Williams said. "I feel strongly that autonomous buses must have a transit employee on board. Computers respond to algorithms and binary codes. People act on impulses triggered by a particular situation. I rode in a vehicle that had sensors to keep it in the proper lane. Sensors are good, but sensors can't make the quick situational responses that humans can.

"We train drivers to be sensitive and understanding, but if you don't have a person onboard, what good is that? I was transporting a lady who laid down in a seat. At first, I thought she was resting, but then I realized she was in a diabetic coma. How would a computer be able to react in an emergency situation like that?"

In discussing the future of public transit, in general, Williams said it is still viewed by too many as a mode for economically disadvantaged people who can't afford a car. In contrast, it is Williams' hope that people will more and more realize the advantages of taking the bus, no matter their economic status.

"It saves money on gas, and a person doesn't have to sit in traffic jams all day," Williams said. "In addition, there are economic and environmental benefits to having a viable transportation alternative to cars."

Williams suggests that aggressive television and other media advertising campaigns, showing people what public transportation can offer, would help motivate people to give the bus a try. He spoke of a past "Meeting on the Bus" event.

"We parked one of our buses in a designated area and rolled out a red carpet. We offered some bulletins and tracts about public transportation," Williams said. "People showed up and asked, 'What is this about?' I told them, 'This bus goes to your community three times a day and takes people to Texarkana, to the doctor, or the Greyhound station — wherever they want to go.' Some people said, 'Wow. I thought you guys just picked up old people.'

"Public transportation is a rewarding career. We make a difference. There are so many people who have nowhere to go — so many who have lost loved ones. Some people have absolutely no one. When I was a driver, I had passengers tell me I was the only face they would see that day. The reward is helping people. To be able to get them where they need to go, while understanding and being sensitive to their wants and needs."
