MINUTES BUDGET/PERSONNEL COMMITTEE ARK-TEX COUNCIL OF GOVERNMENTS June 20, 2023, 9:00 a.m.

The Budget/Personnel Committee of the Ark-Tex Council of Governments (ATCOG) met at 9:00 a.m., Tuesday, June 20, 2023, via teleconference/webinar.

- Item 1. Bobby Howell, Judge, Bowie County, called the meeting to order.
- Item 2. The next order of business was to approve the Budget/Personnel Committee meeting minutes held on September 26, 2022.
 - Motion to approve was made by Mr. Stan Wyatt, NETx Municipal Water District Board of Directors, and seconded by Robert Newsom, Judge, Hopkins County. It was approved.
- Item 3. Melinda Tickle, Finance Director, presented for review and consideration a recommendation for approval of the Investment Policy that establishes procedures to be followed in investing funds for the Ark-Tex Council of Governments (ATCOG).
 - Ms. Tickle stated that the ATCOG Investment Policy has no new updates. Judge Howell recommended that ATCOG review its investment options for improved returns.
 - Motion to recommend approval to the ATCOG Board of Directors was made by Judge Newsom and seconded by Mr. Wyatt. It was approved.
- Item 4. Chris Brown, Executive Director, presented for review and consideration a recommendation for approval of the proposed Salary Schedule for ATCOG for the fiscal year ending September 30, 2024.
 - Mr. Brown presented the proposed recommendation of the FY2024 Salary Schedule, which included the maximum of an 8.7% COLA for ATCOG employees. All ATCOG employees are paid lower or are at the low end of the State salary scale. No positions at ATCOG exceed the pay of State employees in equivalent positions.
 - Motion to recommend approval of the proposed FY2024 Salary Schedule to the ATCOG Board of Directors was made by Judge Newsom and seconded by Mr. Wyatt. It was approved.
- Item 5. Leslie McBride, Human Resources Director, presented for review and consideration a recommendation for approval authorizing the Executive Director to sign the Rerate and Benefit Verification Form with Texas Municipal League (TML) Health to provide health, dental, and life insurance benefits to staff for Plan Year 2023-2024.
 - ATCOG proposes a defined contribution of \$946.54 to each employee per month, a 12% increase, or a \$101.42 increase per month. The rate of \$946.54 will pay for the basic PPO health plan. Ms. McBride stated that ATCOG would continue providing staff with four plan options. Staff can "buy up" to a more expensive plan at their own expense. Ms. McBride noted that the Rerate Notice for FY 2024 includes increased health and dental premiums; however, life insurance rates remain the same as FY 2023.

Motion to recommend approval to the ATCOG Board of Directors was made by Judge Newsom and seconded by Mr. Wyatt. It was approved

Item 6. With no further business to discuss, a motion to adjourn the meeting was made by Mr. Wyatt and seconded by Judge Newsom. It was approved. Meeting adjourned.
