Additional Funding: Review Technical Subcommittee's recommendations for spending the additional funds on additional data collection and prioritizing FMEs and FMSs for evaluation and conversion to FMPs for inclusion in the 2024 addendum to the Regional Flood Plan. In 2019, the Texas Legislature created a state and regional flood planning process administered by the Texas Water Development Board. One of 15 regions, the Lower Red-Sulphur-Cypress Regional Flood Planning Group - comprised of volunteers - was tasked with developing a regional flood plan to identify flood-prone areas and assess ways to address flooding. The Draft Regional Flood Plan is a comprehensive document identifying existing and future flood risks as well as recommendations for Flood Management Evaluations (FME), Flood Management Strategies

(FMS), and Flood Management Projects (FMP). The plan also estimates funding required to implement the solutions identified in an effort to protect life and property.
