## MINUTES ARK-TEX COUNCIL OF GOVERNMENTS NOMINATING COMMITTEE MEETING March 23, 2023

The Ark-Tex Council of Governments (ATCOG) Nominating Committee met at 9:00 a.m. on Thursday, March 23, 2023, via teleconference/webinar.

- Item 1. Bobby Howell, Judge, Bowie County, called the meeting to order.
- Item 2. The first order of business was to review and consider the approval of minutes dated September 14, 2022.
  - Motion to approve was made by Scott Norton, Executive Director/CEO, TexAmericas, and seconded by Scott Lee, Judge, Franklin County. It was approved.
- Item 3. Chris Brown, Executive Director, presented for discussion and approval of a recommendation for appointing Board members to the Executive Committee.
