## ***WATCO/Sicut Rail Spur (July 2021-August 2021)***

Halcomb has completed their portion of work on a new rail spur in Kansas. This job included clearing and grubbing, debris removal, grading, excavation and embankments, erosion control, stone placement, proof rolling, etc. Halcomb provided equipment, operators, supervisors, materials, etc.

## ***US Army Corps of Engineers (USACE) Levee Project (February 2020-August 2021)***

Halcomb provided support as a subcontractor which included furnishing equipment, labor, operators, supervisors, quality control, supplies, materials, and incidentals necessary to satisfactorily help complete this project. Work included earthwork operators, material hauling and placement of material, haul road development, clearing of debris, erosion repair, rutting repair, levee surfacing, stone surfacing and placement, installation of stone armored protection, installation and rehabilitation of drainage structures, and associated apertures to repair crown levee sections. AECOM was the Prime Contractor for the project.

## ***Palatine Properties LLC (Feb 2021-Present)***

As the prime contractor Halcomb is tasked with the responsibility of land clearing, drainage repair, waterway systems, and terrace development for 1,089 acres in Cedar County, Missouri. This work is a government cost share project with private industry to facilitate expansion of productive acreage for farming purposes. The desired end state is increased crop production and erosion mitigation in west central Missouri.
