# Framework for ongoing consideration of FinTech policy issues

#### Recommendation #1

The Australian Government consider targeted outreach to engage special advisors that can provide and represent diverse and inclusive perspectives in relation to policy matters.

#### Intended outcome

 Properly conducted consultations and appropriately considered policy proposals that ensure all voices are heard.

#### Reasons

A number of people and businesses suffering or impacted by regulation, policy proposals, and cultural barriers do not have the time or resources to identify or partake in public policy consultation and submission processes and therefore their voices and experiences are being excluded.

The composition of, and selection criteria for, members of the various advisory councils, groups and committees that advise regulators and government is not diverse or transparent. In general, these councils, groups and committees do not tend to comprise of any persons with expertise in sustainability or ethics, First Nations people, persons with a disability (including mental health); persons that identify as a member of the LGBTIQA+ community, persons of culturally and/or linguistically diverse backgrounds, or women in positions of senior corporate leadership.

Engagement of special advisors to represent a range of diverse and inclusive perspectives would help to address the under representation of diversity in policy proposals.
