The following breeds must be judged on a ramp through all levels of conformation competition: Clumber Spaniels, Sussex Spaniels, Basset Hounds, Cirnechi dell'Etna, Kerry Blue Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows & Keeshonden. Breeds designated as ramp optional may, at the discretion of the judge, be judged on a ramp through all levels of competition. Judges may request the ramp to judge any breed in emergency situations; if granted, unless the use of a ramp has been indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. Junior Showmanship judges should follow the above.

# AKC National Owner-Handled Series (Remember to check the box near the bottom of the entry form)

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS.

Eligible dogs will be identified by an asterisk in the judge's book, steward's book and the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Professional handlers\*, household members and current assistants\*\* to professional handlers may not exhibit the dog in any NOHS competition during the entire show. For a detailed description of the National Owner-Handled Series, please visit the AKC website NOHS pages at:

Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.

This is a recorded event by the AKC for the Certificate of Merit and Puppy of Achievement certificates. Section 1 - Classifications

The Four-to-Six Month Puppy Competition shall be for dogs that are four months of age and over, but under six months on the first day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

# **General Parking**

Parking Fee is \$5.00 per day or \$10.00 for three day event. Cash Only. Exhibitors are expected to only use 2 parking spaces per vehicle to accommodate vehicle and pop-up tents. Please limit the use of canopy, pop-up tents and x-pens to allow room for all exhibitors to park.

Vehicle parking is to be in designated areas only. NO campers are allowed in the general parking area. Exhibitors are free to leave equipment overnight, but TVKC & GVKC will not be responsible for any equipment left overnight.

No vehicles, dogs or people are to stay overnight in the general parking area. NO generators are to be used between the hours of 11:00 P.M. to 6:00 A.M. anywhere on the show grounds unless approved by show chairs.

Cars loading and unloading must leave 4-way flashers on and stay no longer than 15 minutes for unloading or loading. Parking is only allowed in designated areas. No vehicles may drive in show area during show hours.

TVKC & GVKC are not responsible for any fines or towing fees imposed for vehicles parked in areas other than the designated general parking areas or campgrounds.


