Ordinance 2023- 11

AN ORDINANCE PROVIDING FOR AMENDING AND REVISING SPECIFIC LINE-ITEMS IN THE APPROPRIATIONS OF EXPENDITURES FOR THE VILLAGE OF CHESAPEAKE FOR THE CALENDAR YEAR 2023 AND DECLARING AN EMERGENCY

WHEREAS, it is necessary to revise and/or establish appropriations for Village Expenditures, and

WHEREAS, this Ordinance constitutes an emergency measure providing for the daily operations of all Municipal Departments.

BE IT ORDAINED BY THE VILLAGE COUNCIL OF CHESAPEAKE, OHIO, AS FOLLOWS:


