RESOLUTION NO. 2023-07

A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT A GRANT FROM THE STATE OF OHIO FROM THE OHIO FIRST RESPONDER RECRUITMENT, RETENTION, AND RESILIENCE PROGRAM, AND DECLARING AN EMERGENCY.

WHEREAS, the Village has submitted an application to the State of Ohio's Emergency Management Agency for grant funding through the Ohio First Responder Recruitment, Retention, and Resilience Program which has been established through ARPA funding; and

WHEREAS, the State of Ohio has informed the Village that its grant application has been approved, and grant funds in the amount of Seventy-Seven Thousand Nine Hundred and Thirty-Eight Dollars and Sixteen Cents (\$77,938.16) are available to the Village to pay current officers and hire a new officer of the Village of Chesapeake Police Department; and

WHEREAS, it is necessary to accept said grant and to commit the Village to the hiring of said officers and retain current police officers.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Chesapeake, County of Lawrence and State of Ohio, that:

<u>SECTION I:</u> This Council hereby authorizes the Mayor or his designee to accept a grant from the State of Ohio's First Responder Recruitment, Retention, and Resilience Program for an amount up to Seventy-Seven Thousand Nine Hundred and Thirty Eight Dollars and Sixteen Cents (\$77,938.16) to hire up to one full-time police officer for the Village Police Department.

SECTION II: The Mayor or his designee is hereby authorized to execute all documents necessary to accept said grant, and all actions taken by the Mayor or his designee to accept said grant prior to the effective date of this Resolution are hereby ratified and approved.

SECTION III: All formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of the Council, and all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including R.C. § 121.22.

This Resolution shall be declared an emergency necessary to protect the health and safety of our citizens and in full force and effect immediately upon adoption.
