PRIVACY NOTICE

This Privacy Notice will explain how I, Eniko Bihari, the Therapist, use the personal data I collect from you when you sign up for a Welcome Call through this website and then enter into an agreement with me for a therapy session, by also signing the Terms and Conditions and the Liability Waiver Statements. The principles are based on the General Data Protection Regulation guidelines of the EU, which is considered to have the safest and most stringent customer/user protection conditions in the world.

What data do I collect?

I collect the following data:

- Personal identification information (Name, email address, phone number)
- Emergency contact information
- Non-laboratory, non-medical, general health information

How do I collect your data?

You directly provide me with most of the data I collect. I collect data and process data when you:

- Register online or book a welcome call with me.
- Voluntarily fill and sign my Terms and Conditions.
- Enter into communication with me through email and possible other internet platforms, such as Google Meet, WhatsApp, Facebook, Zoom, etc.

How will I use your data?

I collect your data so that I can:

- Process your request and manage your session.
- Send you documents pertaining to the session and the audio recording following the therapy.
- According to safeguarding rules I may release your data to a specific individual or agency if it has been determined that a vulnerable person (child or elder) is at risk or is currently being abused.
- If you, as the client, are in imminent danger to yourself or others; or
- If a subpoena of records has been requested.

How do I store your data?

I securely store your data on a secure hard drive.

I will keep your personal data for as long as the treatment is in process. Following 12-months of inactive, communication-free period I will delete your data, and if you wish to restart cooperation, you need to get in touch with me again.

Marketing

At this time, I do not engage in any third-party marketing.

You will always have the right at any time to stop me from contacting you for marketing purposes.

What are your data protection rights?

I would like to make sure you are fully aware of all your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request me for copies of your personal data.

The right to rectification – You have the right to request that I correct any information you believe is inaccurate. You also have the right to request me to complete the information you believe is incomplete.

The right to erasure – You have the right to request that I erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that I restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to my processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that I transfer the data that we have collected to another organization, or directly to you, under certain conditions.
