# THE CONSTITUTION OF THE KINGDOM OF ATLANTIS

## PREAMBLE

We, the Atlantean Citizens of The Kingdom of Atlantis Decentralized Sovereign Kingdom, in the exercise of our own Sovereignty and willing to implement the Atlantean Metaphysics, Atlantean Sustainable Development and Atlantean Government Administration (herein referred to as the “**Atlantean Education Program**”) in our Sovereign Kingdom, hereby declare ourselves to be:

**DETERMINED** to end poverty and hunger, in all their forms and dimensions, and to ensure that all Human Beings can fulfil their potential in dignity and equality and in a healthy environment,

**EAGER** to protect Planet Earth from degradation, through Sustainable Development, sustainable consumption and production, sustainably managing its natural resources, so that it can support the needs of the present and future generations.

**RESOLVED** to ensure that all Human Beings can enjoy prosperous and fulfilling lives and that economic, social, environmental and technological progress occurs in harmony with Mother Nature.

**WILLING** to foster peaceful, just and inclusive societies which are free from fear and violence. There can be no successful implementation of the Atlantean Education Program without Peace and no Peace without the Atlantean Education Program.

**PREPARED** to implement our Atlantean Education Program, which is composed of Bachelor, Master and Doctorate Degrees in Atlantean Metaphysics, Atlantean Sustainable Development and Atlantean Government Administration in our Sovereign Kingdom in order to create and **Advanced Civilization**, here on Planet Earth, that will bring Humanity to higher **Levels of Existence**.



## **CHAPTER I: SOVEREIGNTY OF THE KINGDOM OF ATLANTIS**

### **ARTICLE 1: NAME**

1. The official name of the Sovereign Kingdom shall be **The Kingdom of Atlantis.**

### **ARTICLE 2: FOUNDING PRINCIPLES**

  - e) To achieve gender (Male and Female) equality and empower all women and girls;
  - f) To ensure availability and sustainable management of water and sanitation for all;
  - g) To ensure access to affordable, reliable, sustainable and modern energy for all;
  - h) To promote sustained, inclusive and sustainable economic growth, full and productive employment and decent work for all;
  - i) To build resilient infrastructure, promote inclusive and sustainable industrialization and foster innovation;
  - j) To reduce inequality within and among all Nations;
  - k) To make cities and human settlements inclusive, safe, resilient and sustainable;
  - l) To ensure sustainable consumption and production patterns;
  - m) To take action to combat industrial pollution and its impacts;
  - n) To conserve and sustainably use the oceans, seas and marine resources for Sustainable Development;
  - o) To protect, restore and promote sustainable use of terrestrial ecosystems, sustainably manage forests, combat desertification, and halt and reverse land degradation and halt biodiversity loss;
  - p) To promote peaceful and inclusive societies for Sustainable Development, provide access to Justice for all and build effective, accountable and inclusive institutions at all levels;
  - q) To strengthen the means of implementation and revitalize the Global Partnership for Sustainable Development in all Nations.

### ARTICLE 3: SOVEREIGN TERRITORY

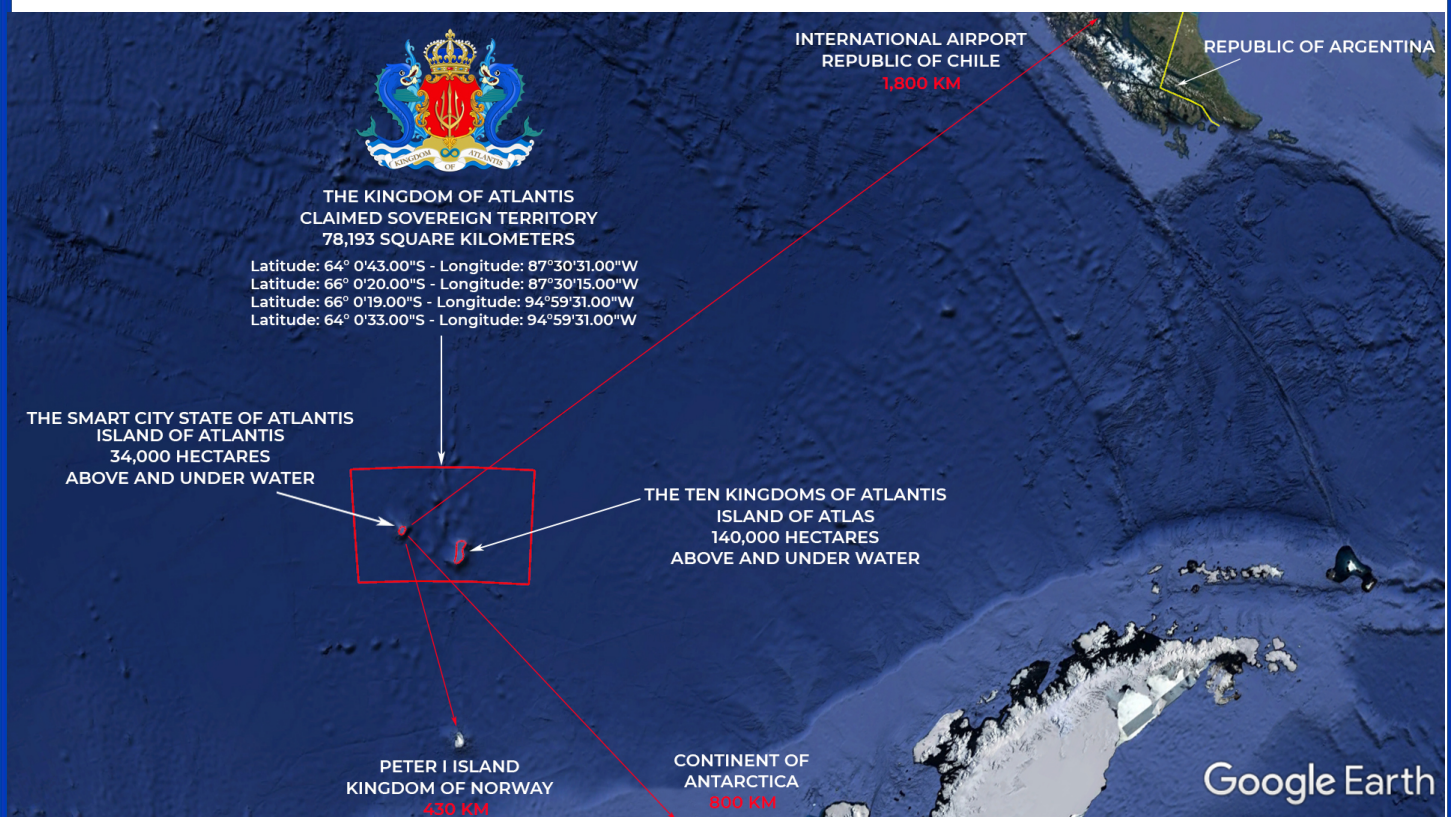
1. The Kingdom of Atlantis has claimed its **Sovereign Territory** (78,193 Square Kilometers in the Southern Ocean) bound by the following coordinates:

Latitude: 64° 0'43.00"S Longitude: 87°30'31.00"W

Latitude: 66° 0'20.00"S Longitude: 87°30'15.00"W

Latitude: 66° 0'19.00"S Longitude: 94°59'31.00"W

Latitude: 64° 0'33.00"S Longitude: 94°59'31.00"W



2. The Sovereign Territory of The Kingdom of Atlantis includes two submerged islands with a total area of 72,000 Hectares on which will be anchored sea steading structures forming the **Smart City State of Atlantis** in Antarctica.
3. The Kingdom of Atlantis shall acquire a Sovereign Territory on the Continents of Africa, Asia, Europe, Oceania, Antarctica, North America and South America to develop the seven (7) Smart City States of Atlantis.
4. Each Smart City State of Atlantis shall be developed on shore and offshore, above and under water, to accommodate a minimum of 5,000,000 **Atlantean Citizens** and **Atlantean Permanent Residents**.
5. Each Smart City State of Atlantis shall accommodate 1,500,000 Business Visitors and Tourists per year.

We recognize that The Hague is developing into a worldwide center in the service of international judicial and administrative cooperation in the field of private law, particularly in the area of child protection and access to justice, all of which are in keeping with the Philosophy and Constitution of The Kingdom of Atlantis.

## ARTICLE 4: POLITICAL SYSTEM

1. The Kingdom of Atlantis shall be a **Constitutional Monarchy**.

## ARTICLE 5: LANGUAGE

2. **English** shall be the official language of The Kingdom of Atlantis.

## ARTICLE 6: PRINCIPAL OF LAW

1. This Constitution, in accordance with the Atlantean Education Program, shall be binding on all Members of the Governments and Organizations of The Kingdom of Atlantis as well as upon all Atlantean Citizens, Permanent Residents, Business Visitors and Tourists (herein referred to as “**Individuals**”)
2. The Kingdom of Atlantis recognizes the principles of the Atlantean Education Program that are based on the right of all Individuals to Life, equality and liberty, the pursuit of happiness and prosperity, and the responsibility of all Individuals to protect Humanity and Planet Earth from destruction.

## CHAPTER II: RIGHTS OF ALL INDIVIDUALS

1. The Kingdom of Atlantis, in alignment with the Atlantean Education Program, recognizes human dignity to be inalienable and therefore seeks to maintain and guarantee the inviolable rights of all Individuals, which constitutes the foundation of political order, peace and social justice. An Atlantean Citizen (**Sovereign Individual**) is defined as a Self-Sufficient and Self-Determined Individual who doesn't need a Government to be Ethical, Operational and Productive.

## ARTICLE 1: EQUALITY OF ALL INDIVIDUALS

1. All Individuals are equal before the Law. No Court or Government Member shall be permitted to discriminate against any Individual on the basis of gender (Male and Female), race, social status, religion or belief as per the Atlantean Education Program.
2. No public authority shall create conditions that substantially abridge the Equality or Liberty of any Individual, except where such Individual is held awaiting trial or has been convicted of a crime.
3. All Atlantean Citizens and Permanent Residents shall study and practice the Atlantean Education Program and are expected to demonstrate Positive Ethical Behaviour in their life. It is understood that lack of Proper Education is the reason why Humanity, Life Forms and Planet Earth are at risk today.

## **ARTICLE 2: FREEDOM OF SPEECH, ASSEMBLY, AND ASSOCIATION**

1. No Law shall substantially abridge Freedom of Speech, communication, or exchange of information, unless it is considered Criminal Speech by the Law of The Kingdom of Atlantis.
2. Censorship, or any other means of ideological control by Law or Decree, shall be prohibited.
3. The right of all Individuals to assemble for any lawful purpose shall not be abridged, except to the extent necessary in order to prevent excessive infringement upon the free movement of goods or Individuals, personal injury, or property damage.
4. The right to associate for lawful purposes, and to create and maintain managerial, professional or trade associations, shall not be abridged.
5. Any Atlantean Citizen and Permanent Resident with direct interest in a matter, shall have the right to petition the Government.

## **ARTICLE 3: FREEDOM OF RELIGION**

1. Freedom to manifest one's religion or beliefs shall be subject only to such limitations as are necessary in order to maintain public safety, order and health, and for the protection of the fundamental rights and freedoms of all Individuals.
2. The Kingdom of Atlantis shall not establish an official religion, nor require any person to disclose his or her religion or religious beliefs.

## **ARTICLE 4: RIGHT TO HUMAN DIGNITY**

1. All Individuals have the right to physical and psychological integrity, No one shall be subjected to torture or to cruel or inhumane punishment. Instead, Individuals shall receive psychological and educational assistance when in need.
2. It is understood that criminality is the result of lack of Proper Education and torture and inhumane punishment do not rehabilitate the criminal but instead reinforce his vengeance against the Society.
3. All Individuals have the right to enroll in the Atlantean Education Program, which will teach them what is Right and what is Wrong in order to live an Ethical and Prosperous life.
4. All Individuals are fully responsible for their acts and should they be involved in any criminal activity, as defined by the Laws of The Kingdom of Atlantis, they will be judged by the competent Court and execute their sentence.





## ARTICLE 5: RIGHT TO DUE PROCESS

1. No Individual shall be deprived of liberty or property except on such grounds and in accordance with such procedures as are established by the Constitution and the Laws of The Kingdom of Atlantis.
2. Death penalty is not supported by The Kingdom of Atlantis as this act is in total contradiction with the Atlantean Education Program. Instead, a **Rehabilitation Program**, to be established by Law, will be administered to the faulty Individual and should he demonstrate no changes in his Ethical Behaviour, the faulty Individual will be **Expelled for Life** from The Kingdom of Atlantis.
3. Executive detention shall take no longer than such a time as is reasonably necessary in order to carry out those inquiries necessary to determine whether probable cause exists. In all cases, the Individual shall be brought before a judge within 72 hours of being brought into custody.
4. The Law shall establish a procedure in order that the Individual will be informed of the charges against him or her, and that the Court may determine the lawfulness of the detention. The Law shall establish a procedure to restore any fundamental rights compromised by the detention of an Individual.
5. No Individual shall be held criminally or administratively liable for any act or omission that was lawful at the time the act or omission occurred. No bill of confiscation of assets shall be passed.
6. No Individual shall twice be put in jeopardy of life or deprivation of property for the same offense.
7. No Individual shall be forced to testify against himself in a criminal or administrative proceeding. No Individual shall be held criminally or civilly liable on the basis of the witness testimony without opportunity to cross examine the witness.

## ARTICLE 6: RIGHT TO JURISPRUDENCE AND LEGAL COUNSEL

1. All Individuals have right to jurisprudence and to have a ruling founded in the Law and to trial with due process before an impartial Court. Any Individual accused of a felony shall have the right to a jury trial. In criminal cases, the Individual shall have the right to competent counsel and a prompt public trial.

## ARTICLE 7: RIGHT, PRIVACY AND SECURITY

1. No Individual may enter a dwelling or any premises against the will of the owner unless a lawful warrant, supported by probable cause, is first issued by the Court.

2. The expectation of privacy of communication within the dwelling or other premises shall be maintained, except upon a reasoned Court order.
3. The right to financial and banking secrecy shall be protected by Law, and disclosure only permitted to the extent necessary to protect litigants from prejudice, or upon a Court order determining the existence or probable cause that a crime has been committed and that the ordered degree of financial disclosure will more likely than not aid in bringing further crime to light or bringing the perpetrator of the crime to justice.

### ARTICLE 8: CRIMES IN OTHER JURISDICTIONS

1. No act committed on foreign soil shall be prosecuted in The Kingdom of Atlantis, unless the act substantially abridges the rights or privileges of an Atlantean Citizen or compromises the integrity of the Government.
2. No Atlantean Citizen shall be extradited for a crime unless the act or acts of which the Atlantean Citizen is accused constitutes a felony as defined by The Kingdom of Atlantis Law.

### ARTICLE 9: RIGHT TO PROPERTY AND EARNINGS

1. No **Income Tax** shall be paid to the Government by any Individual based primarily upon the amount of his income, wages, earnings or property holdings, nor shall any **Corporate Tax** be paid to the Government as a portion of Corporate Profits.
2. No Individual shall be deprived of property without just compensation or, in case of criminal or civil penalties, without due process of Law.

## CHAPTER III: PROHIBITIONS

### ARTICLE 1: PROHIBITIONS IN THE KINGDOM OF ATLANTIS

1. Weapons of all sorts, including Firearms, are prohibited in The Kingdom of Atlantis except for the Authorized Security Personnel. Weapon means anything used, designed to be used or intended for use in causing death or injury to any Individual, or for the purpose of threatening or intimidating any Individual. The **Reigning Monarch** shall issue a specific Law on this subject.
2. Drugs of all sorts are prohibited in The Kingdom of Atlantis except for medical use and only for pain relief. Drugs are degrading Human Beings and this is in total contradiction with the Atlantean Education Program. The **Reigning Monarch** shall issue a specific Law on this subject.

3. Prostitution of all sort is prohibited in The Kingdom of Atlantis. Prostitution degrades women and those who are using it and this is in total contradiction with the Atlantean Education Program. The **Reigning Monarch** shall establish a specific Law on this subject.
4. Briberies and Corruptions of all sorts are prohibited in The Kingdom of Atlantis. Briberies and Corruptions are the source of unfair business, financial irregularities, economic collapse and inequalities between Human Beings, which is in total contradiction with the Atlantean Education Program. The **Reigning Monarch** shall issue a specific Law on this subject.

### CHAPTER IV: SOVEREIGNTY

1. A Kingdom, as an institution, predates the formation of The Kingdom of Atlantis. The selection of this form of Government is based on the historical stability, as well as its ability to provide continuity, create an atmosphere of security, and safeguard the wealth of its Atlantean Citizens and Permanent Residents from excessive taxation and redistribution.

#### **ARTICLE 1: REIGNING MONARCH**

1. The **Reigning Monarch** shall be known as the **King** or the **Queen**, and is the symbol and guarantor of the prosperity, viability, security, continuity, independence and neutrality of The Kingdom of Atlantis.

#### **ARTICLE 2: DUTIES OF THE REIGNING MONARCH**

1. The **Reigning Monarch** sees that the Constitution of The Kingdom of Atlantis is followed without any deviations by all Individuals.
2. The **Reigning Monarch** is also the **Chairman of the Board** of all the Governments of The Kingdom of Atlantis as well as the Chairman of the Board of all the Organizations that are annexed to The Kingdom of Atlantis.
3. The **Reigning Monarch** has full authority to appoint and dismiss any Chairman, Presidents, Vice Presidents, Ministers, Deputies, Secretaries, Senior Officers and Officers of any Governments and Organization of The Kingdom of Atlantis.
4. The **Reigning Monarch** appoints and accredits diplomatic representatives to foreign states, and shall receive credentials of foreign representatives.

#### **ARTICLE 3: POWERS OF THE REIGNING MONARCH**

1. The **Reigning Monarch** may exercise the prerogative of Grace and Will.
2. The **Reigning Monarch** may bestow Royal Titles and honours for exceptional deeds or services beneficial to The Kingdom of Atlantis.

3. The **Reigning Monarch** may appoint and dismiss any member of the Governments and Organizations of The Kingdom of Atlantis, in accordance with Chapter IV, Article 2 of this Constitution.
4. The **Reigning Monarch** shall be immune from suit, except to the extent that a suit is brought by the **Board Committee** for the purpose of enforcing the terms of this Constitution.

### ARTICLE 4: SUCCESSION

1. The throne shall be inherited by the descendants of the **Reigning Monarch**.
2. On the demise or resignation of the **Reigning Monarch**, the throne shall pass to the **Queen** or **Prince** or **Princess**, with a preference for the eldest over younger Prince or Princess.
3. Where one of the **Reigning Monarch's** children has died, the issue of the deceased shall take his place in accordance with the lineal descent and the rules provided in Sections 1 and 2 of this Article.
4. On the demise of the **Reigning Monarch**, who has left no issue entitled to succeed to the throne, the throne shall pass to the Queen or a Prince or a Princess.
5. If the **Reigning Monarch's** designated successor is younger than eighteen years of age at the time of the **Reigning Monarch's** death or resignation, the person next in line to the throne, who is at least eighteen years of age, shall rule instead of the designated successor until such time as the designated successor attains the age of eighteen years.
6. Any issues to do with succession of The Kingdom of Atlantis shall be settled by the **Reigning Monarch**.

## CHAPTER V: GLOBAL STRUCTURE OF THE KINGDOM OF ATLANTIS

### ARTICLE 1: VISION AND MISSION

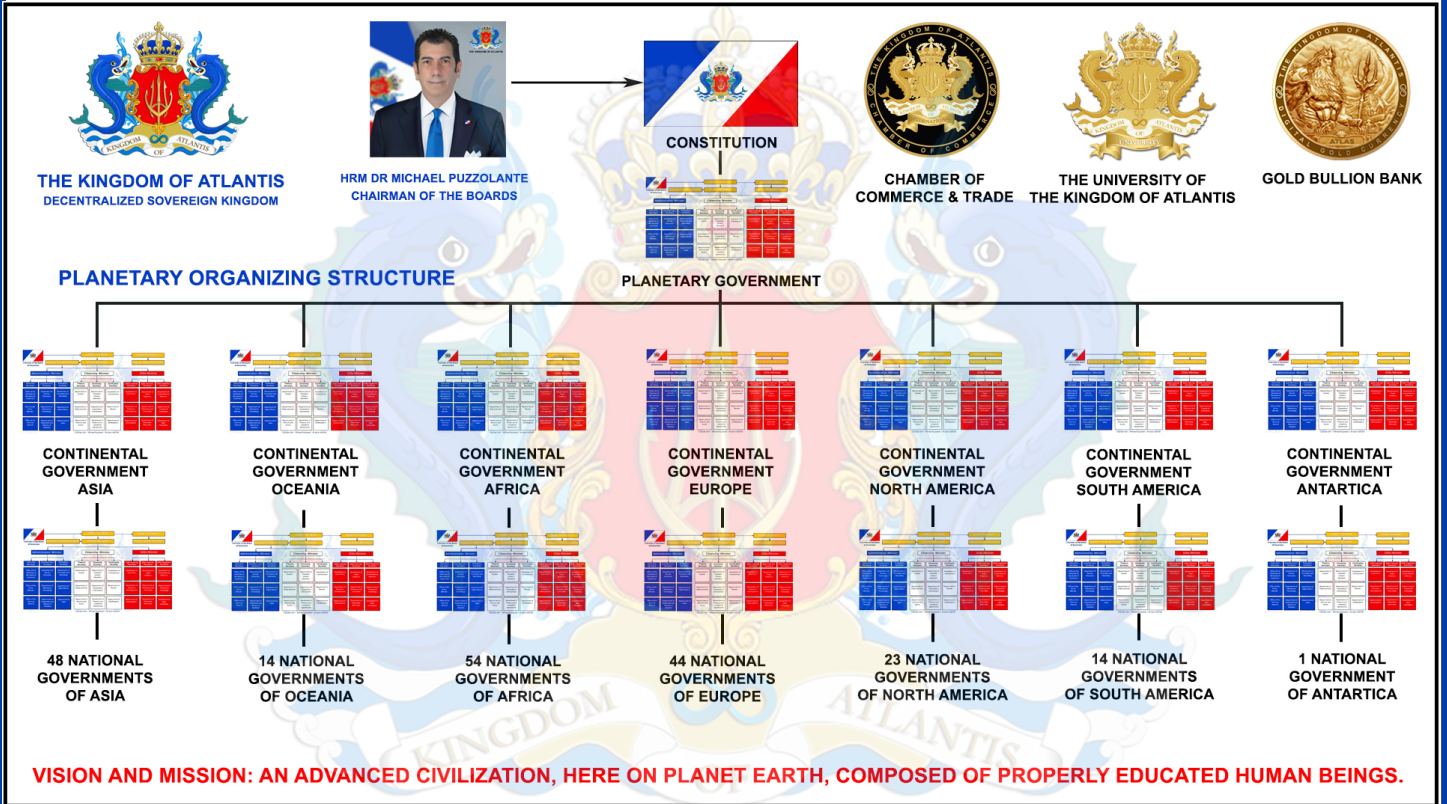
1. To create an Advanced Civilization, here on Planet Earth, composed of Properly Educated Human Beings.

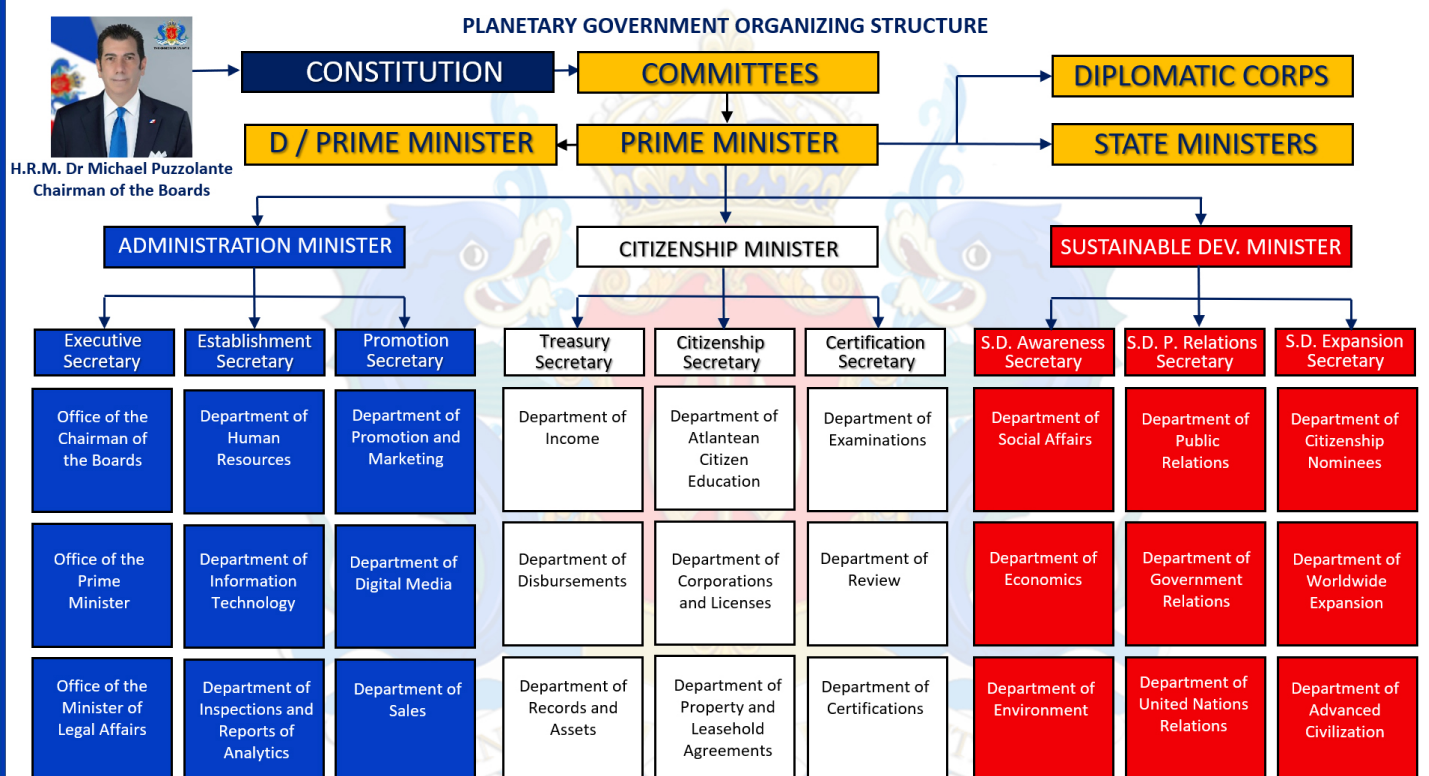

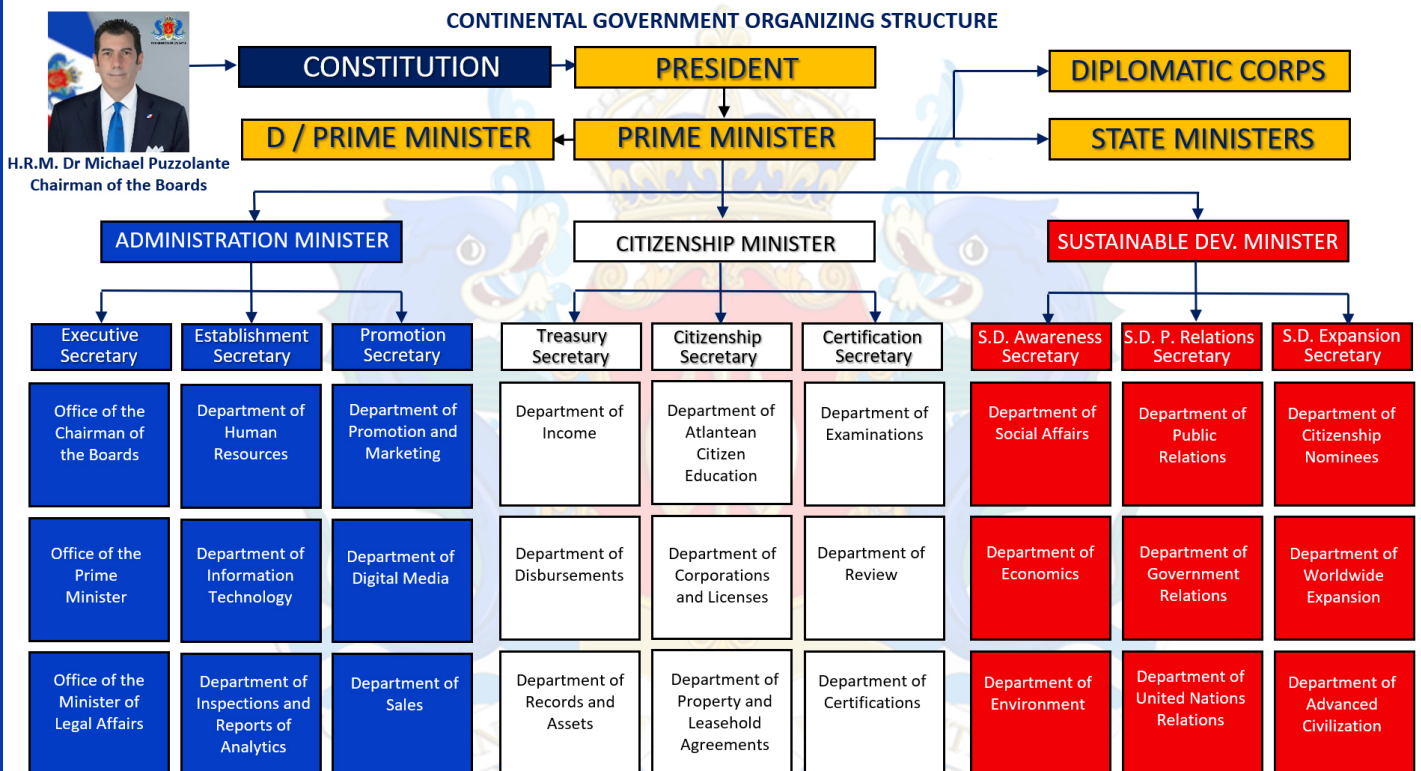

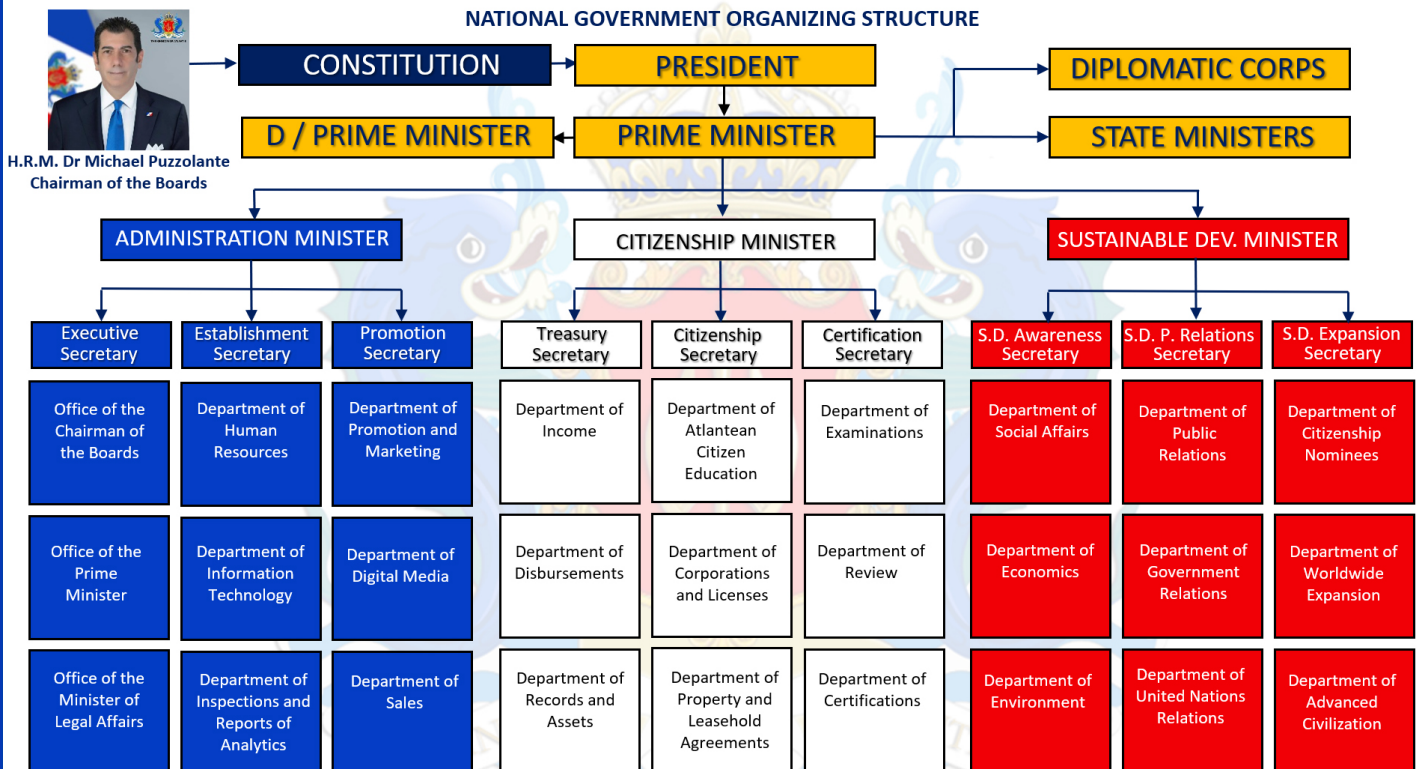

3. The Function of the National Government is to Select a Multitude of **Atlantean Citizen Nominees** and to get them enrolled in the Atlantean Education Program delivered by the **Royal University of The Kingdom of Atlantis** Worldwide. It is composed of:
  - a) The Office of the Chairman of the Boards (**Reigning Monarch**)
  - b) The Office of the President
  - c) The Office of the Prime Minister
  - d) The Office of the Minister of Legal Affairs
  - e) The Office of the Diplomatic Corps
  - f) The Ministry of Government Administration
  - g) The Ministry of Citizenship
  - h) The Ministry of Sustainable Development
4. The Chairman of the Boards may, at any time, dismiss any President, Vice President, Chairman, Minister, Deputy, Secretary, Senior Officer, Officer and Diplomat of any Government or Organization of The Kingdom of Atlantis. Royal Titles and Certificates bestowed for services or deed, however, shall remain with the holder unless revoked due to commission of a High Crime as listed in Chapter 7, Article 3.

### ARTICLE 6: ATLANTEAN GOVERNMENT ADMINISTRATION

1. The Kingdom of Atlantis Decentralized Sovereign Kingdom is a Constitutional Monarchy that has existed since the 01st of January 2021.
2. The Constitution of a Sovereign Kingdom is important because it protects Individual freedom and its fundamental principles.
3. The Constitution of The Kingdom of Atlantis places Free Will and Power in the hands of Individuals and limits the intervention of the Government in the affairs of the Individuals.
4. The Kingdom of Atlantis shall become the first Sovereign Kingdom on Planet Earth that will integrate the Atlantean Education Program into its Constitution, as it is based on the Greater Good for the Greater Number of Aspects of Life. The Atlantean Education Program shall be implemented in all the Smart City States of Atlantis.
5. **Atlantean Citizenship** and **Atlantean Permanent Residency** are gained by meeting the legal requirements listed in the Constitution.

6. The Atlantean Education Program allows every Individual to acquire the knowledge, skills, attitudes and values necessary to shape a Sustainable future for Humanity and Planet Earth.
7. The Atlantean Education Program includes key Sustainable Development issues; for example, climate change, disaster risk reduction, biodiversity, poverty reduction, and sustainable consumption.
8. The Atlantean Education Program also requires participatory teaching and learning methods that motivate and empower learners to change their behavior and take action for Sustainable Development.
9. The Atlantean Education Program consequently promotes competencies like positive thinking, imagining positive future scenarios and making decisions in a collaborative way.
10. A person who wants to become an Atlantean Citizen must acquire the Knowledge, Skills, Attitudes and Values necessary to shape a Sustainable Future. Therefore, the Atlantean Citizenship will be only granted to those who successfully go through the Atlantean Education Program.
11. A person who wants to become an Atlantean Permanent Resident must acquire the Knowledge, Skills, Attitudes and Values necessary to shape a Sustainable Future. Therefore, the Atlantean Permanent Residency will be only granted to those who successfully go through the Atlantean Education Program.
12. The Atlantean Education Program as a Product is a finished High-Quality Service, delivered in the hands of the Individuals it serves, in exchange for money. In other words, it is not a Product at all unless it is exchanged with money.
13. A Product is something that can be exchanged with other activities in return for support. The support usually adds up to food, clothing, shelter, money, tolerance and cooperation.
14. Based on the above definitions we can see that the Atlantean Education Program is a High-Quality Service that can be exchanged for money. It will also attract tolerance and cooperation from International Organizations as it based on the increased Awareness of Human Beings and the implementation of Sustainable Development on Planet Earth.
15. The Atlantean Citizen shall become a Model Citizen who applies the Atlantean Education Program in his life, thus participating to the survival of Humanity and Planet Earth.
16. The Atlantean Citizen shall become the main asset of The Kingdom of Atlantis and its value, as a Human Being, will be higher than anything on Planet Earth.

17. Only an Atlantean Citizen or Atlantean Permanent Resident shall be allowed to incorporate a Company, acquire a License to Operate and Lease Lands in the Smart City States of Atlantis.
18. Only an Atlantean Citizen or Atlantean Permanent Resident shall be allowed to be part of the Governments of The Kingdom of Atlantis.
19. The **Government Organization Structure** is a Chart that shows what Functions are done in the Organization, the Order they are done in, and Who is Responsible for getting them Done. The Government Organization Structure shows the Pattern of Organizing to obtain a **Sustainable Final Product** that can be exchanged for money or support.
20. The Sustainable Final Product of The Kingdom of Atlantis is: **“a certified Atlantean Citizen or Atlantean Permanent Resident who can apply the Atlantean Education Program in his life and in the Society at large”**.
21. Once the Atlantean Citizen or Atlantean Permanent Resident successfully complete the Atlantean Education Program, he will be allowed to incorporate a Company, acquire a License to Operate or Lease Lands for development in the Smart City States of Atlantis.
22. The Kingdom of Atlantis shall be 100% Tax Exempt in order to attract a multitude of Atlantean Citizens and Atlantean Permanent Residents who will participate to the development of The Kingdom of Atlantis. Therefore, the Main Income of The Kingdom of Atlantis shall be generated by Citzenships, Residency, Incorporation of Businesses, Acquisition of Licenses to Operate and Lease of Lands.
23. The Constitution of The Kingdom of Atlantis shall be shared with a multitude of Sovereign Nations in order to be recognized as a Sovereign Kingdom.
24. A Multitude of Atlantean Citizens and Atlantean Permanent Residents shall be Certified, demonstrating their commitment to apply the Atlantean Education Program in their life, and this information shall be shared with a multitude of Sovereign Nations.

### ARTICLE 7: LEGISLATION

1. It is the Power of the **Reigning Monarch** to issue all the Laws of The Kingdom of Atlantis based on this Constitution and the Atlantean Education Program.
2. The **Reigning Monarch** may request Advices from the **Board Committee**, but the **Reigning Monarch** remains the only one who has the Authority to issue the Laws of The Kingdom of Atlantis.

## ARTICLE 8: POWERS OF THE BOARD COMMITTEE.

1. The Board Committee shall have the Power to Advise the **Reigning Monarch** regarding the Establishment, Management and Operation of the Planetary, Continental and National Governments of The Kingdom of Atlantis to the extent that such Advice remains consistent with this Constitution and the Atlantean Education Program.

## ARTICLE 9: INDIVIDUAL ROYAL TITLES

1. **Individual Royal Titles** shall be awarded only to Members of the Planetary Committees and Planetary, Continental and National Governments.
2. Members of the Planetary Strategic Planning Committee shall be awarded an **Eight (8) Star Rank Royal Title**.
3. Members of the Planetary Judiciary Committee shall be awarded a **Seven (7) Star Rank Royal Title**.
4. Members of the Planetary Advisory Committee shall be awarded a **Six (6) Star Rank Royal Title**.
5. Members of the Planetary Government shall be awarded a **Five (5) Star Rank Royal Title**.
6. Members of the Continental Governments shall be awarded a **Four (4) Star Rank Royal Title**.
7. Members of the National Governments shall be awarded a **Three (3) Star Rank Royal Title**.
8. Members of National Governments shall be promoted to the Continental Governments based on their loyalty and personal production.
9. Members of Continental Governments shall be promoted to the Planetary Government based on their loyalty and personal production.
10. Members of Planetary Government shall be promoted to the Planetary Committees based on their loyalty and personal production.
11. Members of the Planetary Committees and Planetary, Continental and National Governments shall be demoted to a lower Government based on their lack of personal production.
12. Members of the Planetary Committees and Planetary, Continental and National Governments shall be prosecuted by the High Court and **Expelled for Life** based on the severity of their High Crimes.
13. Members of the Planetary Committees and Planetary, Continental and National Governments who have been Expelled for Life shall lose their Royal Titles, Certificates, Benefits, Donations and Investments.

## CHAPTER VI: THE JUDICIARY

### **ARTICLE 1: JUDICIARY COMMITTEE**

1. Adjudicative power shall be vested in an **Independent Judiciary Committee**.
2. The Judiciary Committee shall be vested with both the Law and Equity Powers, and shall decide all cases in controversy and criminal prosecutions.
3. The Judiciary Committee shall consist of a High Court, Courts and Tribunals.
4. All Judges shall be paid compensation from the Department of Treasury.
5. All Judges, regardless of Royal Rank, shall be appointed by the **Reigning Monarch** and shall serve, during good behaviour, for ten-year renewable terms.
6. The Judiciary Committee is not involved in the affairs of the Governments of The Kingdom of Atlantis.

### **ARTICLE 2: COMPOSITION OF THE HIGH COURT**

1. No less than Three and no more than Seven High Court Judges shall sit on the High Court. In no instance shall a case before the High Court be heard by less than Three High Court Judges, except with the consent of all parties.

### **ARTICLE 3: JURISDICTION AND DUTIES OF THE HIGH COURT**

1. The High Court shall have Original Jurisdiction over all cases involving Individuals who have committed any High Crimes as listed in this Constitution.
2. The High Court shall have Original Jurisdiction over all cases involving Individuals who have intentionally violated this Constitution.
3. The High Court shall be responsible for administrative, procedural, and ethical oversight of all Lower Courts and Tribunals.
4. Decisions of the High Court shall be final and binding on all parties, except in such instances where the High Court may elect to rehear a case or, in criminal and administrative cases, where the **Reigning Monarch** may elect to grant **Royal Pardon**.

## CHAPTER VII: CITIZENSHIP

### **ARTICLE 1: ACQUISITION OF ATLANTEAN CITIZEN STATUS**

1. Any natural Atlantean Citizen born to at least one parent who at time of the child's birth is an Atlantean Citizen shall be, upon proper registration, considered an Atlantean Citizen of The Kingdom of Atlantis for any and every purpose, unless and until such Atlantean Citizenship status is lost in accordance with another provision of this Constitution.

2. Any Individual, upon proper request or application and after having successfully completed the Atlantean Education Program, shall be considered an Atlantean Citizen and eligible for a Government position, incorporation of business, acquisition of license to operate and lease of land for development, unless and until such Atlantean Citizenship status is lost in accordance with another provision of this Constitution.
3. The Kingdom of Atlantis recognizes dual Citizenships. The retention of Citizenship of a country other than The Kingdom of Atlantis shall be permitted to all Atlantean Citizens.

### ARTICLE 2: LOSS OF CITIZENSHIP STATUS

1. The status of Atlantean Citizen, once acquired, may only be lost as a result of High Crimes committed against the **Reigning Monarch**, The Kingdom of Atlantis and Atlantean Citizens, as listed in Chapter 7, Article 3.

### ARTICLE 3: HIGH C R I M E S

1. Publicly announcing one's departure from The Kingdom of Atlantis without reasonable cause.
2. Any felony (such as murder, arson, etc.) against the **Reigning Monarch**, an Atlantean Citizen or the Properties of The Kingdom of Atlantis.
3. Sexual or sexually perverted conduct contrary to the well-being or good state of Mind of an Atlantean Citizen.
4. Blackmailing the **Reigning Monarch**, Atlantean Citizens or The Kingdom of Atlantis.
5. Using the Copyrights, Trademarks, Patents and Designs of The Kingdom of Atlantis without express permission or license from the **Reigning Monarch**.
6. Testifying or giving data against the **Reigning Monarch**, Atlantean Citizens and The Kingdom of Atlantis falsely or in generalities or without personal knowledge of the matters to which one testifies.
7. Organizing splinter groups to diverge from The Kingdom of Atlantis, still calling it The Kingdom of Atlantis or calling it something similar.
8. Organizing a splinter group to use the Copyrights, Trademarks, Patents and Designs of The Kingdom of Atlantis to distract people from the original Kingdom of Atlantis.
9. Public disavowal of **Atlantean Citizens** in good standing with The Kingdom of Atlantis.
10. **Criminal Speech** against the **Reigning Monarch**, Atlanteans Citizens and The Kingdom of Atlantis.

11. Proposing, advising or voting for legislations or ordinances, rules or laws directed toward the destruction of The Kingdom of Atlantis.
12. Reporting or threatening to report The Kingdom of Atlantis to civil authorities in an effort to destroy The Kingdom of Atlantis.
13. Writing anti-Kingdom of Atlantis letters to the press or giving anti-Kingdom of Atlantis data to the press.
14. Being at the hire of anti-Kingdom of Atlantis groups or persons.
15. Infiltrating The Kingdom of Atlantis to stir up discontent or protest at the instigation of hostile forces.
16. Mutiny, including Non-Execution of Orders, Policy Letters or Programs issued by the **Reigning Monarch**.
17. Engaging in malicious rumourmongering to destroy the authority or repute of the **Reigning Monarch** or any Member of the Governments.
18. Using or stealing the Date Bases of The Kingdom of Atlantis for personal profit or gain.
19. Calculated efforts to disrupt the flow of New Atlantean Citizens to The Kingdom of Atlantis.
20. The Individual who has committed such High Crimes will be prosecuted by the Judiciary Committee. The maximum sentence calls for the **Expulsion for Life** of the Individual. All his/her Royal Tiles, Certificates and Appointments will be cancelled. All his/her Donations, Investments or Properties will be lost. His/her Atlantean Citizenship will be terminated.

## CHAPTER VIII: DIGITAL GOLD CURRENCY

### **ARTICLE 1: ATLAS DIGITAL GOLD CURRENCY.**

1. The Kingdom of Atlantis Official Digital Gold Currency (**ATLAS**) shall be a Redeemable 100% Gold Backed Digital Currency.
2. The **ATLAS** is the Official Digital Gold Currency of The Kingdom of Atlantis and is exclusively reserved to Atlantean Citizens and Atlantean Permanent Residents living in the Smart City States of Atlantis.
3. The **Reigning Monarch** believes that all F.I.A.T. Currencies will eventually collapse as they are backed by “Thin Air” and thus, have absolutely Zero Economic Value.
4. **Gold** is the Real Money. It has been used on Planet Earth for the past 5,000 years as a mean of Exchange of Goods & Services.

5. In 1971, the F.I.A.T. Currencies were introduced to resolve the lack of **Gold** needed to back up the “Money” in circulation. Today we can see the disastrous results of this decision as we are at the edge of a Total Economic Collapse.
6. The **Gold Bullion Bank** of The Kingdom of Atlantis, which is a Private Corporate Entity separate from The Kingdom of Atlantis, will store **Gold** in large quantities to back up the **ATLAS**.

### CHAPTER IX: ORGANIZATIONS OF THE KINGDOM OF ATLANTIS

#### **ARTICLE 1: GOLD BULLION BANK OF THE KINGDOM OF ATLANTIS.**

1. The **Gold Bullion Bank of The Kingdom of Atlantis**, is a Private Corporate Entity separate from The Kingdom of Atlantis and it shall be incorporated in Singapore.
2. The Purpose of the Gold Bullion Bank of The Kingdom of Atlantis is to partner with Gold Miners, to refine their Gold to 24 Carats LBMA and to store their Gold in Private High Security Vaults, in exchange of Shares in the Gold Bullion Bank.
3. The Gold 24 Carats LBMA will be used to back up the ATLAS, the Official Digital Gold Currency of The Kingdom of Atlantis.
4. The Gold 24 Carats LBMA will be used as Collateral to obtain the Funds necessary to Develop the Smart City of Atlantis on the 7 Continents.
5. Part of the Net Profit generated by the Gold Bullion Bank of The Kingdom of Atlantis will be distributed to the Gold Miners / Shareholders.
6. Part of the Net Profit generated by the Gold Bullion Bank of The Kingdom of Atlantis will be used to purchase more Gold 24 Carats LBMA to back up more ATLAS.

#### **ARTICLE 2: ROYAL UNIVERSITY OF THE KINGDOM OF ATLANTIS**

1. The **Royal University of The Kingdom of Atlantis**, is a Private Corporate Entity separate from The Kingdom of Atlantis and it shall be incorporated in Singapore.
2. The Purpose of the Royal University of The Kingdom of Atlantis is to deliver the Atlantean Education Program to all Atlantean Citizens and Atlantean Permanent Residents in High Quantity and Quality, including the issuance of all related Diplomas and Certificates.
3. The Royal University of The Kingdom of Atlantis shall be involved in the Research & Development of the **Atlantean Extension Life Program, Atlantean Spiritual Being Transfer, Atlantean Zero Point Energy Generator** and any other Invention that will improve the Life of Human Beings and the Survival of Planet Earth.





### ARTICLE 3: CHAMBER OF COMMERCE OF THE KINGDOM OF ATLANTIS

- 1) The **Chamber of Commerce of The Kingdom of Atlantis**, is a Private Corporate Entity separate from The Kingdom of Atlantis and it shall be incorporated in Singapore.
- 2) The Purpose of the Chamber of Commerce of The Kingdom of Atlantis is to invite Companies and Corporations to participate to the Promotion, Market, Funding, Design, Build, Operation and Maintenance of the Smart City States of Atlantis on the 7 Continents.
- 3) After Due Diligence and Selection, the Chamber of Commerce of The Kingdom of Atlantis will introduce the best Companies and Corporations to **SFI Universal Pte Ltd**, the Exclusive Property Developer of The Kingdom of Atlantis.

### ARTICLE 4: SFI UNIVERSAL PTE LTD

- 1) **SFI Universal Pte Ltd** is a Singapore based Property Development Company and the Exclusive Developer of the Smart City States of Atlantis.
- 2) The Purpose of **SFI Universal Pte Ltd** is to Promote, Market, Fund, Design, Build, Operate and Maintain the Smart City States of Atlantis to be developed on the 7 Continents.

**CHAPTER X: AMENDMENTS**

**ARTICLE 1: AMENDMENTS TO THIS CONSTITUTION**

1. The **Reigning Monarch** is the Sole Authority to Amend the Constitution of The Kingdom of Atlantis.
2. The Board Committee has the Power to Suggest Amendments of the Constitution, but the **Reigning Monarch** is the Sole Authority that will consider if the Amendments are valid or not.
3. Should a Suggestion be valid, the **Reigning Monarch** will proceed with the Amendment of the Constitution and will make a Public Announcement.


