

## Indiana Republican Party Vice-Chairwoman Rachelle Baker Set to Resign

LAKE COUNTY - Indiana Republican Party 1st District Vice-Chairwoman and Lake County Republican Party Vice-Chairwoman Rachelle Baker is set to resign the second week in June, the Vice-Chairwoman announced on Wednesday, May 23, 2023.

Rachelle Baker wrote that her family has been presented with professional opportunities outside the Republican Party that require relocation.

In a letter dated Wednesday, she submitted her official letter of resignation effective June 7, 2023.



"I will be forever grateful to the conservative precinct committeemen/women in Lake County for electing me in 2021 to serve as the Vice-Chairwoman. When I was elected at the caucus, I said: 'I am dedicated to helping prepare the way to advance life, individual liberty, and limited government for all people.' I kept my word. I intend to maintain relationships across the party and support those who champion conservative values and traditional freedoms. I stand ready to assist the team in a seamless transition however I can." Baker said.

Baker stated she hasn't discussed possible replacements with Republican leadership, saying her departure should allow plenty of time to put someone else in place before the 2024 presidential season.
