

Notice of Cameron County Drainage District No. 6's Citizen Participation Plan

for

Texas Water Development Board - Flood Infrastructure Fund SFY 2024-2025

Cameron County County Drainage District No. 6 ("Drainage District") will be submitting applications for Flood Mitigation Projects ("FMP") funding to the Texas Water Development Board's ("TWDB") Flood Infrastructure Fund SFY 2024-2025 Program ("FIF Program").

The FIF Program is a competitive program that will award a combination of grants and zero percent interest loans.

As part of its Citizen Participation Plan, the Drainage District will be accepting public comments and hosting public hearings. Members of the public are strongly encouraged to participate in this process.

The public comment period will be open from February 15, 2024, until March 6, 2024.

As background, the TWDB is accepting applications for funding for construction and implementation of flood-control projects under its FIF Program.
