❖ *Document's Required –*

- *Passport Scan Copy*
- *Certificate on the absence of Tuberculosis*
- *Bank Guarantee 1,270 Pound in the native bank*
- *Original Police Clearance Certificate*
- *Biometric Photo*
- *Previous Passport (If Available)*
- *Applicants can be from 18 years old to 55year.*
- *Education does not require our language skill.*
- *Responsibility & Stamina must be better.*

❖ *Work / Duties / Work Validity –*

- *Collecting seasonal Produce in greenhouse and fields*
 - *(Strawberry, Asparagus, Mushroom, Fruits, Vegetables, etc.)*
- *Packing of harvested Products on the belt in the production warehouse of the Agro-farm.*
- *Seasonal Working Visa T5 (Tier-5), Valid Working Period for 6 Months with the right to travel.*

❖ *Terms And Conditions –*

- *No fake documents should be provided when asked.*
- *There should be no Deport Sign or Crime Record.*
- *The Candidate must also pay the consular fee and Service fee of 400 Euro.*
- *Work Permit Issued with QR Code and Government Approval (UK Identify Paper)*

❖ *Housing / Accommodation –*

- *Accommodation is provided by the employer in cabins with all amenities inside.*
- *The accommodation conditions are great.*
- *Lodging costs £40- £50 Pound per week.*
- *Accommodation and Working conditions are monitored by separate authority.*

❖ *Timing, Meal, Salary & Feed Back –*

- *Working Day 5 to 6 days a week.*
- *Working hours 10 to 12 hours a day, depending on the weather.*
- *Total 55 to 60 hours a week.*
- *Overtime will be extra time that you work.*
- *Meals are at our own expense, which is up to £40 pounds per week.*
- *Salary Approx. (2500 -3800 EURO) – 10.50 EURO / Hour.*
- *Overtime is usually +40 -50% of the rate.*
- *Salaries are paid weakly.*
- *Employers provide free grocery shopping.*
- *Employer Provides Feedback and Reference for Future Employment.*

❖ *Things You Cannot Do –*

- *Take a Permanent Job.*
- *Work in a Second Job that is not described in your Certificate of Sponsorship.*
- *Get Public Funds*
- *Bring Family Members with you.*

- ❖ *For Renew or Extension or to Convert from Seasonal Visa To Permanent Work Visa.*
 - *You Need to take time of 1.5 – 2 months off, before your work permit is expired.*
 - *Documents you will need.*
 - *Presentation and Selection of Employer.*
 - *Registration of Employer of all necessary documents for official employment.*
 - *Visa Application from the Visa Center of Great Britain.*
 - *You Must be in UK, to do this process.*
- ❖ *All Terms and Conditions of Employment, Accommodations, Insurance etc. are covered in the employment contract. 100% Guarantee of Compliance with all Terms and Conditions.*
- ❖ *Note : Pakistani, Bangladeshi, Irani, Afghan, Russian can get little difficulties issuing visa, But our lawyer will fallow and remove all difficulties.*
