SUPPLY OF INDUSTRIAL EXPLOSIVES AND ACCESSORIES

Drill and blast method is mostly used method for the excavation throughout the world. The method can be used in all types of rocks and the initial cost is lower than the mechanical method like TBM. This tunneling method involves the use of explosives. Compared with bored tunneling by Tunnel Boring Machine, blasting generally results in higher duration of vibration levels. The excavation rate is also less than TBM (usually 3m to 5m a day).

The typical cycle of excavation by blasting is performed in the following steps:

- a. Drilling blast holes and loading them with explosives.
- b. Detonating the blast, followed by ventilation to remove blast fumes.
- c. Removal of the blasted rock (mucking).
- d. Scaling crown and walls to remove loosened pieces of rock.
- e. Installing initial ground support.
- f. Advancing rail, ventilation, and utility works

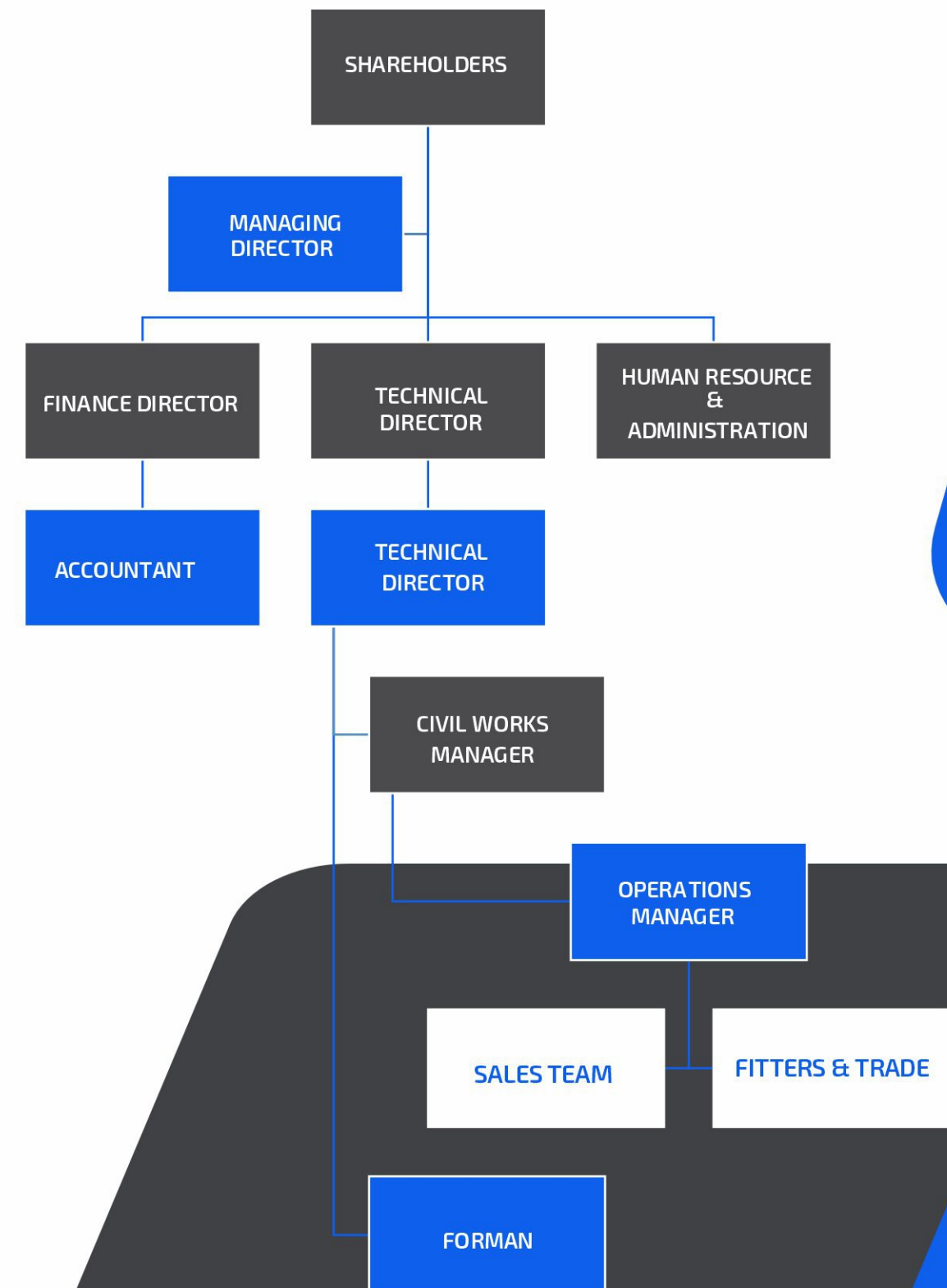
