# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.triplethreatfirearms.com, and Triple Threat Firearms and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Triple Threat Firearms include www.triplethreatfirearms.com and Triple Threat. The Triple Threat website is a Internet gun sales site. By using the Triple Threat website, you consent to the data practices described in this statement.

# **Collection of your Personal Information**

In order to better provide you with products and services offered, Triple Threat may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
