## **Association Rules**

This revision (May 2023) supersedes all previous editions.

## Any person who violates any rule is subject to disciplinary action.

- 1. All members must carry their membership cards and an additional form of ID when on Association property and must produce it upon the request of any Association member.
- 2. Individuals are responsible for their own property. The Association assumes no responsibility for loss or damage to any item(s) or equipment.
- 3. No one is allowed in the club office other than officers without the permission of a Club Officer.
- 4. Proper respect must be shown, and hats must be removed during the Pledge of Allegiance at the beginning of any Club meeting.
- 5. Profane language, derogatory ethnic, racial, religious, or sexual comments or actions will not be tolerated. Offenders may face disciplinary action as a result.
- 6. Members are encouraged to bring guests to the clubhouse. However, members are responsible for the conduct of their guests. Any guest who visits frequently will be approached to become a member.
- 7. No loaded firearms of any type are permitted in the social area of the clubhouse at any time. Persons with a PA License to Carry a Firearm may carry a licensed handgun, but the firearm must remain holstered and secured at all times. If for any reason the person wishes to un-holster a loaded firearm they must proceed to a firearms range before doing so.
- 8. Organized club activities shall have preference over any individual activity.

- 9. Anyone who damages or defaces any Association property will face disciplinary action and be required to make full restitution for the damaged/defaced property.
- 10. Camping is permitted only in designated areas during planned or special events.
- 11. Open fires are not permitted on Association property except in designated places during planned special events. Any open fires must be controlled at all times and extinguished completely before the person(s) responsible leaves the area. During a state or county fire ban no fire will be permitted for any reason.
- 12. Alcoholic beverages are strictly banned from any firearms or archery range. The pavilion at the rifle range is to be considered part of the rifle range. Any person suspected of being under the influence of alcohol or any controlled substance will not be permitted to participate in any event on any range or be in possession of a firearm or archery equipment on Association property. Careless or unsafe actions will not be tolerated at any time. Anyone observed acting in such a manner will be asked to leave Club property.
- 13. The use of 50 BMG firearms is not permitted on Club property.
- 14. Only Association members may hunt on club property. A guest may accompany a physically challenged member while hunting but shall not be permitted to drive any game or carry any firearm on Association property and must remain within close proximity of the member.
- 15. Motorized vehicles shall not be operated on club property except for maintenance activities by authorized workers. This includes but is not limited to ATVs, motorcycles, and such type vehicles. Normal access roads to the rifle, pistol, and cowboy action ranges are open to members using licensed vehicles. Physically challenged members may use vehicles to hunt within the limits of their permit issued by the PA Game Commission.
- 16. No one shall be permitted to remove or borrow from the premises any article of club property to include any natural material including but not limited to, trees, plants, firewood, rocks, stone, etc, without the permission of a Club Officer.
