APRIL 14, 2025**

Call to Order:

Vice-Chairman Fedder called the regular meeting of the Board of Supervisors to order at 6:00PM. In attendance were supervisor, Bobby Christiansen, Secretary/Zoning Dale Sneidman, Chief Richendrfer. There were 17 residents present and two guests. Chairman Baker was absent

Approval of Minute

For the Good of The Township

Vice-Chairman Fedder opened the meeting up to residents to discuss the contaminated well situation. We had three families, Terri Campbell from Senator Lynda Schlegel Culver's office and Greg Reichart from Orange Township. Two of the three families have already had their water tested by DEP and found it to be contaminated. The focus of the discussion was how to make sure all residents are aware of the situation. What size meeting should be held and who should be the host?? Terri stated that DEP and all state representatives are working together on this matter. Residents are currently getting bottled water to drink. Water filtration systems have been offered, but that is only a temporary fix. Terri stated that DEP and state reps will be at the Columbia County Commissioner meeting this week to make sure they are up to speed. Veolia Water company has been informed of the situation and looking at what possible role they could play in the solution. Supervisor Bobby Christiansen handled the questions and stated he has been going to Commissioner's meetings and would continue to be a contact for South Centre residents.

Motion to pay Bills.

Bobby Christiansen made a motion to pay bills. Scott Fedder 2nd the motion. Passed 2-0
