## **Fundraising**

During the past year, emphasis was placed on developing possible new avenues for raising money to support the Foundation objectives. Many have contributed original, creative ideas that have generated funds and involved the community thus creating increased awareness regarding our mission.

A new, online PBGV Foundation store offering unique PBGV items was opened for business by Foundation Board member Sue Smyth in November 2011 with the assistance of Board member Pam Helmer. . Ms. Smyth and Ms. Helmer imported gold and silver PBGV jewelry from England (we are the only U.S. agent for these beautiful items), obtained hand-painted PB items from artist Jackie Adams, added note cards, ceramic wine coolers, socks, umbrellas, and lots of other things which provided for store inventory. But for an integrated website with store capabilities we thank PBGVCA Webmaster Veronica Sheer and Foundation volunteer Sheryl Bradbury for their endless hours of work setting up the infrastructure for our new store. In little more than a month the store took in enough profit to pay for inventory and sales continued to be strong into 2012. Successful projects for 2011 included the donation of vacation opportunities including a week at a fabulous vacation home in Vermont (Laura Liscum/Jerry Faust) and for 2012 a vacation week at a Disney property (Linda Murray with thanks to Paula DePalma) with more with more vacation get a ways being developed. The Pennies for PBs project (Carolyn Randell, Alice McGowen, and nursing home helpers) consisted of mailing out piggy banks to those willing to collect spare change and then sending a donation check to the Foundation equal to money collected. Piggy bank owners are starting to send in the results.

We are so pleased to report that two PBGV Regional groups supported the PBGV Foundation this year during the National Specialty. The Texas group made up packets containing a variety of homemade dog cookies, and the Carolina Group sold ringside seats during the National and Regional Specialty shows. .

Highlights of our fundraising efforts at the 2011 PBGVCA Nationals included a very successful auction. Along with many wonderful items available during the silent auction, the live auction included gorgeous jewelry donated by Barbara and Gary Oxholm, a week's stay at a beautiful southern Vermont cabin donated by Laura Liscum and Jerry Faust, and a lovely picture of the Skycastle PBGV hunt pack. Carolyn Randel had little plastic cosmetic bags with the Foundation logo and darling PBGV socks made up just for us which were given away in return for a \$20 donation – these were a big draw to our

education table. All in all, we raised \$5,579 at the Nationals this year, \$3,396 restricted to rescue efforts and the remainder for general use. PBGVCA members and others were very generous. Thank you all.

## **Health Research**

The Foundation has worked closely with the PBGVCA Health and Genetics Committee to identify appropriate and meaningful research needing support through the AKC's Canine Health Foundation (CHF) program. CHF generally provides at least 50% funding of research identified by its team of research experts and solicits the remainder of funding from breed clubs and others. The CHF research experts monitor the grant process through completion and provide reports of achievement. Dr. Laura Liscum, Chair of the PBGV Health Committee's Research Subcommittee, and an experienced health researcher in her own right interprets these reports into interesting and understandable language for Saber Tails.

## **DNA Bank**

The Foundation continued to financially support the PBGV DNA Bank at the University of Missouri which includes approximately 500 individual PBGV samples.

In late 2011, the PBGVCA Board of Directors elected to be an OFA CHIC (Canine Health Information Center) breed. "The CHIC DNA Repository, co-sponsored by the OFA and the AKC/CHF, collects and stores canine DNA samples along with corresponding genealogic and phenotypic information to facilitate future research and testing aimed at reducing the incidence of inherited disease in dogs." CHIC also stores their blood DNA samples at the University of Missouri so our existing samples there continue to be an important resource.

We will continue to encourage owners to submit DNA for their dogs and urge breeders to contact all puppy owners to submit DNA. The Foundation will reimburse up to \$75 per dog for veterinary fees and shipping expenses for submitting a DNA sample. See the Foundation web site for information.

#### **Electronic Health Survey**

The Foundation continues to fund the PBGVCA's cumulative electronic health survey. Annual snapshot for 2011 is not yet available.

## **Health Education**

The PBGV Foundation was pleased to sponsor Dr. Christopher Mariani, as the health speaker for the 2011 PBGVCA Nationals. Dr. Mariani is Assistant Professor of Neurology, College of Veterinary Medicine, North Carolina State University.

The Health Education Committee has submitted health related articles for Saber Tails as well as to promote participation in the PBGV Health Survey and PBGV DNA Blood bank, and there is a commitment to continue to promote all health related information to PBGVCA members and others.

#### Rescue

The Rescue Committee of the Foundation has worked with the Rescue Committee of the PBGVCA and the treasurers of both organizations to make sure that expenses for fostering, veterinary treatment and

other appropriate expenses were reimbursed. Bob Cohen prepared another successful grant application to the Pedigree Foundation.

## **RESEARCH**

This past year the Foundation has continued to actively review the current research grants sponsored by the Canine Health Foundation, which might have significance to the breed. Several grants were thought to have relevance to PBGVs and were sponsored.

The subjects of these studies are as follows:

Early Diagnosis of Cushing's Disease

The Rabies Challenge Fund

Identification of Novel Drugs to Halt the Metastasis of Tumors that Cause Cushing's Syndrome Defining the Genetic Basis of Inflammatory Bowel Disease

Understanding the Flexibility and Limitations of How Dogs Acquire Knowledge and Understanding.

The last three studies are detailed by Laura Liscum in an article in this issue

The Foundation sponsored Dr. Komaromy's attendance at the 2013 National Specialty to lecture and perform eye exams.. The dogs also had blood drawn with samples sent to Dr. Komaromy's lab( Primary Open Angle Glaucoma study) and to CHIC for DNA banking.

In 2015 the Foundation donated \$2,500 to Dr.Ned Patterson's Grant sponsored by the AKC Canine Health Foundation. His research is focused on looking for new genetic markers to Identify epilepsy.

A second grant was supported with a \$1000 donation focusing on structural defects/DNA analysis associated with closed angle glaucoma.

This past year the PBGV community worldwide has gained a tremendous tool to screen our dogs for Primary Open Angle Glaucoma. With the discovery of the marker by the Animal Health Trust we now have the ability to screen our dogs and identify the status of our dogs. Everyone has been on a huge learning curve trying to understand the process and the implications of the results. The Foundation and the Health Committee have collaborated on disseminating information to PBGV owners, helping them negotiate through the testing process.

The Foundation supported these efforts financially also. This support will continue in 2016. This will be reevaluated yearly.

The members of the Foundation Board are committed to the mission of the Foundation and are looking forward to the challenges of 2016. We wish all PBGV's and their people a healthy, safe
and peaceful year.
