<u>President's report</u>: Linda Murray--NNTR <u>Vice President's report</u>-Laura Liscum-NNTR <u>Secretary's report</u>- Sue Smyth reporting:

Laura motioned to accept the minutes. Helen seconded. All voted in favor.

<u>Treasurer's report</u>- Jo Ann Hacker reporting:

Balance is \$34,714.59 in our Money Market act.; \$1,564.23 in the checking account. Laura motioned to accept the treasurer's report, Jill seconded. All voted in favor. Discussion regarding the PBGVCA web mistress. JoAnne has information/password to go into Volution to work with our store. Sheryl can become administrator for the store/site. Helen suggested we go back to having our own web site & link to the club site. Bob suggested forming a committee to look for someone to develop our site. Members appointed to this committee: Bob Cohen & Laura Liscum.

### Committee Reports:

- **A. Fundraising-**we need to come up with new ideas to raise funds at the 2014 Nationals
- **B. Store** Sheryl Bradbury absent
- C. Health/Education/Research- Helen & Laura reporting:
- 1. Dr. Cathryn Mellersh, Head of Canine Genetics at AHT in the UK- if currently working on idiopathic epilepsy in the PBGV, & she supplies a paragraph describing her project, a \$5,000 contribution would be recommended.
- 2. Three Grants identified of interest:
- A) Grant #2011- Identification of Novel Drugs to Halt the Metastasis of Tumors that Cause Cushing's Syndrome. Cushing's is a problem in our breed, although only 15% of the cases are due to adrenal tumors. Most Cushing's cases are due to tumors of the pituitary. Laura's research revealed SF-1 antagonists such as the investigator is testing have the potential to suppress cortical levels in all Cushing's patients. Donate \$2,500
- B) Grant #2002- Defining the Genetic Basis of Inflammatory Bowel Disease-study focuses on finding genetic factors that contribute to IBD in GSD's. Donate \$2,500

- C) Grant #1995 "Understanding the Flexibility & Limitations of How Dogs Acquire Knowledge & Understanding: Application to Service Dog Emotional Health & Selection. Suggested that the club support this grant using it's Donor Advised Fund. However the DAF only has \$1,423 as of December 2012. Perhaps the DAF could contribute \$1,400 & the Foundation could contribute \$1,100 to make the minimum contribution. Laura made a motion to fund each grant with \$2,500; Bob seconded the motion. All voted in favor.
- **D** Policy and Procedures-Bob Cohen-reporting about trademarks/copyright. Cost \$35 to copyright our logo. Trademark/Patent is much more complicated. Common Law trademark does not need to be registered. Cost is prohibitive for us. Bob recommended we be more careful. Bob will write a policy for PBGV Health & Rescue Foundation. He will also look into copyrighting our logo.
- **E. Rescue** Bob reporting: none in foster (2 were adopted in the last 2 weeks).
