#### Accountant's Report

#### WATER HOOKUP PROJECT

As previously reported, Bid Submittal/Opening Location and Time: Souder, Miller & Associates, 2904 Rodeo Park Drive, Building 100, Santa Fe, NM 87505; was scheduled on June 5th, 2025 at 2:00 pm. However, it was postponed by Engineer Amendment for today, June 10, 2025 as a result of delays with receiving the necessary wage determination from the Department of Workforce Solutions. Opening Bids were held today in Santa Fe at the Office of Souder Miller Engineering. The lowest bid came in at \$267,837.51 and will be awarded to: *Apple Mountain Contractors*. The following process must take place before actual construction begins, estimated for the middle or late July of this year:

- 1. The Engineer will make a formal recommendation to the Board. This will happen within a week. We will need a Special Board meeting for this.
- 2. The Notice of Award will need to be signed by Association Board Member.
- 3. The Contractor needs to prepare Performance Bond, Certificate of Insurance and the executed Agreement.
- 4. 2 copies of the Executed Contract will be issued to the Contractor and 2 copies to the Association.
- 5. The Contractor needs to be ready in terms of purchase of supplies and materials needed for the project such as meters, copper setters. He will notify the Engineers when ready.
- 6. The Engineer will then issue the Notice to Proceed with construction.

In the meantime, I have been corresponding with the DFA Local Government Division to submit the first invoice for services rendered to date. The process has been cumbersome since documents submitted for payment have to meet very specific requirements. As I indicated previously, the \$200,000 DFA Appropriation for this project must be expended before the remaining funding sources.

#### **SEWER CONNECT PROJECT**

As a follow up on my May report, in correspondence with our contact person on the \$3 million Federal Direct Spending funding with respect to our funding application, it has been determined that the State Historical Preservation Commission is now requiring a Cultural Survey for the project excavation the areas of "Potential Effect" may have not been included in the survey on sections of the project design. An Environmental Report for the "East Pecos Sewer Collection System" was prepared on October 2017, by HawkPoint Environmental Consulting, LLC. This report which took several months to compile comprehensively addresses all environmental impacts and consequences in the development of this project, as well as any Cultural and otherwise sensitiveland impacts. Subsequent to this report, another environment report was commissioned by our current project engineers, CDM Smith and was prepared in April 2023, by Epsilon Systems Solutions, Inc. I have already corresponded with our federal contact person, our consultants and our engineers to hopefully avoid the need for another Cultural Survey.

Another survey will inevitably result in additional project and costs and delays. Our Engineer stated in her E-mail to me today that she is still waiting for the boundary survey from Wilson & Company.
