Candidates must accept nominations at the time made or, if absent, in writing. Candidates may accept nomination for only one office. Self nominations are acceptable. Nominations will be held for the following Branch offices:

President, Vice President, Recording Secretary, Financial Secretary, Treasurer, Sergeant-at-Arms, three (3) Trustees, MBA/NSBA Representative, Health Benefit Representative, Director of Retirees, and two (2) Labor Management Representatives. The term of office will be three (3) years beginning January 21, 2017.

Any member having applied for, or served as a supervisor within the last two years, including detail to an acting supervisory position, is ineligible for nomination.

As of September, 17, 40,000 CCAs have been converted to fulltime regular carrier status nationwide. With that news, nationwide we continue to struggle as only 54% of CCAs are retained. Locally our percentages are higher, as we take an interest in our CCAs. CCAs are the future of the USPS, and they should be treated better than they are. Stewards are instructed to introduce themselves to new CCAs, to get involved with their struggles. Remember back, we all had our struggles when we began our careers. In Branch 599 we strive to welcome in our CCAs, starter uniforms are available, and for the 2nd time this year we will be conducting a CCA Town Hall Meeting on October 20, to address their questions and concerns. We represent our CCAs during or past their 90-day probationary period to assure excellent representation. We have been successful in saving jobs; there have been situations we have been able to fight for resignations so a CCA can be rehired into another craft and/or government job. We have been successful to have our CCAs join the union, the National rate is 87%, and Branch 599's rate is over 90%. Nationally, contract negotiations look to improve starting pay and benefits. Training is getting a facelift, with another day added and more hands-on, a shadow day, and 4584s (street observations) to better prepare CCAs for the realities of the carrier job. We stress giving CCAs the opportunity to learn, and finding the deficiencies which may require additional training.

Things to know about CCAs: 20 frequently asked questions

 Do CCAs receive Night Differential or Sunday Premium? CCAs receive Night Differential as defined in Article 8.7 of the National Agreement. CCAs do not receive Sunday Premium.

2. Do CCAs have a work hour guarantee?

Yes, CCAs employed in post offices and facilities with 200 or more work years of employment have a four hour work guarantee and CCAs employed in all other post offices have a two hour work guarantee.

Tampa has a four hour guarantee, it is important to note, any CCA scheduled to work and reports and upon reporting to work is told they are not needed will be paid the four hour guarantee.

3. Does the five-day break between CCA 360-day appointments refer to five calendar or work days?

Five calendar days.

- 4. Can CCAs be required to remain on stand-by or remain at home for a call-in on days they are not scheduled to work? No. This issue has gotten much better but there are still offices that want their CCAs on stand-by; it must be constantly monitored.
- 5. May CCAs carry over leave from one appointment to another?

No. Currently any accrued annual leave is paid out at the end of a 360-day term.

- 6. Are CCAs covered by the Memorandum of Understanding, *Re: Bereavement Leave*? Yes, however, CCAs do not earn sick leave and therefore may only request annual leave or leave without pay for bereavement purposes.
- 7. Can a CCA serve as a union steward? Yes. We have appointed several CCAs to steward positions and several have continued as stewards after being converted to fulltime regular.
- 8. Are CCAs entitled to higher level pay under Article 25 of the National Agreement? No.
- 9. What defines the anniversary date for the purpose of annual

uniform allowance eligibility for a CCA?

The calendar date the CCA initially becomes eligible for a uniform allowance.

10. How is the uniform anniversary date determined for a CCA who is converted to career status?

The employee retains the same anniversary date held as a CCA.

- II. Does relative standing earned as a CCA in one installation move with a CCA who is separated and is later employed in another installation? No.
- 12. Will CCAs be allowed to opt on (hold-down) vacant duty assignments? Yes.
- 13. Is there a waiting period for a new CCA (no former experience as a career city letter carrier or city carrier transitional employee) before the employee can opt on a holddown?

Yes, 60 calendar days from the date of appointment as a CCA. Once the CCA has met this requirement there is no additional waiting period for applying for/ being awarded a hold-down when the employee is converted to career.

- 14. Is there a difference in the application of opting (holddown) rules between parttime flexible city carriers and CCAs? No.
- 15. What is the official CCA Work Schedule?

The service week for CCAs begins at 12:01 AM on Saturday and ends on Friday at midnight.

16. What is a CCA's rate of accrual for annual leave? Is there a maximum?

I hour for each unit of 20 hours in pay status in each pay period. A 40 (Continued on page 4)

hour week earns 2 hours of annual leave. An 80 hour pay period earns 4 hours of annual leave, the maximum per pay period.

17. Do CCAs converted to fulltime regular serve a 90 day probationary period?

City Carrier Assistants converted to fulltime career status during the term of this agreement will not serve a probationary period when hired for a career appointment provided the employee successfully served a cumulative 360 days as a City Carrier Assistant directly before conversion to fulltime career status. CCAs who are converted to fulltime career status usually serve at least one 360 day term, very few conversions should face the 90 day probation.

18. Are there rules covering work hour guarantees for a CCA who has a gap between two periods of work?

Yes. If a CCA is notified prior to clocking out that he/she should return within two hours, it is considered a split shift and no new work hour guarantee applies. However, if a CCA is notified prior to clocking out that he/she is to return after two hours, the CCA must be given another work hour guarantee pursuant to Article 8.8 (2 or 4 hours depending on office size).

19. Must a CCA serve the entire 360-day initial appointment to qualify for Health Benefits? No. All CCA employees will be eligible for the USPS Plan within a reasonable period from the date of hire and entry into a pay status, consistent with the requirements established under the Patient Protection and Affordable Care Act. You must either elect coverage within 60 days of the date you were hired or during any open season period. CCAs who select self-only coverage and want to receive a biweekly contribution of

\$125 from the Postal Service toward their health insurance premium must select the USPS Plan. More than self-only coverage is also available. However, keep in mind that the Postal Service contribution is \$125 regardless of whether you elect self-only or more than self-only coverage.

20. Are CCAs converted to fulltime regular after the quarterly overtime desired list sign-up period (2 weeks prior) allowed to place their names on a list?

Yes, per local agreement, CCAs converted to fulltime regular following the signup period may place their names on either the overtime desired list (10 or 12 hours) or work assignment list (own route).

Vehicles: The Next Generation

On September 17, six different manufacturers have been awarded contracts to produce 50 prototype vehicles. The manufacturers include AM General, Oshkosh, VT Hackey plus three more, with the contract valued at over \$37 million. The Next Generation Delivery Vehicle, will replace the Grumman Long Life Vehicle (LLV) that's been in use since 1987. None of the designs have been revealed, but the preliminary requirements called for right-handdrive, sliding curbside doors for driver and cargo, a payload capacity of 1,500 pounds, interior height of six feet four inches, and an overall length of 19 feet. It's also expected to have either an aluminum or composite body and deliver significantly better fuel economy and emissions performance than the LLV. The prototypes will include hybrid, the newest in technological innovations and alternative fuel options. In addition, a variety of vehicle sizes, motors, transmission/drive trains, and different power trains to satisfy all delivery conditions. The manufacturers will have a year to produce their respective prototypes for possible approval. The

Postal Service over a six month period, will test the prototypes in different cities and states, different types of weather, different delivery methods, and testing all geographic challenges. The tests will also include: measuring temperatures inside the vehicle, safety improvements, maneuverability, and visibility. Production of the winning entry or entries is scheduled to begin in late 2018. —Postalnews.com

Sharing Our Members' Joys and Sorrows



Nick's News

Hello to all, active and retired. It's been a busy year so far, especially for the NALC. Our national contract expired in May and negotiations are ongoing, and it's a huge election year. I attended my second national convention in August, in Los Angeles, with the rest of our delegates and really wish that I would have started attending these things years ago. One of the things that I really appreciate at these conventions is the magnitude of the gathering of fellow carriers. Sometimes we forget just how grand the NALC is and the force behind it. To hear stories and issues from carriers across the nation and to realize that, for the most part, we all deal with the same issues is somehow comforting. Everyone there can relate to each other. It is also nice to be able to venture out a little to a part of the country that you may have not seen before. While we were there we used the subway several times, which is never boring, to go to the Hollywood strip and do some people watching. We also had to hit the In and Out burger, which probably tasted better than it really was due to the time of night we ate there. I was also able to take the train to the Santa Monica pier and walked to Venice Beach, where the freaks are and took an Uber to Rodeo Drive for a real fish out of water feeling. I can say that I've been there now though.

A few things from the convention that I thought I'd share:

1. Sunday Amazon is now in 8,590 ZIP codes with an average of 1.8 million

parcels delivered as of June, 2016.

- 2. Priority Mail same day delivery has started in San Francisco and New York, and in Sacramento there are carriers picking up parcels directly from Walmart to deliver to their customers.
- 3. Grocery delivery through Amazon Fresh continues and in some areas will be delivered by the regular on the route in their line of travel.
- 4. There are 7,000 Amazon cluster lockers that we are delivering to, for customer convenience.
- US Postal Service has given several companies the opportunity to build the next generation delivery vehicle, it would be one of, if not the largest, government vehicle contract ever. It would be approximately 180,000 vehicles at \$25,000-35,000 each.
- 6. The CDRAAP process added 2,600 routes nationally.
- 7. Scanner voice implementation is supposedly coming soon with possible turn by turn directions and parcel notification at each address.
- Our union is organized at 93.5% and our CCAs are organized at 86.9%, which is the highest that they have been ever.

I would also like to mention and to thank our branch for sending Steward Varick Reeder and me to the Formal A and Beyond training at the National Maritime Institute in Baltimore MD in September. The training was quite rigorous, but was well worth our time and the branch's money. We worked daily from morning

until night on cases that we would argue in front of a group of our peers at the training. We would take turns acting as the union and as management as though we were at an actual Formal A hearing, and of course they shifted us around a couple of times so we would not be with someone that we were familiar with. To see these Formal A meetings in a small group setting with facilitator and peer critiques was critical. Vice President Lew Drass lead the training and Regional Administrative Assistants lead the small groups; they were all exceptional. I would definitely recommend the course.

Get involved...come to some meetings. If you're interested in becoming a paid national delegate, it's easier than you think...just show up. Officer and steward elections are coming up as well, if you haven't been a supervisor in the last 2 years all you have to do is to be nominated.

Remember 3 things that we can control: our appearance, our attitudes and the service that we provide to our customers.
