the Postal Service from downsizing from near a

million strong at one time to little over half that size now, to assisting in interim route adjustments to save millions over what six day inspections cost. We don't work in the same system we did; just in the last five years drastic reductions have placed us at the point where we all do more and make more deliveries and with less personnel. This is a trend that will not change any time soon unless the economy improves and this nation puts more people back to work and the housing market begins to have new and steady growth.

As of October 1, 2011, I have joined the ranks of the retired members and I pledge to continue to actively pursue the rights of Letter Carriers and the working class Americans that we represent the same as I did as an active member for 38 years. I made this decision for the good of my office at TCA so that I no longer hold a spot on the leave calendar and to save the branch the high expense of paying for my benefits. I want to thank all the retirees for their support and activism to stand up for the active carriers that work to the 5 o'clock window and beyond and can't attend many of the rallies that are scheduled during working hours. When we presented the petitions to the Congressional District offices on September 27, the majority of those attending the rally were retired members. Next time a motion for retirees comes up at the union meeting, the active carriers need to show a little love and appreciation. It is more important than ever that active and retired members stand together in harmony, solidarity, and unity. I know a lot of you have been asking when we are going to get the truth out in the media and counter the

misinformation that is occurring daily. The day of the rallies I was involved in, two TV interviews and one radio interview, the media was contacted prior to that date, but it wasn't on their minds until the day of the rallies. There was also a lot of support from the AFL-CIO in getting the media attention. There was a lot of coverage at the rally at Kathy Castor's office when we rallied to thank the Congresswoman

for her support. There was no media at Gus Bilirakis' office in Plant City, which was mostly attended by rural carriers and a contingent group from Branch 599 when we presented the petitions to his staff member.

There is a lot of video on the NALC.org website showing rallies throughout the nation. After the rallies we finally had a majority of sponsor and cosponsors supporting HR 1351 that can provide the legislation to Save America's Postal Service. There were also gains in HRS 137 to save six day delivery with a few more cosponsors needed to have a majority vote on that issue as well. During this period the Branch has sent letters to all members of congress who are members of veterans and armed forces committees. One response from Congressman Allen West was returned addressed to Mr. A.R. "Tony" Huerta, even though the letter was signed by this writer; his response was about as misinformed as who it was addressed to. Apparently he has bought into the Congressman ISSA syndrome of gross misinformation.

### **Commitment to Our Community continues**

On October 2, we had our first annual *Fill the Satchel for MDA*, a day proclaimed for Letter Carriers by Tampa Mayor Bob Buckhorn. We received permission to wear our uniforms and use our satchels for this MDA fundraiser as we continue our pledge to

build a muscle for the kids at MDA. Although the turnout was small and we only had enough volunteers for two corners, it was still helpful. Sunday November 6, we will have the second annual Bowl-A-Thon for MDA; this coupled with two previous events will help us provide some badly needed funds to those locally who are suffering from neuromuscular diseases. Besides our efforts for MDA, also the

Combined Federal Campaign is starting for those who may have other charities of choice that they prefer to help. This is what members of the NALC do, besides the service we provide we also help our communities

and when there is a need, we will be there. The planning stages of *Toys for Tots* are underway, too. Let's keep counting our blessings and give until it hurts because there is always someone hurting worse than us.

### Stay Dedicated!

As we proceed towards the end of our current contract and look forward to our continued efforts to negotiate and bargain in good faith, we can only hope that there will be some common sense from our employer that has been lacking in regard to their employees. The effort that is made on a daily basis, in spite of deliberate decisions that are made to cause unwarranted disputes, shows the dedication of our craft employees. This coupled with some proper legislation can help the Postal Service return to the kind of service that we are capable of providing for all the citizens of our nation. Keep up the great job that all of you do and remember that our customers deserve our best!

Nominations for delegates to the 2012 NALC National Convention in Minneapolis, Minnesota were taken at the regular branch meeting on October 6, 2011 and will continue to be taken November 3, 2011, at the Union Hall located at 3003 W. Cypress St., Tampa, Florida 33609. The meeting is scheduled to begin at 7:30 PM.

Members must be present to accept nominations or have a written notice on file prior to the time and the presiding officer declares nominations closed.

Any member having applied for, or served as a supervisor within the last two years, including detail to an acting supervisory position, is ineligible for nomination.

In the event the number of nominations exceed the number of delegates allowed to the branch, an election will be conducted with the results announced at the regular branch meeting in December.

### Fill the Satchel for MDA

Brothers and Sisters, special thanks to the carriers who participated in the NALC Fill the Satchel for MDA. On Sunday, October 2, 20 carrier volunteers gave up their Sunday morning for a great cause. We met at the Union Hall at 9 AM to coordinate the threehour collection, which began at 10 Am. Two busy intersections were selected, Hillsborough Ave. and Himes Ave., and Dale Mabry Hwy and Kennedy Blvd. Additional volunteers would have allowed us to cover more intersections and thus collect more money. The 20 carrier volunteers represent about 2% of the total Branch 599 membership, active and retired. I know we can do better than that, just 3 hours of your time. We were well received by the passing motorists for the most part, however with the saturation by the panhandling, people were somewhat skeptical at first. Our clean Postal uniforms along with our new MDA signs separated us from the panhandlers. We still collected over 1,600 dollars, on a Sunday and on just two intersections. This was not only an important event for MDA, this was also great opportunity for the Letter Carriers to be seen in the public eye, in a positive light. With all the turmoil and uncertainty that surrounds the Postal Service these days, any positives are welcomed. I received many comments of support for our jobs during the collection. People still want and need the Postal Service, and events such as this promote just how important we are to the community. For those of you who were not able to volunteer for MDA this time, there will be more events planned this year. A national Bowl-A-Thon is scheduled for November 6. It would be great to have at least one team from each station. Make a difference...get involved.

### H.R. 1351 & H.R. 137

These numbers should be very familiar to you. If they are not, you do not care about your job or about the future of the Postal Service. I would think now is a really good time to educate yourself and get tuned-in with these two critical House Resolution Bills. If you are an *e-activist* (a free NALC informational service), you should be up-to-date with all pertinent information and news that will affect all of us. Let's briefly review these two bills. *This information comes directly from the NALC website:* 

### H.R. 1351

### H.R. 1351 takes the necessary first steps toward ensuring a

financially sound future for the United States Postal Service. The bill was drafted with three major components, taking into consideration the recent Segal Company Report issued by the Postal Regulatory Commission:

- 1. It calls on the Office of Personnel Management [OPM] to recalculate the USPS surplus in the Civil Service Retirement System within six months of enactment, using a methodology that fairly allocates the cost of pensions between the Post Office Department and the U.S. Postal Service as proposed by the Segal Report.
- **2.** Then, once the accurate *postal* surplus is determined by the OPM, the agency would have 15 days to transfer the surplus to the PSRHBF.
- **3.** Direct the OPM to permit the USPS to use most of its \$6.9 billion surplus in the FERS system to satisfy two obligations in FY 2011: a \$5.5 billion payment due to the PSRHBF, and a \$1.2 billion estimated payment to the Department of Labor for Federal Employees Compensation Act (worker's comp.)

expenses. Any remaining funds would be used to reduce the Postal Service's normal costpercentage for FERS in future years.



Good news for **H.R. 1351**, in the House of Representatives, at press time for this article, there were 223 members, Democrats and Republicans who are already cosponsors of this Bill. That is a majority!

### H.R. 137

So far 205 House members from both parties are cosponsors of H.R. 137; this Bill expresses the sense of the House that the USPS should take "all appropriate measures" to ensure continuation of six-day delivery. There is still some work to do with H.R. 137, again at press time 13 more cosponsors were needed for a majority. This Bill should create a lively debate. However, if H.R. 1351 passes and the financial obligations of the Postal Service are corrected, is the discussion to eliminate the six-day delivery even necessary?

Stay tuned and stay informed.

### A Point of Personal Privilege

Recently I was given a letter from a brother letter carrier that stated I was repugnant. I was quoted scriptures as to apparently my need to repent? I guess I am a sinner for being a Democrat and a Liberal like my father. ### The United States Postal Service is in dire straits

because former Republican President George W. Bush's administration chose to force the prepayment of retiree benefits from the USPS in the amount of \$65 billion. It was to be paid out in \$5.5 billion amounts. No other business or corporation in the history of the United States has been forced to pre-pay for future retiree benefits! The Mail Handlers or the Clerk Craft have run an ad on television that clearly states that the USPS receives NO tax moneys or subsidies from the Federal Government to fully fund or assist the USPS. We only receive moneys to pay our expenses through the sale of stamps and other avenues of shipping. As always there are quite a few letter carriers unaware of any legislation in the House of Representatives that would require the payment of those pre-paid moneys

to be refunded to the USPS to make it solvent or go into the BLACK. Those of you that live in a district that is represented by a Republican, please write to them and request that they cosponsor this vital piece of legislation! This bill is H.R. 1351 (latest title: United States Postal Service Pension Obligation Recalculation and Restoration Act of 2011) that not one Republican from the state of Florida has cosponsored! Even though 19 fellow Republicans have cosponsored this bill from other states and they are: Charles F. Bass (NH-2), Rob Bishop (UT-1), John R. Carter (TX-31), Charles W. Dent (PA-15), JoAnn Emerson (MO-8), Michael G. Fitzpatrick (PA-8), Jim Gerlach (PA-6), Michael G. Grimm (NY-13), Richard L. Hanna (NY-24), Lynn Jenkins (KS-2), Walter B. Jones Jr. (NC-3), Peter T. King (NY-3), Frank A. LoBiondo (NJ-2), Tom Marino (PA-10), Patrick Meehan (PA-7), Todd Russell Platts (PA-19), Jon Runyan (NJ-3), Christopher H. Smith (NJ-4) and Don Young (AK-at large). There are 185 Democrats on board this important piece of legislation! One Democrat from Florida has failed to become a cosponsor as of this date (9/13/2011) and her name is Corrine Brown (FL-3). The Republicans that have *not* cosponsored this bill are: Sandy Adams (FL-24), Gus M. Bilirakis (FL-9), Vern Buchanan (FL-13), Ander Crenshaw (FL-4), Connie Mack (FL-14), John Mica (FL-7), Jeff Miller (FL-1), Richard Nugent (FL-5), Bill Posey (FL-15), David Rivera (FL-25), Tom Rooney (FL-16), Dennis Ross (FL-12), Steve Southerland (FL-2), Cliff Stearns (FL-6), Daniel Webster (FL-8), Allen West (FL-22) and C.W. Bill Young (FL-10). If you need some talking points on this bill to write to your Republican representative, you can find them at nalc.org. President Fred Rolando has been quite vocal on this bill (HR 1351). Please apply for the monthly deduction of \$5 to COLCPE to protect your family's

Postal Service customers deserve first-rate service six days a week.

The Postal Service is critical to our economy—delivering mail, medicine and packages on time and at an affordable price, without a dime of taxpayer money.

But no company can grow or even maintain its business by cutting its service. Reducing the scope and quality of service by eliminating Saturday delivery service or closing post offices and facilities will not restore the Postal Service to health. It would likely drive mailers away and therefore worsen the Postal Service's financial problems.

- Cutting Saturday delivery is penny wise and pound foolish—a 16 percent service cut that saves little money.
- Closing post offices and facilities will cost jobs, cut off rural communities and make it harder for small businesses to grow.
- Eliminating Saturday delivery would undermine the Postal Service's role in parcel delivery, the fastest growing part of the postal industry.

The root of the Postal Service's current financial crisis is a 2006 law that drains the USPS of \$5.5 billion a year and forces it to overpay billions more into federal pension accounts. Congress created the USPS financial crisis, and Congress can fix it—without drastic cuts in service or massive layoffs, and at no cost to taxpayers.

### Things You Should Know

### The Final Chapter for TLC

Our lawyer, E.G. Bourlon P.A., has now completed all the paperwork and we have filed with the Florida Department of State regarding the dissolution of Tampa Letter Carriers Inc. This was voted on and approved at several meetings by the TLC members and then by the Branch members which was sufficient for approval. The Branch members also appointed and approved a new Building Manager along with his monthly salary. All of the Hall's physical and financial assets were counted and verified by several members appointed by President Peacock, so the dissolution of Tampa Letter Carriers Inc. is now final and the Building Trustees will have supervision over the operation (rentals) and maintenance (repairs, cleanup, etc.) of the building of A.R. "Tony" Huerta Branch 599 NALC. The Hall and all its assets are now under one umbrella which is Branch 599. The building trustees constitute the Branch's President, Vice President, Financial Secretary, and the Board of Trustees who will submit for approval, a monthly report to Branch 599's Executive Board along with a monthly financial report to the Branch members.

On another note, there have been several rallies across the nation in order to educate the public on

We also held a rally at Plant City and another group stayed in Tampa to try to get support from our representatives on our bill being constituted in Congress. All of us have a say in our future; make your concerns count and force the politicians to decide a better future with our voices, rallies, and letters. Our 20 billion dollars in Postal losses don't stem from the mail, rather a 2006 Congressional mandate on prefunding future retiree health benefits. There is a 20 billion dollar cost since 2007 which accounts for 100% of the agency's red ink over that period. Congress created this mess, so let our lawmakers fix it; we must help them pass House Bill 1351 for that
