## From the President's Desk

With the advent of the Memorandum of Part Time Flexibles being given the opportunity to eReassign to become full time carriers, note that presently, there are no positions in the Suncoast District that have been listed for this purpose. Even though we have at least 14 positions in the Tampa installation that are Carrier Technician vacancies that cannot be held for withholding for excessing employees from another craft. We currently have a grievance that is part of a partial settlement that included converting our last Part Time Flexible to one of our Carrier Technician assignments to become full time. When the memorandum on eReassign for the Part Time Flexibles is exhausted and there are still vacancies that have not been filled, we expect to fill these by converting senior City Carrier Associates that have at least one year of

relative standing in the carrier craft. The original memorandum was to expire April 10, that was extended until May 10 and the parties stated that they could extend the memorandum again. We have to be patient with the constant changes that are coming from the national level. When we look at our situation and magnify what they are looking over at the national level it is easy to understand the complexity of dealing with this particular contract issue. Remember, the only contractual conversion to full time that exists is that all Part Time Flexible carriers will be converted to full time by the end of the current Collective Bargaining Agreement. This must not be confused to say that they will be the only ones, but they are the only ones guaranteed.

There are many concerns regarding a mountain of issues

pertaining to the new **City Carrier Associate** position and the different Question and Answers memorandums that keep coming out to help in the interpretation of many of these issues. This will be a work in progress no different than any contract negotiation from previous periods. Even once we have a contract, it takes several years to get a Joint Contract Administration Manual to assist in settlement of interpretation. Once we have that we still will have disputes that arise because two people will rarely agree on the same meaning that was supposedly jointly decided. The Tampa Post Office has hired over 120 of these new carriers and hopefully they will have the opportunity to have a great career like most of us have enjoyed. (Continued on page 3)


