State of the Branch 599 Report - year ending 2016

Branch Bylaws, under Duties of the President, Section 1. (A), states:

Representation

◆ Representation of our membership is our number one focus; we construct and produce quality grievances, and assist in EEO cases. Our success rate is extremely high at all levels...Informal, Formal and B-Team decisions.

◆ We have recruited new stewards and have alternates in training. We have a diverse group of stewards that include all races, genders, and nationalities and the Branch should be extremely proud of that. Representation has no barriers, and no colors, everyone is equal.

counseling and OWCP cases. We find the answers and refer our members to qualified NALC representatives and specialists with any questions we cannot answer.

- ◆ We have dealt with the new CCA workforce: saving jobs, converting over one hundred to full time regular, conducted town hall meetings, ensured proper training, we provide starter uniforms, we address questions and concerns, and we strive to keep our retention rate above the poor national average.

- ◆ We comfort members who have lost loved ones, who are dealing with personal and or family issues. We send sympathy cards, make phone calls, and mail out any necessary paperwork needed. We visit funeral homes, churches, members' homes, hospitals, and rehab centers.

Charities

- ◆ Letter Carriers Annual Golf Tournament benefitting MDA. Three Annual Golf Tournaments have generated \$18,000 for the Muscular Dystrophy Association. Great times, great raffle prizes, very organized, many volunteers...**it is an event!**

- ◆ Letter Carriers Food Drive. Branch 599 continues to hover around one million pounds collected annually; supplying food pantries throughout Hillsborough County. Our one-day collection is 90% of their collections for the entire year.

- ◆ We will take a proactive approach to the failing Toys for Tots drive that is just a shell of what the program used to be. We will not allow the kids to do without...we will make a difference!

Building

- ◆ We have kept our building beautiful by continuing to improve and maintain our facility. Two new air conditioners and a new roof has solidified this building and enhanced the rentals. We have painted and repaired and done the necessary upgrades as needed. We have AC and roofing maintenance

agreements in place to keep the building operational. Our rentals continue to soar. Repeat customers are complimentary of our hospitality and cleanliness. Work parties once a month are productive. *Thanks* to all our volunteers, working to continue to keep this building beautiful. Our Building Fund allows us to maintain and repair the hall without any monies from the Operational Fund.

In Closing

- ◆ I am very conscious to the image of Branch 599, statewide and nationally. Our Branch had a strong showing at the past 2016 State Training Seminar, where we were very much a part of the training. Two of our members headed classes that were very educational. In addition, hosting the State-wide Retirees Seminar, that was acknowledged throughout the state as a success by the attendees, has placed Branch 599 on the map positively. Thinking Past Retirement

Most of us think of retirement as the next phase, and having many many years to enjoy what we worked our whole lives for. While retirement may be thought of as the next phase of life, there is more to think about as we all

become older. I am talking about long-term care, defined as someone with a long physical illness, a disability or a cognitive impairment (Alzheimer's disease) often needs long-term care. Many services help people with chronic conditions overcome limitations that keep them from being independent. Long-term care is different from traditional medical care. Long-term care helps one live as he or she is now; it may not help to improve or correct medical problems. Long-term care services may include help with activities of daily living, home health care. So who pays for long-term care? How do you pay for it? Will you be prepared to pay for it if needed? Will you have the extra assets available to afford your needs? Does your health insurance cover long-term care? Does long-term insurance cover all services or are they specific to certain needs? How much coverage should you have? Would long-term insurance protect your assets and income? Is long-term insurance tax deductible? When do the benefits begin and how? **Protect yourself and your family and your assets.** Do not place the burden on your children. Our health benefit plan does not cover long-term care, so educate yourselves, and be prepared should you need long-term care. Contact your health care provider, and you can always Google long-term care.

FDA Approval of Spiranza

Happy New Year! You may have read or heard this in the news already, but I wanted to make sure you heard from MDA as well, since you're such an important part of the MDA family.

Last week, the FDA formally approved a new drug from *Biogen/Ionis*—called Spiranza—for the treatment of spinal muscular atrophy (SMA). To make it

even more meaningful to you, SMA is the disease that many of our Tampa Bay area kids are living with including Allison, Isabelle, Tyler, and Becky as well as our National Goodwill Ambassadors Joe and Reagan. As you can imagine, this is the news MDA families have been waiting to hear for decades, and another example of why your support of MDA research has never been more important.

Following the approval in September of Exondys 51 for the treatment of Duchenne, this news marks another solid step forward—of turning promise into progress. The success of these two new drugs will encourage

more partners to move into the neuromuscular disease space, inspire research innovation and drive the development of new treatments and cures—not only for SMA and DMD, but for all muscle diseases.

MDA could not have done this without you. Your commitment to MDA has helped us spearhead this research development and new treatment option for SMA families.

The Key

Greetings fellow union members and Letter Carriers and Welcome to 2017, which is off to a bang up start. Let's start off the New Year with a discussion about safety. For starters safety is everyone's responsibility, from the Postmaster General right down to the new hire CCA. There are procedures and directives in place that govern how safety is to be addressed, but they all pale in comparison to the human ability to address safety issues head on. We observe daily issues that if not addressed can and often do lead to accidents because they are safety issues just waiting to happen. From the banding strap on the floor to the failure to write up the vehicle with a warning light on, these issues are simply accidents waiting to happen. Clearly we don't need to have a directive to remind us to pick up the banding strap so no one slips on it and falls and common sense tells us if there is a warning light on in our vehicle we need to have it checked out before continuing to use the vehicle. These examples may be simple but they show some of the safety issues that happen daily that sometimes go unchecked because many think it is not their responsibility. Hopefully you, the reader, can now see that it is indeed everyone's responsibility.

All stations in the installation are supposed to have a safety captain and a

safety committee which should be meeting on a monthly basis to help address safety issues as they arise as well as trying to prevent safety concerns from becoming problems by addressing them before they escalate. The meetings are to have minutes kept so all issues raised are recorded. If your office is not having monthly meetings or worse, has no safety committee, please let the Branch President know as this is unacceptable and goes against the stated goals for safety within the Suncoast district.

There are several safety related forms that you need to know about which should be used when needed. The form 1767 is for safety issues to be brought to management's attention as well as providing a record so the problem isn't forgotten. This form has multiple copies, one of which is returned to the person filling it out. Additionally one is sent to the Installation Safety Committee for follow-up to ensure the issue is corrected. Form 4565 Vehicle Repair Tag is used for identifying vehicle defects needing repair for the safe operation of the vehicle. This tag is filled out in the AM after the morning vehicle check prior to ever loading or taking the vehicle out to start delivering the mail. The morning vehicle checklist is contained on page 84 of the M-41 Handbook and it is important that it is

properly done daily to ensure for the safety of the driver as well as anyone that the vehicle comes in contact with each day.

These are just a couple of thoughts and basic information on safety and you in your position with the Postal Service; hopefully you understand its importance in the daily operation of your job. There are many publications in the Postal Service that address safety and if you have additional questions simply go to NALC.org and lookup Postal Handbooks and Manuals to review them at your convenience.



ARTICLE VI Duties of Officers Duties of Vice President

Section 3. (B): Currently Reads:

The Vice-President shall be in charge of all EEO cases for the members of Branch 599.

Section 3. (B): Proposed to Read:

The Vice-President shall be in charge of EEO Cases at the informal levels, redress and or mediation for the members of NALC Branch 599. This excludes Formal Hearings.

ARTICLE XI Funds

Section 3. Currently Reads:

All funds shall be devoted to such uses as the Branch may determine. Provided: That no appropriation shall be made except when ordered by not less than a two-thirds vote of the members present and voting at a regular meeting. Provided: That duly authorized bills for expenses may be presented by Branch Officers for payment. Provided: Further that Branch Officers may spend reasonable and proper amounts between Branch meetings in case of emergency as provided in Article XIII, Section I of these bylaws.

Section 3. Proposed to Read:

All funds shall be devoted to such uses as the Branch may determine. No appropriation shall be made except when ordered by not less than a two-thirds vote of the members present and voting at a regular meeting. Duly authorized bills and receipts for expenses must be presented to the Treasurer for proper reimbursement. Branch Officers may spend reasonable and proper amounts between Branch meetings as provided in Article XIII, Section I of these bylaws. All bills and claims in excess of \$1000.00 will be presented to the Board of Trustees for approval before being acted upon by the Branch.

ARTICLE VIII Committees

Section 2. Currently Reads:

All bills and claims in excess of \$1000.00 will be presented to the Board of Trustees for approval before being acted upon by the Branch.

ARTICLE XIII Executive Board

Section I. Currently Reads:

There shall be an Executive Board of this Branch, which shall be composed of the President, Vice-President, Recording Secretary, Financial Secretary, Treasurer, Sergeant-At-Arms, The Board of Trustees, Service Relation Representatives, MBA/NSBA Representative, Health Benefits Representative and the Director of Retirees. This Executive Board shall be empowered to act for the Branch between meetings and shall have the power to expend Branch funds not in excess of the sum of one thousand dollars (\$1000.00), when in the judgment of a majority of the members of this board, an emergency exists which justifies an expenditure of such money, for the best interest of the Branch or of the National Association of Letter Carriers.

Section I. Proposed to Read:

There shall be an Executive Board of this Branch, which shall be composed of the President, Vice-President, Recording Secretary, Financial Secretary, Treasurer, Sergeant-At-Arms, Board of Trustees, Labor Management Representatives, MBA/NSBA Representative, Health Benefits Representative and the Director of Retirees.

This Executive Board shall be empowered to act on behalf of the Branch membership between meetings and shall have the power to expend Branch funds, (with the exception of the Branch Action Fund), not in excess of the sum of five hundred dollars (\$500.00), when in the judgment of a majority of the members of this board, an expenditure of such Branch funds is necessary in order to maintain continued operations of the Branch and/or meet the need as deemed appropriate or required as necessary by the President or the Vice President if he/she is acting as President of the Branch at the time.

This Executive Board shall also be empowered to act for the Branch between meetings and shall have the power to expend Branch funds (with the exception of the Branch Action Fund), not in excess of the sum of one thousand dollars (\$1,000.00), when in the judgment of a majority of the members of this board, an emergency exists which justifies an expenditure of such money, for the best interest of the Branch or of the National Association of Letter Carriers.

The Birdseye View

The pomp and circumstance is all over and now it is time to roll up our sleeves and get to work in what may be a very adversarial administration towards unions and federal employees. The Office of Personnel Management has proposed a new rule saying the Postmaster General and the Treasury can work together to determine what percentage postal employees should pay into the Federal Employees Retirement System (FERS) and the Civil Service Retirement System (CSRS), rather than using standards it applies to all agencies. According to the Federal News Radio.com the Postal Service made the request since most postal workers tend to be from different demographics than the rest of the federal workforce. That sounds like an [end](#) around way of creating locality pay that the union has always seen as unfavorable, or possibility of dismantling the trust funds we currently have which are very solvent. Also announced on the first session of the new Congress, the majority party is moving to

repeal or dismantle many government programs such as Medicaid, Medicare and the Affordable Health Care. No mention yet of the Social Security trust which is solvent with \$2.7 trillion currently in the fund. These types of actions could be devastating to seniors, retirees and the truly disabled including veterans. Already starting off as what may be quite a tenacious year and who would have thought that.

On the branch level we have started off with several new bylaw proposals to be voted on in February in an effort to continue to update and make changes that help us stay in compliance with the way our Constitution and work place have changed. We will continue to look at the way we go about our business and make necessary changes that are in the best interest of all our members and meet all Labor Department Standards. Hopefully, everyone that attended the Installation and Member Appreciation Dinner and Dance had a very enjoyable time shared with other

brothers and sisters and friends and went back and told your coworkers that couldn't make it and what they missed.

Still at the deadline for the February articles there have been no updates on contract negotiations. The last two unions still negotiating contracts with the Postal Service are the NALC and the Mail Handler union. The same word seems to be that they both are finalizing details for pay and benefits especially for the non-career employees that had no sick leave or holiday benefits that have been awarded to the other postal unions that have settled through arbitration or members' ratification. We shall all hope!

Just in a day's work...

Training a new CCA and helping save a life

While training a new CCA, J.D. heard the voice of a fallen customer; hearing the cry for help, J.D. first made sure his vehicle was secured before acting to assist the elderly customer.
