## Legislation

We all have to pay attention to what


is happening in legislation that affects all postal employees, active and retired. Many retirees think that because they are retired they have nothing to worry about. That could not be farther from the truth and the recent senate hearings on S.1486 are the proof of that. If you are not contributing a measly \$5 to COLCPE or join eActivist for free, you are not going to know when you need to act on something that by one stroke of a pen could change everything you take for granted in retirement. I was recently appointed by State President Al Friedman to the position of Congressional District Liaison for District 14, Congresswoman Kathy Castor's district. Fortunately we have a great supporter in Congresswoman Kathy Castor, but there are 435 districts and many are not as friendly towards our concerns. Hopefully, next year we will put boots on the ground again like we did in the 2012, and make gains that will stop the stagnation and put America on a path that brings more jobs to Americans and support American companies that support the American economy. Saving America's Postal Service is a major concern for us and all Americans; we need legislation that stops the erroneous pre-funding that is only required by the Postal Service as 100% funding 75 years in advance while all agencies that are supported by tax payers only fund 30% annually. Even most corporations that prefund only do it at around 30% annually, so why burden only the Postal Service? It can only be for the purpose of dismantling to privatize. Get on board and join eActivist and COLCPE for the future of all active and retired letter carriers!

## Local Issues

The first conversions of CCAs [City Carrier Assistants] took place in some office November 2, 2013; why we always have to file a grievance in Tampa to get anything done is beyond me, but glad to see all offices are not dealing with the stupidity that we do. That is why we are on pace to have the most grievances this year since 2000. Most of the grievances pertain to an ongoing dispute over the Window of Operation that has been a battle since early this year and you have become use to working even later than their goal of 6 o'clock Window of Operation. There was a dispute in Minneapolis this year that all the violations of a similar conflict cost the Postal Service over a million dollars due to their ignorance, not including plenty of good customers they probably ran off. Forever it was pounded into us that all mail had to be delivered before five o'clock; what makes them think customers really want it later, on top of delayed mail and missed deliveries in the dark. They don't think about the consequences of their idiotic plans and the ones who make them keep being rewarded. # Around the Horn

**Merry Christmas and Happy Holidays** to all my Union Brothers and Sisters! This month I want to focus on what behavior is expected on our workroom floor. *Every employee should be treated at all times with dignity, respect, and fairness.* This statement is taken directly from the *Joint Statement on Violence and Behavior in the Workplace*, signed in 1992. We must insure that all carriers are and will be treated all times with dignity, respect, and fairness. This is not an option, there is no maybe, there is no might, **you/we** must be treated in accordance with the *Joint Statement*. The following three paragraphs of the *Joint Statement* (M-01242) are very powerful, and it is made very clear how we should all be treated on the workroom floor:

We also affirm that every employee at every level of the Postal Service should be treated at all times with dignity, respect, and fairness. The need for the USPS to serve the public efficiently and productively, and the need for all employees to be committed to giving a fair day's work for a fair day's pay, does not justify actions that are abusive or intolerant. *"Making the numbers" is not an excuse for the abuse of anyone.* Those who *do* not treat others with dignity and respect will not be rewarded or promoted, Those whose unacceptable behavior continues will be removed from their positions.

We obviously cannot ensure that however seriously intentioned our words may be, they will not be treated with winks and nods, or skepticism, by some of our over 700,000 employees. But let there be no mistake that we mean what we say and we will enforce our commitment to a workplace where dignity, respect, and fairness are basic

human rights, and where those *who* do not respect those rights are not tolerated.

Our intention is to make the workroom floor a safer, more harmonious, as well as a more productive workplace. We pledge our efforts to these objectives.

If you would like to read the entire *Joint Statements*, go to the NALC.org website. Once on the website go to Departments, then Contract Administration, look to the left hand column where you will find Joint Statement links. There are two, Joint Statements (M-01242 and M-01243). In addition you will find a National Arbitration (C-15697), this case National Arbitrator Carlton Snow, in 1996 declared that the *Joint Statement* was a binding contractual obligation and the NALC could file grievances to enforce it. It states, *The grievance procedure of the National Agreement may be used to enforce the parties' bargain, and arbitrators have available to them the flexibility found in arbitral jurisprudence when it comes to formulating remedies, including removing a supervisor from his or her administrative duties.*

With all that said, are you being treated with dignity and respect? Do you notice a coworker being treated abusively or disrespectfully? Do you have a supervisor or manager who *loses it* on the workroom floor? Remember, *Making the Numbers* is not an excuse for the abuse of anyone. A *bad estimate* is not an excuse. Being *down routes* is not an excuse. If you feel you are being disrespected or notice abusive behavior, alert your shop steward or Branch 599's office. We cannot allege...we have the burden of proof, documentation is key, and a witness or witnesses supports the claim.

Document any abusive behavior, include what was said, who said it, a time, a date, where it was said, how the situation began, what you believe the cause was, and mention anyone who may have witnessed the scene. Document immediately or as soon as you possibly can. This will provide the documentation to support a *Joint Statement* case.

## **Quick Hits:** **Information you should know**

**\*) 2014 retiree COLAs—1.5% for FERS & CSRS:** The cost-of-living adjustments (COLAs) for both Civil Service Retirement System (CSRS) and Federal Employee Retirement System (FERS) benefits will be 1.5% in 2014, based on the October 30 release of the Consumer Price Index (CPI) for September. Although the release of the September CPI was delayed by the 16-day federal government shut-down, the COLA will take effect on time and will be included in January 2014 annuity payments. The 2014 COLA is based on the increase in the average CPI between the 3rd quarter of 2012 and the 3rd quarter of 2013. Since the CPI did not increase by more than 2%, COLAs for both CSRS and FERS benefits will be the same in 2014.

# Time to Elect the Steward

It is that time again in Branch 599—time to elect Shop Stewards for the coming year. As guided by our By-laws, every year in the month of November we will prepare our membership for the election of new Shop Stewards.

The election process is started with meetings in each station zone where the Bylaw guidelines for the election will be read to the members of the station/zone in preparation for nomination of the individuals running for the position. The requirements of the position are that you must be a member of Branch 599 in good standing and you need to be nominated for the position, self-nomination is allowable. If nominated, the individual(s) must accept the nomination and show that they have not applied for and/or served in management positions in the previous two years.

Nominations will take place on two consecutive days so that all Branch members have the opportunity to hear the information and are able to be nominated or to nominate someone of their choosing. The two consecutive days may not be a Friday/Saturday.

If there is only one nomination made and accepted the election may be accomplished by a single vote as there is no opponent, however if

there are two or more individuals nominated there will be an election in the first week of December. A noninvolved member (one not up for election) may be used to conduct the election. The Branch office will provide the ballots for any election after being notified of the candidates and their ability to run and serve as a Shop Steward.

Once elected the new stewards are installed at the Branch Installation Dinner (in Branch election years, every three years) or at the January Branch meeting in non-Branch election years.

I know what you are thinking—why does this concern me? It is the right of every member to be allowed to run as a candidate as well as to vote for the candidate of their choice as their representative. This is the member that you want to represent you in dealings with management throughout the coming year and is not a choice that should be made lightly. You want to consider who will best represent you in the day to day issues that arise in the workplace.

Additionally you may want to consider throwing your hat into the ring and stepping up to be a steward. The job is important, but simply because you might not have as much experience as you think the job takes should not be a barrier to running.

Remember that the Branch has a wealth of experienced members who are active and available to assist new members just getting started as stewards.




