

As we report to work each day we wonder what new program management will think of to try to speed us up. From my experience, these programs have the reverse effect. I have suggested to many higher-level managers that, for example, they should call for a DPS holiday. Let the individual carrier decide how to handle their work for thirty days. Morale would be higher along with productivity. With the new health concerns brought about by anthrax, I suggested that casing DPS would be safer than handling it alone on the street. state my position on DPS. The test used in Memphis was flawed; it has been poorly implemented and managed. DPS, while it does reduce our office time, increases the total time that our daily assignments take. Not to mention trying to do a trip

as 20 minutes to my day. More money for me, less work I have to do and more work I get to give away to some other carrier so that they can make more money. As I have practiced most of my 22 years as a letter carrier, give me a rule

Doesn't Produce Service [some good, some stupid] and I will figure out how to use it to my advantage. My goal each day is to deliver the mail I am entrusted with to

my patrons as early in the day as possible and to make sure that they get only their mail. I do this while following all the LAWS, RULES, and REGULATIONS as I know them. I wonder how many more time saving ideas management has to slow us up?

#### 8-Hour Routes?

Through most of the past eight or so years, Branch 599 has benefited by having letter carriers involved in the route adjustment process. This has not been the case with the Rome administration in Tampa. The minor route adjustments made within the past couple of years have been done without the consent or the cooperation of any un-

ion representatives. They asked Sergio Garcia and me to help in the beginning and we refused because they wanted to adjust routes without inspection, using paper analysis that we do not agree with. I have been filing grievances against them since. Unfortunately,

our Dispute Resolution Team has stated that the word *minor* in route adjustments is silent and has allowed these proposals to be implemented. Given the state of our economy, it is even harder to find an arbitrator to rule against any adjustments that propose to save money. Finding problems or errors in their packages is easy, convincing those who decide on these issues is not. Arbitrators have allowed volume adjustments even when I can prove that their data is not only

faulty, but unreliable. Their latest twist is to analyze volume figures using median figures and comparing them to average adjusted mail volumes. Median figures are substantially lower, thus underestimating our actual mail volumes. This is comparing apples to

oranges when trying to evaluate routes.

The purpose of this article is to

stress one important fact. Regardless of any paper adjustment that management makes to your route, it is you, the regular carrier on the route who determines how long the route is on any given day. If they add an hour to your route, and you still do your route in 8 hours, then you only prove them right. Is your route 8 hours? It's up to you.

I can't close without responding to some criticism regarding a unit's complement, or number of personnel. Sergio and I have never, and will never negotiate a settlement reducing the number of letter carriers in any station. The complement of a unit is determined by a simple formula [the number of routes \* 1.44]. If management is using a new formula, then Branch 599 has not been notified and it should be grieved.

It has been a long time since our words have been printed. It's good to be able to vent again. This special issue of the *Tampa Letter Carrier* is brought to you by some very dedicated carriers, their wives, and families. So, you need to pay attention, read and seek what is in your heart.

I will quote [with I hope permission] of a letter carrier from our office—The Post Office is the only place that hires you, then tries to fire you for the next 30 years! Read it again! It's the truth, more so now than ever in the 15 years that I have been here. Every day we hear or see another carrier getting pulled into the office for an official discussion. They come out with a letter of warning in their hands, added to their file. What have these carriers done to deserve this? It is a constant your fault attitude from the bottom supervisors to the top. How many times a day do you hear: you're not scanning, you're not picking up the hot case, you're not picking up the collection boxes, you're not delivering Express on time, you're talking too much, you're too slow on the street, your office time is too long, you don't need

street help. You and I thought we were part of the Postal Service [often talked about in the many satellite broadcasts]. WE, should I say YOU, are now the lame duck. We are beginning to see the era of

the demise of the fulltime letter carrier. First step, abolishing utility bids. Have you noticed that they no longer post these positions once someone has left them? Sec-

ond step, hiring a casual work force of letter carriers. No training for these people and don't even complain about them, it falls on deaf ears. The biggest slap in our face recently is the contracting out of International Mall. Future contracting is now being looked at in new developments.

All the newly elected officers will need our best wishes and our pledge of support to work with them as needed for the good of Branch 599 and all members.



Dear Union Brothers and Sisters,

My name is Michael A. Lezcano, and I currently hold the position of Sargent-At-Arms with Branch 599. I am recently retired with the USPS and therefore would like to do more for less with Branch 599. Let me explain! I am in the running for Financial Secretary. A position that I think is a little overpaid. This position gets 2% of the gross receipts that our union takes in. This means that every time we get a raise and our dues go up, the Financial Secretary gets a raise. And when we add new members to the branch like PTF's becoming regular or stations like Plant City or Ruskin become members of Branch 599, the Financial Secretary gets another raise. I feel this is a great financial burden to our branch, especially when in my first year of being a shop steward I was told that there was a possibility of not getting my dues rebated!

Note: All branch officers and stewards are supposed to get their dues back at the end of the year. The Financial Secretary's pay is about \$7,600 per year plus dues rebated of \$468 for a total of over \$8,000 per year!!! Now that I'm retired. Branch 599 would only have to rebate my \$20/year. Plus I would like to do the job of Financial Secretary for more reasonable rate of pay, like a flat fee.

My experience is well suited to serve the needs of Branch 599. I am a graduate of Jesuit High School and had a 4.0 GPA in math. I am a licensed realtor and also soon to be a contractor after I test in the near future. I am trained in minor accounting practices including general ledgers, financial statements, balance sheets, depreciation, and bank statement balancing and financial ratios. I was a Shop Steward for 3 years, a Step 2 Designee for a short time, ran the CFC as Branch 599's representative, coordinated the food drive in 1999 and currently I am the Positive Greeter at the union meetings when you show up on Thursdays.

In closing I would like to say that I've been proud to serve the members of Branch 599 under President Lenin Perez. Hopefully I can secure your vote to keep our union strong against the constant menace of postal management. I feel I can do more for less and with your help together we will make it happen!







## **Notice of Nomination and Election for Branch Officers**

The official notice to all members of Branch 599 that nominations would be accepted for the following positions was published in the Postal Record: President, Executive Vice President, Vice President, Recording Secretary, Financial Secretary, Treasurer, Sergeant-at-Arms, MBA-NSBA Representative, Health Benefits Representative, Director of Retirees, a Board of Trustees consisting of three (3) members, and a Labor Management Committee consisting of three (3) members, one (1) of which will be the President.
