Around The Horn from The President's Desk

Happy New Year to all Branch 599 Brothers and Sisters! May the 2016 year bring prosperity, good health, peace, and the conversions of many, many CCAs.

As we begin another year, we are faced with many challenges in 2016. This is a Presidential election year and it is the final year of the NALC's collective bargaining contract with the United States Postal Service. We are also coming off the third consecutive year with 600 plus grievances filed by the stewards and officers of Branch 599. Several zones begin 2016 with no union steward which will need to be covered by Branch officers.

Breaking News

One more CCA was converted to fulltime regular carrier effective December 26, 2015!

Information

On November 13, the US Postal Service announced that it had made \$1.2 billion in operating profit in Fiscal Year 2015. This marks the second consecutive year in which the Postal Service's operating profit has exceeded

\$1 billion, NALC President Fredric Rolando said in a statement following the release of the agency's 2015 financial report. This is a remarkable achievement for a government entity that receives no taxpayer money and whose business model until recently was seen by some as being unsustainable. Equally important, he said, this impressive performance results from two ongoing structural factors: As the economy continues to improve from the worst recession in 80 years, letter revenue is stabilizing. And as the Internet drives online shopping, package revenue is skyrocketing, boding well for the Postal Service's future.

The president observed that the annual report arrived just as USPS was preparing for its busiest time of year. *Historically, the Postal Service does well financially during a fiscal year's first quarter, since that October through December period includes the always-busy holiday season, Rolando said. That's expected to be all the more true this year, he said, given that USPS was projected to deliver 15.5 billion pieces of mail in December—not only cards*

and letters, but also an estimated **600 million packages**,

with the latter an increase of 10.5% over last year's volume. The president said that these financial results were neither a fluke nor a one-year wonder. *Fiscal Year 2015 is the third straight year when the Postal Service has recognized an operating profit—that is, the money it earned by selling stamps and services exceeded the costs of delivering the mail.* In fact, he said, in the past two years alone, USPS' earned revenue actually left its operations \$2.4 billion in the black. Moreover, the changes stem from structural factors—an improving economy and the increase in online shopping.

Any talk of deficits, losses or red ink has nothing to do with the mail, Rolando said, but rather with congressional politics: the 2006 decision by a lame-duck Congress to compel

the Postal Service to pre-fund its future retiree health benefits. USPS is alone among public and private entities in the United States in being required to pre-fund these benefits, he noted. *No one is obliged to do this for even one year in advance*, Rolando said, *yet the 2006 law forced the Postal Service to pre-fund 75 years' worth of future retiree health benefits. If Congress fixes the pre-funding fiasco it created, the president said, the Postal Service will be able to focus on addressing the evolving communications landscape while continuing to provide its customers—residential and commercial alike—with the world's most-affordable delivery network.*

The Associated Press story about the report noted the Postal Service's \$1.2 billion operating profit in Fiscal Year 2015 and other positive news, and it quoted two people—NALC President Fredric Rolando and USPS Chief Financial Officer Joseph Corbett, with Rolando quoted more than Corbett. The Federal Times story had a good headline (*Postal Service revenue gain allows 'limited flexibility' to invest*) and it did an effective job of getting in both good and bad financial news.

***) Imagine a customer walking into his/her hometown post office, going to the clerk and signing over his/her paycheck for deposit or asking to take out a small, short-term loan. Sounds crazy, right? But it wasn't that long ago that post offices acted as banks. And if Senators Elizabeth Warren (D-MA) and Bernie Sanders (I-VT) have their way, post offices will be the people's banks once again. The reasons these senators have decided to make postal banking part of their legislative agendas is not primarily because it's good for the Postal Service, but because it would benefit the poorest class of Americans—those known simply as *the unbanked*. That it also might financially aid the cash-strapped Postal Service is a side benefit. USPS could partner with banks to make a critical difference for millions of Americans who don't have basic banking services because there are almost no banks or bank branches in their neighborhoods, Warren wrote in a Huffington Post op-ed in 2014.**

The Birdseye View

The following article is dedicated to the numbers because numbers tell the truth and never lie! As I have been involved with the National Association of Letter Carriers for over 42 years, there has always been one thing that we all have in common, our numbers. We started with a badge number... now you have an EIN employee identification number. The day comes when you get your own route number and associated vehicle number and some people never change that first route number their whole career, but this is quite rare unless you are one of the few who bid on a route that senior carriers thought they couldn't get awarded but you bid anyway. We always said it doesn't cost anything to place a bid. Of course getting your own route also leads to something you have to deal with every day, your base numbers from inspection of your route. *How you going to be today* is asked before you have your final receipt of mail. Believe it or not some of you never know what to answer because you don't even know what your base time numbers are and many don't care to know, or leave themselves to the magic of manufactured numbers by someone that also has no knowledge of your route or its base numbers. Then this leads to a number of other scenarios and some number of disputes as well. When you fail to meet the manufactured number it may lead to unauthorized overtime or unprofessional estimate charges. Then comes a grievance number your steward will have to file to defend you from the discipline that could have been avoided if you are professional at your job and know how to properly make an estimate in accordance with the M-41 Handbook – Letter Carriers Duties and Responsibilities. When we don't learn to do our job correctly and leave it to the whim of others that also don't know, it puts a burden on a number of others and to the Union and the Postal

Service as well. Even in years when we are showing an increase in operational profits due to the efforts of hardworking employees, we also have had a record number of grievances that impede that hard earned profit from our sales of products and services. Yes the Postal Service itself imposes many unnecessary issues itself, but all parties are responsible and that is the numbers that don't lie.

As we go through the holiday season there are a number of records continuing to be broken; amount of package delivery well exceeded the records of first quarter of fiscal year 2015. This will also lead to another successful year of operating profit in spite of the burdens financially placed upon the US Postal Service for the past 10 years. Without the prefunding imposed the Postal Service would have made operational profit for every year, even through the entire Great Recession. Numbers never LIE!

Now focus on the numbers of our own organization, NALC Branch 599, and what percentage of our members are actively involved. Out of our 546 active letter carriers, 517 are union members...that equates to 94.7% that support all of our collective bargaining cost for the 29 non-members that receive the same benefit from contract negotiations. Out of the total 127 CCAs, 101 are members...that equates to 79.5% are members, supporting the 26 non-members in all negotiations that affect all CCAs. Overall active membership is 91.8% support the remaining 8.2% that accept the benefit that is provided by our collective bargaining expense. We welcome all carriers to be members and join in the collective efforts that we fight for every day for working class letter carriers and their families. We will have contract negotiations in 2016 that will be hard fought and expensive, every penny worth of effort in the tough

economic times we are in to keep from giving back hard fought wages, benefits and working conditions. The last contract negotiation that went through negotiation, mediation and arbitration for over a year cost the union over \$2 million. For all those non-members it was free, the Numbers Never Lie. Someone once said, *Liams never figure and figures never lie!*

Now as much as I appreciate all the active and retired members, we average about 45 members at each branch meeting and that is continuously all time lows for this branch that is still actively pursuing everything that is beneficial for all union and working families in America. We are veterans, voters, community activists, and we pledge to the flag of the United States of America. God Bless America and God Bless the National Association of Letter Carriers. Happy New Year... hope to see more numbers in 2016.




