hear the term class warfare and everyone wants to create jobs and help our suffering middle class and those living in poverty, why would anyone want to destroy good middle class jobs? The answer is simple, PROFIT, and the way to get more is to take away something that was earned by someone else. That is what Venture Capitalists do. They know how to run a business and destroy thousands of good jobs and make a few better ones and write-off the losses so that the tax payers get the bill. Be very careful of who you think is looking out for you, especially when there is a large amount of greed involved. There was a recent article in the local newspaper that compared postal services around the world and it concluded that in nations that were strongly educated and well managed there was no difference in the excellence of workers whether they were government or private workers. It did establish that countries that were struggling and especially those that are at the third world tier, services were poor when these services were from government or private sector. This theory probably would apply to almost all labor intensive type industries.

Arbitration and Insurance

No news yet from the arbitration hearings and whether our contract will be any better than what the other crafts' unions have agreed to or received from their arbitration. As long as we still have collective bargaining rights that some in congress would love to take away, we will faithfully represent the

members of this union and work hard to keep enforcement of all our agreements. One example when you shop for your health benefit plan this year...notice that NALC has one of the few plans that decreased its premiums and it was the largest decrease of any plan offered. Our plan is always one of the top rated plans available to federal employees. There were a lot of questions regarding changing from PPO to OAP last year and many of my providers were not in our network, but I wanted to stay with the same doctors and my visits went from having a \$20 co-pay to only paying just over \$12 out of network for my visits. As long as we have a union and NALC has a health plan, it will be the plan I choose.

Know Your Rights

We have ordered some new cards for all our members to carry and the ones we have ordered will have Weingarten Rights on one side and Miranda Rights on the other. It is so you know your rights at all times when you might be interviewed by management or a postal inspector. You should always request representation just so none of your rights are violated or any negotiation of any agreement is offered, due to the Union being the sole bargaining unit representative in all agreements. When in doubt of any action or any requirement that you are instructed to sign on a document that you are not familiar with, request that you have the opportunity to review it with your Steward or a Union Officer.

Better safe than sorry since there seems to be some gotcha operations going on that need some scrutiny.

We are scheduled for some Dispute **Resolution Training provided for** Stewards and their counterparts in management; they will be training together and hopefully this will help settle some of the tremendous numbers of grievances that are stacking up at the B-Team level. While we are on the local subject, we have received another large amount of excessing letters for the clerk craft and that means that there will be withholding of residual routes with future no successful bids. Our Carrier Technician will still be converted as they occur unless there are any carrier events of excessing in the carrier craft. While the Postal Service has eliminated some Postmasters, Mail Handlers and Clerks, there is still a shortage of Letter Carriers and that will continue unless something happens in this election that will continue the financial devastation of the US Postal Service that started in Congress and can only end in Congress. Soon we will know the answers...let's hope they will be good for all our citizens, not just a

stewards and officers the continued



1, 2012: The APWU has negotiated a retirement incentive agreement that awards eligible full-time career employees a \$15,000 payment in two installments, President Cliff Guffey has announced. The first installment will be \$10,000; the second will be \$5,000. "Our goal was to achieve an incentive for members who are ready to end their postal careers; to ensure that no groups of employees are excluded, and to lessen the hardships of excessing for those who remain," Guffey said. "This agreement accomplishes those objectives." The \$10,000 payment will be made on May 24, 2013; the \$5,000 payment will be made on May 23, 2014.

Proposed Bylaw Changes and Our Future Direction

At the October 4, 2012 Union meeting, we found some technical problems with one of our proposed bylaw changes. Also, there were some scheduled delivery problems with our news-letter. So as the bylaw committee chairman, those bylaw changes were pulled and will be resubmitted in our newsletter next month, and then the bylaw changes can be voted upon the following month. We do feel that most of these bylaw changes are in the best interest of our membership. Every change that we bring to the Union meeting will be openly discussed on the floor and if the membership decides that it is not needed, we all can go on with our lives.

No one is going to be upset with the will of the membership because we want everyone to know the real facts of our entire operation. This is the reason we felt the unification of the TLC was the right thing to do.

Now every dollar that comes into our hall is deposited into our building fund or operating account. There are no separate accounts with the total revenue any longer. All of our funds are under the same umbrella and the total revenue figures are given to the members at the monthly meeting. Now only the Union members can decide what to spend and how to divide these funds outside of the everyday bills. This is the best change that has been accomplished during this administration's term. Two separate term officers should not decide how to spend the income that was derived from our hall's capabilities. So now all of our income is under the leadership of the officers that the membership elected and only the membership can decide what to do with those funds.

Our Union hall belongs to all its member Letter Carriers, past and present, not the officers in charge. So let's continue to work for the entire membership and not allow a few members to disrupt or accuse those of us who are trying to provide everyone with the

real facts of our operating funds including the past funds that were in the TLC account. The figures that were presented at the October 4, 2012 Union meeting were derived from the 990 forms. These forms were sent to the IRA by our former CPA, Mr. Collazo, who worked for TLC during those particular years. I realized that some of our members that disputed those figures were past TLC board members. So why didn't they know the salaries of their officers?

In closing, if anyone wants to know or see the figures from our accounts in the past in order to guide them in what directions we're going in the future, we will be glad to present that information. Please don't be surprised or mad at us when you discover those figures. In the final analysis, you, the membership, can
