V. PRM DIRECTOR UPDATE

Director Dennis presented on the following highlights:

- The 10 weeks of summer kicked off last week. Alex and Trinka presented the Movies in the Park check presentation at city council
- Speedo wants to have an event in MLK park and invite youth. They are hosting swimming clinics and Long Beach will bus kids to the official speedo event in Irvine
- Hoops After Dark had a very successful season. Currently working to see if we can extend the program for another 5 years.
- Animal Care Services- Veterinarian, Dr Natasha Wood will be committed to staying at the center. They plan on having more pop up adoptions events
- In August the budget process will get restarted with community input

VI. LONG BEACH GOLF FESTIVAL UPDATES

Trinka reported that we had to raise prices on the threesomes. We have two confirmed title sponsors, Air Products and Coast Aluminum. Still working on final sponsorships and some additional silent auction items are still needed.

VII. STRATEGIC PLANNING UPDATE
