Brief Summary of the 2022 Legislative Session

Educator Friendly Bills That Passed:

One has provided funding to help raise support staff salaries to \$15 per hour. Since are already above this minimum hourly rate, so will be in a good position to negotiate salary this next year.

Educational Bill We Stopped:

Our union dues may come out of our paychecks directly. We defeated the bill that would have taken this option away from educational unions and given districts control of our recertification application as well as creating unreasonable roadblocks to this process. The bill's intent was clearly to kill support staff and teacher educational unions. As a reminder, without a union there is no Collective Bargaining Agreement, "the contract," and due process as well as other rights would have been no longer assured.

Non-Educator Friendly Bills That Passed:

The testing bill actually added testing to our plates and did not do as promised and decrease it.

Parents may now sue school districts if they think the school is making their children uncomfortable by teaching sensitive subjects. Rules for how this law will be applied have not yet been released.

Parents may now sue teachers because the parents do not like a book that is being used or disagree with the content of a specific course. Rules for how this law will be applied have not yet been released.

Any person may object to and request a ban of materials/books used in curriculum or in school media centers/ libraries. Rules for how this law will be applied have not yet been released.
