BITS AND PIECES

These are reprints of 2 emails that were recently sent to all LACOA Owners:

Sent 5/31/23: RUNWAY 13/31 WILL CLOSE JUNE 1 AT 0700 AND RE-OPEN JUNE 3 AT 0600 !!!!!!!!

The grass runway is still available during this time. Please access the grass runway from the airport entrance road / taxiway leading to BB/CC ONLY.

USE CAUTION FOR MEN AND EQUIPMENT!

ATTENTION: RUNWAY 13/31 will be closed on June 1 AND June 2!!!

As part of our long term plan to maintain our airport and after exhaustive discussions with 4 different contractors, the *LACOA Board of Directors* has decided to crack fill the runway as a cost effective stop gap measure that we anticipate getting 2-3 years out of before major repairs and/or replacement of the runway is necessary. The runway will be closed for 2 days for crack filling and weed abatement. A follow up reminder email will be sent 24 hrs in advance.

The Grass runway will be available during the work. Please access the grass runway via the entrance road East of the approach end of 13. USE CAUTION FOR MEN AND EQUIPMENT!!!!!!

Additionally, we have signed a contract with Plote Construction to replace the ramp areas between rows 6-7 and 11-12. We anticipate this work to take approximately 4 days in the first week of June timeframe. Only those specific ramp areas will be affected at that time.

When ramp area work is complete, the entire taxiway and the "newer" ramps between rows 5-6 and 8-9 will be crack filled. seal coated, and re-striped. Additional information for any closures will be communicated as the time approaches.

We appreciate your patience and understanding with these closures as we continue to ensure our airport is positioned for another 50 years of success.

That frees up some cash from this year's pavement work to address other pavement issues around the airport. Financially, we're looking strong this year, and we have recently invested some of our long term cash reserves into a short term CD to take advantage of the current interest rates. Our snow plowing costs came in under budget this year due to the minimal snowfall, and that money will be put towards our much-needed maintenance and repairs.
