

SCREENING ZONES

Nearly all 50 states require or recommend symptom screening. The EEOC* has also enabled employers to conduct screenings, take temperatures and more.

- Branded privacy partitions with wheels easily move for shift changes and evolving requirements
- Standard social distancing reminders like floor decals and symptom posters, plus mobile sanitizer stands

SCREENING FOR LOSS OF SMELL, FEVER

Screening lines compromise safety and privacy so efficiency *and* effectiveness need to be prioritized.

- Adding Scent Check[™] for at-home or worksite smell testing is "the best indicator for COVID-19," more reliable than fever or cough, study says**
- Branded screening forms can be customized to the requirements of your state or locale
- Confidential medical folders ensure privacy and required separation from personnel records

COMMUNICATE SAFETY MEASURES

Prominently display requirements and mandatory facility expectations for safety and conditions for entry.

- Posters in multiple languages make it clear whether employees should go home or to the hospital when symptomatic
- Policy folders for employees explain emergency paid sick time procedures and benefits
- "Screened" stickers for guests

Having a point person at each facility is a critical administrative responsibility

- Custom badge talkers
- Policy folders from HR



CONTACT TRACING


For employees and guests, easy tracking procedures improve the speed to slow the spread

- Two- and three-part forms allow fast information dispersal
- Budget pens can be kept by users



EMPLOYEE DIRECTIONS

Custom postcards with on-the-spot messaging are necessary for people who do not pass a screening



▲ UPON ARRIVAL

Temporary pop-up vaccination clinics can be held indoors, outdoors or in a drive-up format - depending on climate. All sites should display clear signage upon arrival to indicate parking areas, designated entrances, safety requirements and screening procedures.

- Durable outdoor banners clearly identify the clinic location from a distance
- A-frame sandwich board signs or corrugated plastic yard signs are easy to place and remove, and can direct off-site employees to parking or entry points

5 CHECK-IN STATION

Ensure sufficient staff and resources to help move patients through the clinic flow as quickly as possible.

- Retractable banner stands can provide reminders about needed materials, and can be easily transported to multiple locations
- Promote social distancing and one-way traffic flow with repositionable floor decals
- Place hand sanitizer stations at the entrance and exit
- A kiosk with acrylic divider provides a barrier to limit contact at check-in

6 VACCINATION STATIONS AND POST-VACCINATION MONITORING

Ensure the safe delivery of care during vaccinations.

- Fabric partitions provide privacy and separation between vaccination stations
- Use seat decals to mark available, socially-distanced seating for post-vaccination monitoring

PRE-CLINIC PROMOTIONS

Advertise upcoming vaccination clinics to employees

- Posters can be displayed in common areas
- Mail postcards to reach off-site employees
