It is dues paying time again. Aerie dues are \$48.00.

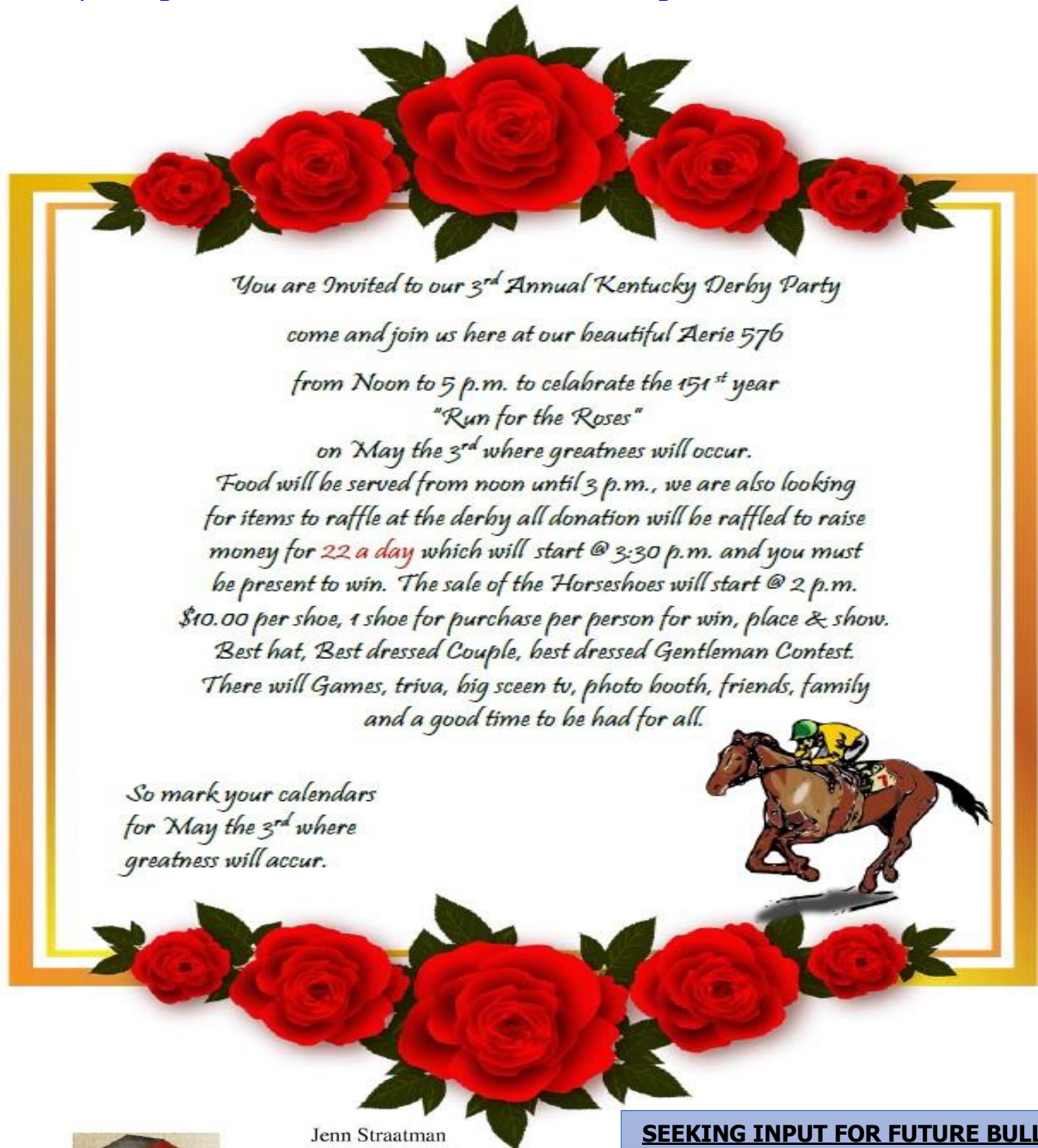
Auxiliary dues are \$30.00 for non-benefit members/\$31.00 for benefit members (the amount of dues needing to be paid is shown on your membership card).
