Introduction

Clinical supervision is emerging as the crucible in which counselors acquire knowledge and skills for the substance abuse treatment profession, providing a bridge between the classroom and the clinic. Supervision is necessary in the substance abuse treatment field to improve client care, develop the professionalism of clinical personnel, and impart and maintain ethical standards in the field. In recent years, especially in the substance abuse field, clinical supervision has become the cornerstone of quality improvement and assurance.

The M.E. Green House offers a clinical supervision program for those seeking to become a Certified Alcohol and Drug Counselor (CADC), Licensed Clinical Addiction Specialist (LCAS) and License Clinical Mental Health Counselor (LCMHC in NC)

Melani Green is the clinical supervisor for this program. Melani is a Certified Clinical Supervisor with the North Carolina Addictions Specialist Professional Practice Board. She is also an approved clinical supervisor for those seeking Licensure as a Licensed Clinical Mental Health Clinician in North & South Carolina

The MEGH Supervision Program includes:

- Face to face and/or on-line clinical supervision in the ratio of 1:40 of direct service with focus on utilizing the 12 core functions and increasing competency of clinical skills.
- Guidance in diagnosing, conceptualizing and treating clients with substance use disorders and dual diagnosis.
- Resources to help supervisee prepare for the AADC examination.
- Psychoeducation on substance use disorders.
- Learning about local services and resources, including types of treatment, levels of care, and referrals
- Learning the ins and outs of legal and ethical guidelines and mandates to ensure best practices.
- Access to clinical resources to support group in areas such as clinical documentation
- Access to Continuing Education Opportunities
