Actions: -

Opening prayer was rendered by Dr. Adenekan.

Last minutes was rendered by Victorian Moji Alabi and it was adopted by Victorian Mrs Titi Adenekan.

Victorian Ijelu thanked members for the success of 51st Anniversary celebration and their efforts and contributions towards the Association.

Victorian Mrs Adeola Afolabi passed the special message sent by the Proprietor (Chief Olaniyan). She said that the Proprietor was very happy and thanked members of the VHS/VC UK & Europe Alumni for their effort/contributions and for keeping the flag up. Proprietor key words to members were integrity, honesty, satisfaction and for us not to be over ambitious.

Victorian Adeola also commented members for their contributions towards the success and graceful occasion. She also said that members from other Chapter were asking about how we have put things together for a successful 51st Anniversary celebration.

It was agreed that the Alumni name should remain VHS/VC UK & Europe/NI Alumni as it is until further notice and when a new guideline is set out by the UK Government. (due to Brexit issue).

Victorian Ijelu informed members that the Alumni Headquarter in Nigeria has set up a Committee involving UK, EU, NI and USA Chapter in order to work together for the growth of VHS/VC Alumni worldwide.

It was agreed that Victorian Ola (Welfare officer) to represent VHS/VC UK, Europe and NI Chapter in Social/Welfare Committee that was set up in Nigeria. Her duty is to feed back to the Association with their plans/decisions made by this Committee. Victorian Ola confirmed that she has had a contact with Social/Welfare Committee in Nigeria, and they promised to get back to her with the next meeting date.

Victorian Eugene was nominated to join the Constitution Review Committee in Nigeria.

Victorian Titi talked more about what was required to opening the Association account with Metro Bank. Requirements are names of the

signatories (Vic. Ijelu, Vic. Adegbite and the Treasurer), a completed application form and to be submitted with a copy of the Association Constitution.

Majority agreed to go for Metro Bank who is more association friendly than other conventional Banks who are stricter with their requirements.

After a long discussion on the Association yearly contribution, it was agreed that members should not contribute any money for the year 2020 due to Pandemic issue but the Association can accept free will contribution from members who are willing to contribute.

It was agreed that Annual contribution is £120.00 as it has been stipulated in the Association Constitution and no payments should be made until the account has been opened.

It was also agreed that members name that are willing to contribute can be unanimous and vice versa (optional).

Victorian Alhaja Latifat suggested that a financial report or statement of Association account should be prepared and ready for members to access for accountability and transparency.

Prince Olaniyan suggested that Executives should check the welfare of members that have been very active in the past.

Meeting was adjourned by Victorian Toyin and seconded by Victorian Ola Beckley.
