The meeting started with an opening prayer rendered by Dr. Adenekan.

Victorian Ijelu started explaining the purpose of today's meeting and he thanked everyone for sparing their time to honour the meeting. He also apologised for not providing the previous minutes available for today's meeting. He talked briefly on the last meeting and apologised for the system error that occurred during the last meeting.

Victorian Ijelu explained briefly about the drafted Constitution for VHS/VC UK & EUROPE Alumni and thanked Victorian Obibi for his help/support in preparing the document.

Victorian Moji read out the agenda for today's meeting and Victorian Ijelu asked Victorian Obibi to explain more about the drafted Constitution.

Victorian Obibi talked briefly about the drafted Constitution and then asked members to make any suggestions towards any amendment. He talked about the name of the association and asked members to decide which name they prefer to use. He talked about the responsibilities of members and annual matters of the association. He also asked members to agree on the name of the association and everyone voted and agreed on **VHS/VC UK&EUROPE ALUMINI.**

Victorian Moji asked if the association is a charity organisation. Victorian Obibi explained that the association is not a charity organisation and the

association nothing to do with the charity organisation. He then talked about opening an account with Metro Bank.

Dr. Adenekan asked about the position of the associate in the Constitution and Victorian Moji said that will can be discussed during A.O.B.

Victorian Moji asked Victorian Obibi to please clarify few points in the Constitution – the full meaning of ECOM; the duties of Grand Patron and Grand Matron and lastly the members contribution/fee.

Victorian Obibi explained the full meaning of ECOM which is Executive Committee of Members.

Victorian Ijelu explained that we all know that Chief Olaniyan who is the HVS/VC Proprietor of the School is the Grand Patron and Matron can be election in future election. He throws the issue of levi to members to decide and everyone agreed that members should contribute a minimum of £10 Monthly which is equivalent to £30 per quarter.

Victorian Victoria asked about what percentage will be sent to Nigeria from members contributions.

Victorian Ijelu explained that no money will be sent to Nigeria and if there is any need for members to contribute towards any project in Nigeria it would be discussed during future meetings.

Victorian Victoria also explained about how contribution should be spent and managed. She suggested that money should be giving to members whenever they celebrate any occasion, such as birthday, children weddings etc. She said by doing this it gives member sense of belonging to a caring association.

Prince Olaniyan argued that there will be no money left when we start given members money during every celebration.

Victorian Eugene concord/agreed with Prince Olaniyan regarding to given money to members from the member's contributions.

Although the line was not really in order to hear Victorian Charles properly, but I perceived that he did not agree with both Prince Olaniyan and Victorian Eugene and every member has the right to the money contributed.

Victorian Beckley also suggested that members should be given gifts whenever they are having an important celebration. Such Wedding and birthdays etc and individual can also contribute money amongst themselves. She also said members needs to inform the association beforehand.

Victorian Haastrup agreed with Victorian Beckley with regards given gifts from the contribution.

Victoria Ijelu suggested that the money should be given to members only during important celebration. Such as Bereavement and not for birthday celebrations. However, money issue will be discussed another due to time constraint.

Victorian Adenekan also agreed with regards to money should be to members during Bereavement.

Victorian Moji referred to the point raised earlier by Dr. Adenekan regarding Associate members responsibilities in the Constitution. She asked for more clarity especially their input and contributions to association.

Victorian Charles did not agree that associated members has not right as HVS/VC Associate members.

Victorian Eugene and Prince Olaniyan strongly agreed that as long as associated members contribute financially means that they have equal right and responsibilities as VHS/VC members. Such as right to vote and decision making etc.

Victorian Ijelu suggested that this issue can be discussed in future meeting and also the appointment of the executive also can be carried out.

Victorian Ijelu later asked Victorian Obibi to look into the role of Associate members and their criteria of them joining VHS/VC old school Alumni.

Prince Olaniyan explained more about the work that has been carried so far regarding the Website design also encouraged members to on what name the domain should be. He gave about three names and asked members to choose their favourite name and he also promised to write the three options on the WhatsApp forum. He gave members option to decide and to select the right name domain asap and to reply on WhatsApp forum.

The was adjourned by Victorian Ijelu and seconded by Victoria Adenekan till next Sunday starting from 4.pm.
