

ORDINANCE 2-13

**AN ORDINANCE SETTING FORTH ALL STOP INTERSECTIONS WITHIN THE TOWN OF ORESTES, ESTABLISHING A FINE, AND REPEALING ALL PREVIOUS PORTIONS OF ORDINANCES PERTAINING THERETO**

WHEREAS, I.C. 9-21-1-3(a)(7) authorizes a local authority, with respect to streets under the jurisdiction of that authority, and within the reasonable exercise of police power, to designate an intersection as a stop intersection and require all vehicles to stop at one or more entrances to the intersection; and

WHEREAS, the Town Council of Orestes has heretofore enacted Ordinance no. 1466 providing for certain stop intersections within the Town of Orestes, and allowing the erection of stop signs at such intersections together with various amendments thereto on various occasions; and

WHEREAS, the Council now desires to restate and adopt a comprehensive ordinance setting forth all stop intersections within the Town, establishing a fine for violations, and repealing all previous ordinances pertaining to the same.

BE IT THEREFORE ORDAINED by the Town Council of Orestes as follows:

**SECTION ONE:**

FOUR-WAY STOP INTERSECTIONS

The intersection of Oak and Superior Street.

STOP INTERSECTIONS

East Broadway Street shall stop for North Superior Street.

East Broadway Street shall stop for North Prospect Street.

North Leota Street shall stop for West Oak Street.

South Lotus Street shall stop for West Oak Street.

North Main Street shall stop for East First Street.

Michigan Street shall stop for East First Street.

Michigan Street shall stop for East Broadway.

West First Street shall stop for Leota Street.

West First Street shall stop for North Superior Street.

West Second Street shall stop for North Superior Street.

East Second Street shall stop for North Prospect Street.

North Ontario Street shall stop for East Broadway Street.

Ontario Street shall stop for Oak Street.

South Ontario Street shall stop for East Sycamore Street.

North Prospect Street shall stop for East First Street.

North Prospect Street shall stop for East Oak Street.

Sycamore Street shall stop for South Superior Street.

Birch Street shall stop for South Superior.

Walnut Street shall stop for South Superior.

Huron Street shall stop for East First Street.

Huron Street shall stop for East Broadway.

Erie Street shall stop for East Broadway.

**SECTION TWO:**

Any person violating the directives set forth within Section One while operating a motor vehicle shall be fined a sum of not more than One hundred dollars (\$100.00).

**SECTION THREE:**

Ordinance 1466 and all parts of ordinances amending Ordinance 1466 as it pertains to Stop Intersections, including Ordinances 3-97, 2-99, and 4-05, are hereby repealed effective upon passage of this ordinance and publication as by law required.
