• Signing up for auto deliveries means we will schedule and deliver every 30-60 days based upon your delivery zone and fuel usage. For customers with high usage a 14- or 21-day delivery option will be available.

Delivery typically occurs monthly September – April as a convenience to our customers. Until we have a history of delivery to your address, we may make deliveries that are less than 100 gallons. (If we deliver based on our scheduling system and you take less than 100 gallons no small load fee applies.) The longer you remain a customer the better we can estimate your typical usage accurately and adjust your delivery schedule accordingly.

**Please note:** If you take under 50 gallons during a month our system may indicate that you are not ready for a delivery until the following month. (Ex. If your first delivery was September 9<sup>th</sup>, your next might not be until October 11<sup>th</sup>)

- Customers who use less than 400 gallons a season or request delivery for less than 100 gallons are NOT eligible for auto delivery
