7. Refer to acceptance packet and follow the steps detailed in it involving the Flight Booking Form, eVISA Application, and Team Member Response Form. **Do not** apply for the eVISA prior to receiving an acceptance packet.
8. Receive email with final instructions and details about attending the scheduled ministry trip.

DEPOSIT AND ACCEPTANCE INFORMATION:

A mandatory deposit reserves your spot on the ministry trip pending review and approval of your application. Space is limited on most trips. Acceptance is based on a first come, first serve basis. If a deposit is not received with your application, your application will not be processed, Global Kingdom Mandate Alliance reserves the right to deny any application.

COST OF TRIP INFORMATION:

The cost of the trip includes round trip airfare from the following major airports in the east coast U.S.: New York (LGA, JFK) NJ (EWR), Baltimore (BWI), Washington DC (IAD, DCA), Charlotte NC (CLT), Charleston SC (CHS), TX (DFW, IAH), Miami FL (MIA), Fort Lauderdale FL (FLL), and Atlanta GA (ATL). You are responsible for any increase in airfare cost from the hub city as well. Also included in the trip is your hotel room (based on double occupancy), breakfast, and all internal transportation (unless otherwise noted). You will be responsible for your travel cost to and from the hub city airport, personal spending money, the cost of snacks, meals on travel days, gratuities where appropriate (waiters, bus drivers, housekeeping, etc.) passport and eVISA fees, country exit tax (if applicable), immunizations where required, and COVID-19 testing fees.

- All payments must be made in U.S. dollars.
- The full trip payment and completed application must be received in our office by the due date, see the acceptance package for details.

CANCELLATION & REFUND POLICY:

If you are not selected for a team, your deposit will be refunded in full. If for any reason, a team member cancels within 30 days of departure the full deposit will be forfeited. In addition, you will not be refunded monies that Global Kingdom Mandate Alliance has paid out on your behalf to secure hotel, transportation, and food service reservations. If for some reason you cancel your trip within 4 weeks of your departure date or after your airfare has been purchased, you will not be refunded your ticket price. Also, you will forfeit your deposit. Any amount over and above the deposit, airfare, late cancellation fees (where required), and reservations that are not donations will be refunded to you by check.

DONATION POLICY:

Tax deductible donations can be applied towards your trip. Ministry Trip Awareness

MINISTRY TEAMS:

Everyone on the trip functions as one team.

MINISTRY CONDITIONS:

Some of the places and hotel conditions we may encounter can seem primitive in comparison to what you are used to. The pace required on these trips can be rigorous, emotionally draining, and physically exhausting. Each team member must be able to stand for long periods of time, climb steps, bend, and lift up to 50 lbs., continuing to function autonomously, even under trying conditions. We ask that you prepare "to run and not grow weary, to walk and not faint" and work diligently to prepare your physical body for the ministry trip (ex. exercise and clean eating). On the other hand, the rewards of being instrumental in God pouring out His Spirit on His people are immeasurable!

MINISTRY MEETINGS:

The key word is flexibility. Ministry meetings are often held in local churches, but sometimes are held in open-air arenas, the bush, homes, or large tents. Global Kingdom Mandate Alliance works side by side with the local church and ministry leadership. Meetings or economic mission objectives are subject to change at any time during a trip.

QUESTIONS AND ANSWERS

Q. How do I apply and prepare for a ministry trip?

A. Step 1: Complete an online application and submit the deposit of \$500. Step 2: Once your application has been processed, we will email you a confirmation email. In this email we will explain what documents are missing, all required documents, and general information about preparing. Step 3: Once we have received and reviewed your references and you have been accepted, we will email you an acceptance package that will include all the information you will need to prepare for the trip. Step 4: It is now your responsibility to carefully and thoroughly read through the acceptance package and follow the instructions to prepare for the trip. Information included in the acceptance package is booking flights, obtaining eVISAs, COVID-19 test requirements, vaccinations, etc.

Q. What is covered in the cost of a trip?

A. The trip cost includes round trip airfare from one of twelve major airports in the U.S. when flights are booked in advance. Also included is your hotel room (double occupancy), travel insurance via the airline, the cost of daily meal (breakfast), and all ground transportation.

Q. What is not covered in the cost of a trip?

A. The trip does not include travel cost to and from the hub city airport, personal spending money, the cost of daily meals (lunch & dinner), snacks and beverages, gratuities where appropriate (waiters, bus drivers, housekeeping, etc.), passport and eVISA fees, COVID-19 testing fees, country exit tax (if applicable), and immunizations where required.

Q. Can I upgrade my ticket to Business or First Class?

A. Yes, you will however need to pay the difference in price of what the standard flight would cost. Please notify the GKMA Administration Team at: gkmalliance@gmail.com prior to booking.

Q. Can I have a single room on the trip?

A. Usually no, but exceptions can be made. Roommates are an important part of the trip and we don't want you to miss out on that fellowship. We will consider making an exception depending on room availability and hotel accommodations. You should email us at gkmalliance@gmail.com and explain the reason you would like the single room. Of course, if it is approved, there will be an additional cost that will be incurred, and you will pay this on the trip.

Q. Can I arrive late, leave the trip early, or stay later than the rest of the team?

A. No, the team will arrive together and depart together.

Q. Does Global Kingdom Mandate Alliance offer a scholarship for ministry travel?

A. No, there are no scholarships available for international ministry trips.

Q. Can I receive donations for a trip?

A. Yes. Tax deductible donations can be made on your behalf up to the date the trip departs. All donations will go to Global Kingdom Mandate Alliance and are non-refundable. GKMA will attempt to apply donations in the manner requested and directed by the donor. Instances where donations would go to GKMA and applied at our discretion, would include, but not limited to receiving donations after the trip commencement date, receiving donations exceeding the trip balance, or cancellation of the individual's trip.

Q. Do I need training before attending a trip?

A. Yes, training is required, and details will be provided in the acceptance package.

Q. What are the age limits for trips?

A. 18 or older

Q. What vaccinations do I need to get?

A. We highly recommend the following website <http://wwwnc.cdc.gov/travel/destinations/list> regarding what type of vaccinations or medications to take when going overseas. If there are required vaccinations, we will let you know in the acceptance package.

Q. Do I need a passport?

A. Yes. You will need your passport BEFORE you can apply for ministry travel and your eVISA(s). Due to recent changes in the law, processing time for passports can be extremely slow. All U.S. team members are required to have a valid passport. Application forms to apply for a passport are available at post offices. Currently, United States passports are valid for 10 years. If you do not have a passport you may need to pay for expedited processing. If you need to expedite your passport, call Swift Passport Services at 1-877-917-9438. The GKMA Administration Team will provide information on applying for your eVISA(s) in the acceptance package.

Q. Are there fees for checked bags?

A. There have been changes to airline policies and flights. Domestic flights and some international destinations permit (1) free checked baggage. **If you have a cost for checked baggage you will be responsible for the cost.** You will pay for your baggage when you check-in at the airport. Please check with your airline for baggage allowance and costs. Global Kingdom Mandate Alliance is not responsible for any damaged baggage. Also, if you want an advance seat assignment, you will also be responsible for the cost.

Q. What is the cancellation policy?

A. If you are not selected for the trip, your deposit will be refunded in full. It is your responsibility to cancel your flight arrangements with the airlines, they will determine if your airline ticket can be refunded or credited.

COVID-19 Cancellations: If you choose to cancel because of the uncertainty of COVID-19, Global Kingdom Mandate Alliance's cancellation policy still applies.
