ALL COMPETITORS WHO WISH TO PARTICIPATE IN A NORA92 EVENT MUST ACT RESPONSIBLY AT ALL TIMES AT THE EVENT, BOTH ON AND OFF TRACK. ALL COMPETITORS MUST ACT IN ACCORDANCE WITH THE RULES AND REGULATIONS. 3) I WILL ENSURE THAT BEFORE I ENTER ANY EVENT I AM COMPETENT AND THAT ANY VEHICLE I USE IS SAFE AND FIT FOR COMPETITION AND THE NATURE OF THE COURSE.

4) I WILL SATISFY MYSELF BEFORE TAKING PART IN ANY COMPETITION THAT THE VENUE IS ACCEPTABLE TO ME WITH REGARD TO ITS FEATURES AND PHYSICAL LAYOUT AND THAT I AM SATISFIED THAT IT IS SAFE FOR ME TO TAKE PART.

5) I WILL NOT ENTER OR TAKE PART IN ANY COMPETITION WHERE I HAVE DOUBTS AS TO MY SAFETY.

6) I WILL INFORM NORA 92 IMMEDIATELY AND IN WRITING IF, FOR ANY REASON I BELIEVE THAT I AM NO LONGER ABLE TO SATISFY THE TERMS OF THIS LICENCE OR I BECOME AWARE THAT I HAVE BECOME UNABLE TO COMPETE DUE TO A PHYSICAL OR OTHER DISABILITY.

7) THAT THERE IS AN INHERENT RISK OF INJURY OR DEATH BY PARTICIPATING IN MOTORSPORT EVENTS.

- 2) I CONFIRM THAT THE APPLICANT IS COMPETENT TO PARTICIPATE IN EVENTS OF THE TYPE TO WHICH THEIR ENTRIES RELATE AND THAT MACHINES ENTERED WILL BE SUITABLE, SAFE AND WILL COMPLY WITH THE REGULATIONS FOR THOSE EVENTS.

If you are caught misusing drugs or alcohol in any way you will be immediately asked to leave. NO EXCEPTIONS UNLESS YOU HAVE A MEDICAL CERTIFICATION WHICH YOU WILL BE ASKED TO PROVIDE EVIDENCE OFF.**
 - 2. Absolutely no riding of electric powered bikes in the paddock. You may push your electric bikes to the track for the race but any riding off the track and you will be immediately asked to leave. Please make your children aware of this.**
 - 3. If you are given a High Visibility vest to wear trackside you must not use a mobile phone at any time. If you are caught using a mobile phone you will be asked to leave. If you request a vest (to which a £10 returnable deposit must be paid) then you will be allocated a place to stand on the track. You must not leave this designated place and you must not be caught filming or checking race results as the race is happening. This is for the safety and welfare of all riders.**
 - 4. All generators and music MUST be turned off by 11pm. Our events are YOUTH events and the youth riders need their sleep and must not be kept awake by loud noise or otherwise.**
 - 5. The parking area for motorhomes and vans is not owned by ourselves and this is rented out for each event. ANYONE caught throwing litter or riding their motorcycle through the parking area will be immediately asked to leave. This area is rented to us by a local landowner and it is to be respected at ALL times.**
