Poverty Level

DataUSA – Monte Vista, CO has a population of 4,072 people with a median household income of \$37,810. The median income is well below the state median income of \$80,184. The Monte Vista Community has a 22.2% poverty level which is much higher than the state average of 9.7%. The needs of children and families remain the same with high poverty levels and unemployment.

Parent Involvement

The organizational design allows for Program Governance to be supported by parents through the Parent Committee and Policy Council. A hundred percent (100%) of parents that currently have children enrolled in Head Start are automatically on the Parent Committee. Parents are encouraged to join the Policy Council. We currently have one parent and one community member serving on the Policy Council. We try to get a parent representative from each classroom.

Policy Council meets on a monthly basis and are responsible for the direction of the Head Start Program including program design and operation. There has been a combination of virtual meetings and in-person meetings offered.

Preparing for Kindergarten

MVHS uses the evidence-based Creative Curriculum and the School Readiness Goals in preparing children for Kindergarten. We will work with Marsh Elementary and Sargent Elementary on scheduling transition meetings and attending open houses.
