
# From the Desk of the Secretary

# Sovereign Grand Commander Sands - Official History Maker

The election of Sovereign Grand Inspector General Basil L. Sands to the Office of Sovereign Grand Commander of the United Supreme Council at its 45th Triennial Session made him become the first non-American to hold the highest office in Prince Hall Scottish Rite Freemasonry.

With nearly 60 years in Freemasonry, Sovereign Grand Commander Sands has been active in multiple Masonic branches. He has been a member of Royal Eagle Lodge No.1 since 1959. An Honorary Past Grand Master of Prince Hall Grand Lodge of the Commonwealth of the Bahamas, he was an integral part in the establishment of a Consistory in the Bahamas. He served as the first secretary of James E. Morley Consistory No.73 in 1962. By his efforts and service, he was crowned a Grand Inspector General in 1968. He was elevated to "Active" status as a Sovereian Grand Inspector General and appointed Deputy of the Orient of the Bahamas in 1979. He served as Deputy for the Orient through 2004 until he was elected to the Office of Grand Minister of State for the United Supreme Council in 2004. In 2006, he was elected to Lieutenant Grand Commander and Chief Executive Officer of the Rite, and, subsequently, elected to Sovereign Grand Commander in 2016.

Roosevelt and DePaul Universities. She prepared the application and acquired the largest grant awarded from HUD Region III office in Philadelphia, Pennsylvania for 10.5 million dollars. The project groundbreaking was November 2, 1995 and was completed November 8, 1996. She worked with the architect and the management company to determine floor plans; room layout; furniture plans; staffing plans and rent-ups. She met with the architect and the general contractor regularly to ensure that budgets and schedules were consistent with the estimates, resulting in the completion of the Scottish Rite Tower Building 45 days ahead of schedule.

SGLLR Brown was the "only" female involved in this project. Having a clear understanding of the fraternal needs of the Supreme Council, she prepared the package for their 501c(3) to which they were granted.

Her resume includes her work as Administrative Secretary Dept. Head at IIT Research Institute, Contract

Proposal Writer for the Dept. of Defense and other Federal and State Agencies, Legal Secretary at the University of Chicago Law School, Administrative Assistant to the Deputy of Municipal Prosecution Division for the City of Chicago. She also served as the only "African American" Court reporter for Cook County Courts and Administrative Secretary at the University of Illinois Dental School in the Dept. of Periodontics.

Finally, SGLLR Pauline James Brown continued to use her skills and knowledge to obtain Haven Towers 501c(3) grant from HUD Chicago Office to develop the 1st Senior Housing Complex on the Southside of Chicago in 1999 in the 8th Ward, using the same management and architect skills that she previously used in Philadelphia. SGLLR Pauline James Brown is the only female ever listed in the history of the United Supreme Council. She is definitely someone you should know.



# The Scottish Rite Double Headed Eagle

The symbol most widely recognized as Scottish Rite Masonry is the Double-Headed Eagle of Lagash. It is one of the oldest Royal Crests in the existence. This symbol has been in use at least a thousand years before the Hebrew Exodus from Egypt and more than 2,000 years before the building of King Solomon's Temple.

Records indicate that in the days οf modern early Freemasonry the Double-Headed Eagle was first used around 1758 by a Masonic body in Paris. That Masonic body was known as "The Emperors of the East and West", and controlled the advanced Degrees then in use. It is these degrees that became a precursor of the Ancient Accepted Scottish Rite.

Our Double-Headed Eagle features the white-ribboned motto, pendant from the hilt of the sword to the point, and displaying the Latin "SPES MEA IN DEO EST", which translates "My Hope Is In God". As a Scottish Rite Mason you will recognize this phrase from the lessons taught in the 31°.

Generally, the symbolic meaning of this symbol in the Scottish Rite is that of duality contained in or resolving itself in unity. Among other things, it reminds us that as man we are composed of both body and

spirit, that he is both temporary and eternal; that both good and evil exist in the world and that we must perpetually espouse good while opposing evil. It also reminds us that knowledge comes both from study and insight; and that our obligations are both to ourselves and to others; that both faith and reason are necessary.


The various symbols of the Scottish Rite do not easily reveal their meanings to us; furthermore, there may be many meanings to any one symbol. Only after thought and reflection do they fulfill their function and begin to trigger ideas in the mind.

# Some Signs and Symptoms of PTSD

According to mental health professionals, post-traumatic stress disorder (or PTSD) is a mental condition that results in a series of emotional and physical reactions in individuals who have either witnessed or experienced a traumatic event.

Events that cause the individual to fear for personal life and wellbeing—such as a car collision or other accident, a physical or sexual assault, long term abuse, torture, a natural disaster, living in a war zone, or life-altering experiences like the death of a loved one—can all spur the following PTDS symptoms...

# 1. Physical Pain

PTDS will often begin with a series of common physical ailments—such as headaches or migraines, dizziness, fatigue, chest pain, breathing difficulties, and stomach and digestive issues.

#### 2. Nightmares or Flashbacks

It's very common for those with PTSD to suffer nightmares or flashbacks—a symptom known as re-experiencing—in which the patient suddenly and vividly re-lives the traumatic event in a repetitive manner. Re-experiencing can enter dreams or come on suddenly in waking images or sensations of physical and emotional pain and fear. It may cause both children and adult sufferers to have sleeping difficulties and anxiety leaving the safety of home.

#### 3. Depression or Anxiety

Mental phobias, which professionals deem as irrational and persistent fear and avoidance of certain objects or situations can cause extreme anxiety in PTSD sufferers to the point where it causes paranoia and depression.

#### 4. Withdrawal

Both adult and children PTSD patients with solid social lives and interests may suddenly lose interest in favorite hobbies, activities, and friends that they used to be very passionate about. Seeking out risky behavior can also be a form of escapism through drug or alcohol abuse, or thrill seeking.

#### 5. Avoidance

Avoidance of physical or mental stimuli that reminds them of a past traumatic event can be typical of PTSD. For example, those involved in tragic car collisions may avoid driving and commuting in a car whatsoever. I could also cause particular avoidances of places or people or places that are reminiscent you of the traumatic experience.

#### 6. Repression

Repression, or the intentional blockage of memories associated with a past event or experience is also a symptom of PTSD. The patient may destroy pictures or memorabilia of a time in their life or attempt to distracting themselves by throwing themselves into work.

#### 7. Emotional Numbing

It's very common for those with PTSD to try to numb their feelings. After all, it's hard to suffer pain when you don't feel any emotion at all. Emotional numbing often leads to the gradual withdrawal and eventually the complete isolated from social circles.

#### 8. Hyper-arousal

It's common for those with PTSD to suffer jitters so sever that it becomes impossible to relax due to the fear of threats. These individuals can be characterized as "on edge" and "jumpy" or easily frightened.

# 9. Irritability

This state of constant fear and paranoia can cause extreme PTSD-associated irritability, indecisiveness, and a total lack of concentration, sleeplessness, and difficulty maintaining personal relationships.

#### 10. Guilt and Shame

Those PTSD patients who can't get past their negative experience may find it difficult to move forward and maintain a healthy life. They may blame themselves and constantly relive the event, wondering how they could have prevented it. Often immense shame and guilt will set in if they blame themselves for the tragedy.

# Norman's Nook—From the Archives of William L. Norman

Many men are listed among the rolls of prominent Prince Hall Masons yet it is difficult to find photos of many of them either dressed in Masonic regalia or photographed in the midst of a Masonic service. This photograph from the archives of Grand Inspector General William L. Norman was taken on December 19, 1945 and will, hopefully, clarify the linkage of John Sengstacke to the Illinois Prince Hall Masonic ranks.



John Herman Henry Sengstacke (November 25, 1912 – May 28, 1997) was an African-American newspaper publisher and owner of the largest chain of black newspapers in the country. He was also a civil rights activist and worked for a strong black press, founding the National Newspaper Publishers Association in 1940, to unify and strengthen African-American owned papers. He served seven terms as president of the association, which by the early 21st century had 200 members.

He was the nephew of Robert Sengstacke Abbott who founded the Chicago Defender. Sengstacke ran the newspaper after his uncle's death in 1940. In addition to the Defender, he also published the Michigan Courier in Detroit, the Tri-City Defender in Memphis and acquired the Pittsburgh Courier in 1966. He also worked with multiple Presidents of the United States of America in desecrating the press corps. Under President Franklin D. Roosevelt, he accomplished the goal of having black reporters admitted to presidential press conferences. Under President Harry Truman, Sengstacke was appointed to a armed forces commission. This appointment served as a strong blow to desegregation in the military.

Brother Sengstacke was a member of Mt. Hebron Lodge #29 of Chicago. He is pictured with Right Worshipful Brother Rudolf Johnson, 32° (left) and Most Worshipful Brother Ashby B. Carter, 32° (right) above giving a charitable donation to the Grand Lodge on behalf of the National Newspaper Publishers Association.
