



The Breakfast of Scholars Program was introduced by Menelik Consistory #49, Valley of Springfield with the aim of mentoring African-American young men in the Central Illinois community between the ages of 8 and 16 years old.

The last breakfast was held in Peoria, IL on Saturday March 21, 2015 at the Boys and Girls Club on the south side. The food for the Breakfast was donated by Bob Evan's Restaurant. The focus of the breakfast was a discussion about responsibilities and life skills for males. Fraters from Menelik Consistory lead the conversation, C-I-C SP. Richard H. Andrews II 32, SP Nicklaus A. Shultz 32 and Bro. Charles Miner from the Jurisdiction of New York, also spoke and provided the youth with personal experiences to iterate the aforementioned points. Their input along with other local youth organizations proved to be invaluable. We had on hand about 60 young men from different organizations, Boys and Girls Club, Common Place, Alpha's and the Think Program.

More Breakfast of scholars programs will be held at other locations throughout Central Illinois, The Valley of Springfield. # How Well Do You Know Your Rite—DR. SUMNER ALEXANDER FURNISS

#### GRAND INSPECTOR GENERAL DARYL ANDREWS, 33°, WESTERN CONSISTORY #28



Born in Jackson, Mississippi on January 30, 1874, Sumner Alexander Furniss moved to Indianapolis with his family as a small child. He attended public

schools and the University of Missouri. Before graduating he returned to Indianapolis at the age of 17 to study medicine under Dr. E.S. Elder while attending the Medical College of Indiana. He graduated second in his class from the Medical College in 1894. That same year he successfully competed for a internship at City Hospital, becoming the first African-American professional to serve at the hospital.

In 1895, Furniss started his own practice in which he would serve for more than 50 years. While practicing medicine, he also practiced his civic duties at high levels. In doing so, he eventually became very active in the political arena.

Furniss held memberships in the Marion County and Indiana medical societies and the American Medical Association. A lifetime member of the Flanner House Board, he was also a charter member and first president of the Senate Avenue YMCA. He also served as the President of the Indianapolis Branch of Booker T. Washington's National Negro Business League. In these roles, he touted moral character and conservative principles as the pathway to success.

His civic efforts drove him into politics. He was elected the second African American on the City Council in 1917 and was a member of the Marion County Republican executive committee. Service in these areas lead to his selection as a delegate to the Republican National Convention from 1918 to 1922. His competency in leadership, intelligence and poise are the characteristics that made him a trusted figure within the State of Indiana. These characteristics made him a prominent figure in fraternal circles.

In the 1900s, Furniss had become an active and prominent member of multiple fraternal organizations. He held memberships in the Grand United Order of Odd Fellows and the Knights of Pythias. He was a founding member of the lota Lambda Chapter of Alpha Phi Alpha Fraternity. By 1908, he had advanced to the 32nd Degree of the Ancient Accepted Scottish Rite of Freemasonry. Shortly after being crowned a Grand Inspector General, his elevation to higher offices within the Rite was swift. By 1916, he had earned election as Grand Minister of State of the United Supreme Council of the Northern Jurisdiction. With Sovereign Grand Inspector General Richard E. Moore stepping down from the office of Lieutenant Grand Commander in 1920, Furniss gained election to the office of Lieutenant Grand Commander at the 13th Triennial. Having served faithfully

in this role and several others, he was elevated to the Office of Sovereign Grand Commander of the United Supreme Council Northern Jurisdiction in 1921 following the death of Sovereign Grand Commander J. Francis Rickards.

Sovereign Grand Commander Furniss served from 1921 to 1949. It was under his leadership, that the Cathedral was built in Philadelphia, the City of Brotherly Love. It was also under his leadership that Sovereign Grand Inspector General Frank M. Summers, the first Sovereign Grand Commander from the Orient of Illinois, was first appointed Deputy for the Orient.

**Brothers and Sisters:** 

I have a very weak voice, but I choose to exercise the action that someone said to me years ago, "that somebody ought to say something."

The young black men that comprise the Jackie Robinson West (JRW) Little League Baseball team of 2014 are not at fault. They sacrificed possibly more than each of us can imagine. They practiced for hours, days in and out and they played the game fair and square on the diamond as they were taught. They WON! But in the aftermath of a sudden, long-winded investigation, they were stripped of their title.

Some of them were possibly told they would never amount to much, if anything. Sarcastically, they were possibly told that "you think that you are better than I am or the rest of us." 

uring the period May 22-26, 2015, under the leadership of Sovereign Grand Inspector General Melvin Frierson, Deputy of the Orient, for the Illinois Council of Deliberation (ICOD), Ancient Accepted Scottish Rite of Freemasonry, Prince Hall Affiliation, Northern Jurisdiction, U.S.A. Inc., served as host for the One Hundred Thirty-Fourth Annual Session of the United Supreme Council (USCS), Ancient and Accepted Scottish Rite of Freemasonry, Prince Hall Affiliation, Northern Jurisdiction, U.S.A., Inc. The USCS was held at the Chicago Marriott Downtown Hotel, 540 North Michigan Ave.,

Chicago, Illinois.

Sovereign Grand Inspector General Frierson extended a warm welcome to Sovereign Grand Inspector General Dr. Solomon Wallace, 33°, Sovereign Grand Commander, Northern Jurisdiction, Sovereign Grand Commander Deary Vaughn, 33°, Southern Jurisdiction, the USC Convention Department, the Official Delegations, Visiting Delegations, Loyal Ladies of the Golden Circle, Members of the Masonic Organizations and Friends.

Chicago is a city of history and the host of major events. The United Supreme Council was one of those major events. Jean Baptiste Point DuSable a black man in 1799 was the earliest recorded resident of the settlement close to the mouth of the Chicago River that grew to become the city of Chicago. Mr. DuSable was a prosperous business man and a wealthy trader by profession. Because of his contributions a number of Chicago Institutions have been named in his honor.

The golf outing sponsored by the ICOD on May 21st was a grand success. The revealing of the bust of SGC Wallace was a session highlight.

On October 8, 1871, Chicago, was destroyed by fire (commonly referred to as "the Great Chicago Fire") as the result of Mrs. Catherine O'Leary's cow named Daisy, who allegedly kicked over a lit lantern in the barn. The fire burned for two days however, following the cooling of the ashes, the surviving residents began to rebuild Chicago which now stands as one of the greatest cities in the nation.



On April 12, 1983, Harold Washington was elected the 51st Mayor of Chicago making him the first Black Mayor of Chicago. Mayor Washington was elected to a second term and served to his death on November 25, 1987. He was born and educated in Chicago and was a life long politician who rose through the ranks as alderman, state

representative and congressman. Brother Washington was also a Prince Hall Mason (Harmony Lodge No. 88).

Barack Hussein Obama began his political career in Chicago as a grass roots community organizer working his way through the political ranks. He became a United States Senator. In November 2008, he was elected the 44th President of the United States of America making him the first

Black President of the United States of America. In 2012 President Obama was re-elected President of the United States of America, again making history.

In 2007 Sovereign Grand Inspector General Dr. Solomon Wallace, Sovereign Grand Commander initiated a

directive that every Orient hosting the United Supreme Council Session do it's own degree work.

As a result of this directive, on May 25, 2015, again, history has made in Chicago. Just like the City of Chicago rose from the ashes in 1871 from, "the Great Chicago Fire", the Illinois Council of Deliberation 33° Degree Team also rose to a great height and made history by making Thirty-Third Degree Masons. This was the first time this was done in the Orient of Illinois. There were Sublime Princes from the Northern Jurisdiction and abroad to include the Orient of the Far East, Orient of Eastern Canada, Orient of Western Europe, and the Orient Commonwealth of the Bahamas. In the words of S.G.I.G. Frierson, Deputy of the Orient, "this level of degree work is normally reserved for members of the United Supreme Council". The ICOD Degree team rose to the occasion and did an outstanding job. # **Essentials of Intentional Interviewing DR. JAMES LANIER RECOGNIZED**

> across the country. In the words of the authors Allen and Mary Ivey and Carlos Zalaquett:

"The book has been dedicated to James Lanier, Professor at University of Illinois, Springfield. He has been an important part of our constant movement toward a healthier, more positive orientation to human change processes."

Many brethren in the Masonic ranks know of Dr. James Lanier as a brother who has worn

many hats. He is a Grand Inspector General of Menelik Consistory #49 in the Valley of Springfield, Illinois; Past Master of Central Lodge #3; an active member in the York Rite Bodies in all houses at all levels; as well as an active member of the Ancient Egyptian Arabic Order, Nobles of the Mystic Shrine. While only a few however know that he was a Golden Gloves Boxer in past years, a few more know that he is an educator at the University of Illinois-Springfield. All in all, he is a renown Freemason, and now, a renown, educator.

In general, it is indeed an honor for one to be recognized in a dedication to an academic work most especially at the collegiate level. These works require a great deal of vetting before they can be introduced as materials to trains the leaders of the future. Contrary to fictional works, the vetting process is much more extreme.

Vetting for collegiate texts are typically done by experts and scholars within the specific field. In this process, the sources for the research must be valid and accurate and able to stand to the challenge of the scholars. The conclusions outlined in these types of books must also be able to stand a high degree of scrutiny from experts in the field before a publisher would even take a first glimpse at the work. The publisher, subsequently, engages in its own vetting and proofreading efforts to solidify the work for print. Once completed, the work is released to the designated destinations with great assurance that it is solid. While additional vetting processes may also be included in this effort, the act of vetting is the piece that secures the credibility of the work.


With regard to non-collegiate works, sources of information are verified but not validated necessarily by experts. Fictional works are done primarily for entertainment and may not require a detailed validation. Nonfictional works however do required some form of vetting if they wish to be considered credible. Conclusions from the information also should align with the sources but do not necessarily prevent the work from being published. In both instances, a major goal of the publisher is to reap profits from the sales of the works. If profit is the major driver, credibility may, indeed, be a secondary concern.


As compared with other types of works, dedications in collegiate texts are the substance of great respect and distinction by colleagues. While other non-fictional or fictional works typically contain personal dedications, many collegiate works are void of these types of recognition. In fact, individuals are not typically listed in dedications for collegiate works unless their contributions were either at a grand scale or so significant that they guided the specific course in the book. Clearly, this is the case with Grand Inspector General Lanier.



# Veterans Affairs: Burial Benefits GRAND INSPECTOR GENERAL

## MAJOR LACY, 33° For Burial in a National Cemetery

Burial benefits available include a gravesite in any of our 131 national cemeteries with available space, opening and closing of the grave, perpetual care, a Government headstone or marker, a burial flag, and a Presidential Memorial Certificate, at no cost to the family. Some Veterans may also be eligible for Burial Allowances. Cremated remains are buried or inurned in national cemeteries in the same manner and with the same honors as casketed remains.

Burial benefits available for spouses and dependents buried in a national cemetery include burial with the Veteran, perpetual care, and the spouse or dependents name and date of birth and death will be inscribed on the Veteran's headstone, at no cost to the family. Eligible spouses and dependents may be buried, even if they predecease the Veteran.

The Veterans family should make funeral or cremation arrangements with a funeral provider or cremation office. Any item or service obtained from a funeral home or cremation office will be at the family's expense.

#### **Preparing in Advance**

Gravesites in Department of Veterans Affairs (VA) national cemeteries cannot be reserved in advance.

You should advise your family of your wishes and where your discharge papers\* are kept. These papers are very important in establishing your eligibility.

At the time of need your family would contact a funeral home who will assist them with making burial arrangements at the national cemetery. You may wish to make pre-need arrangements with a funeral home.

To schedule a burial: Fax all discharge documentation to the National Cemetery Scheduling Office at 1-866-900-6417 and follow-up with a phone call to 1-800-535-1117.

### Donating Burial Flags in National Cemeteries

Most of the Department of Veterans Affairs national cemeteries display an Avenue of Flags on patriotic holidays and during special events. The Avenues consist of burial flags donated by the families of deceased Veterans and provide a unique visible tribute to all of our Nation's Veterans.

A Certificate of Appreciation is presented to the donor for providing their loved ones' burial flag to a national cemetery.

Please contact the cemetery of your choice for information on how to donate a Veteran's burial flag.

#### For Burial in a Private Cemetery

Burial benefits available for Veterans buried in a private cemetery may include a Government headstone, marker or medallion, a burial flag, and a Presidential Memorial Certificate, at no cost to the family. Some Veterans may also be eligible for Burial Allowances. There are not any VA benefits available to spouses and dependents buried in a private cemetery. You may want to ask the following questions when preparing for burial in a private cemetery:

- When responding to an offer of a "free" gravesite for Veterans, ask if there is a requirement to purchase an additional gravesite.
- If an additional gravesite is required, where will it be located and what is the cost?
- What type of trust fund does the cemetery have to protect buyers?
- Ask if there are restrictions on the type of headstone or marker that can be used to mark the grave.
- Does the cemetery require a special marker base to be purchased prior to ordering a free government marker for a Veteran's grave?
- Is there an additional cost for the placement, setting or care of a free government headstone or marker? Is it more than if a private headstone or marker is purchased?
- Is an outside container (usually called a "vault" or "grave liner") required and how much does it cost?
- Know what you are receiving and what is required by the company and have them put it in writing prior to burial.

We suggest that if burial will be in a private cemetery and a Government headstone or marker or medallion will be requested for the Veteran's grave, that the family complete, in advance, one of the following forms and place it with the Veteran's military discharge papers for use at the time of need:

- Claim for Standard Government Headstone or Marker
- Claim for Government Medallion for Placement in a Private Cemetery

Only an eligible Veteran may receive a Government-furnished headstone or marker or medallion for placement in a private cemetery. Veteran's spouses and dependent children are not eligible.
