may result in personal injury, property damage, wrongful death or other damage to me or my family, heirs,
legatees or assigns that may occur as a result of my participation in this trip or as a result of the negligence of any party, including the Released Parties, whether passive or active. I further state that I am of lawful age and legally
competent to sign this liability release, or that I have obtained the written consent of my parent or guardian.
