CLASSES OFFERED AND OBSTACLES

- Beginner Agility – formerly AGI (A&B)
 - Intermediate Agility – formerly AGII (A&B)
 - Excellent Agility – formerly AGIII
- Please refer to the 2022 rules for Agility posted on the UKC website for obstacles in each class.
- Beginner Agility A** will be open to dogs that have not earned a UKC Beginner Agility title and other restrictions as set for by UKC rules as of January 1, 2021.
- Intermediate Agility A** will be open to dogs that have not earned a UKC Intermediate Agility title and other restrictions as set for by UKC rules as of January 1, 2022.
- Excellent Agility** - The Excellent class is open only to dogs with a U-ACH title.
- **Dynamic Hurdles** – Novice class has 10-16 obstacles and Elite class has 15-24 obstacles. Open to all dogs.
 - **Tunnelers** - This class focuses on the speed and accuracy of navigating tunnels, with courses featuring between 6 and 12 tunnels, depending on the level (Novice or Expert).

EXHIBITOR INFORMATION

- The building will be available for set up at **10:00am on Friday, August 22, 2025 until 7:00pm. UNLESS HELPING WITH UNLOADING AND SET UP OF EQUIPMENT WHICH THOSE EXHIBITORS CAN SET UP CRATING AT 9:00am.**
- The building will be open at 7:00 am on Saturday & Sunday.
- Ample crating is available.
- Lunch will be available each day for volunteers.
- Entries must be on UKC entry forms.
- All dogs must be UKC registered prior to entering the trial.
- All contacts are rubberized non-slip surfaces.
- Ring rubber matting.
- There will be individual familiarization walk through on lead before the Beginner Agility and Intermediate Agility classes only for dogs entered in Beginner Agility A, Intermediate Agility A and for Beginner

Agility B and Intermediate Agility B dogs which have not earned the Beginner or Intermediate titles respectively and are not eligible to run in the A class.

- Dogs may run with or without a collar. Slip collars, prong collars, or collars with tags are not permitted. Scored performances must be done off lead. If there are obstacles for which you have not trained, bypass them for safety's sake. To receive a qualifying score, dog and handler team must have successfully completed all obstacles.
- A dog may be entered in both Beginner & Intermediate classes at the same trial. However, titles will be awarded by UKC in sequence (Beginner (U-AGI), Intermediate (U-AGII)). If a dog meets all requirements for the Intermediate title, they must complete Beginner title before the certificates or dog's record is updated by UKC. ACH points begin accumulating at the trial (date) following one in which the Intermediate title is completed. The Excellent class is open only to dogs with a U-ACH title.
- No entry fees will be refunded after closing date.
- Bitches in season may not compete. CDO will refund all but \$5 of each class entry fees if veterinarian certification is received by trial secretary prior to the start of trial. Full refund will be made if notified prior to closing date.
- Dogs must be under handler's control at all times.
- Crates may be left in the building overnight. No dogs may be left overnight.
- No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbance, fire, extreme &/or dangerous weather conditions, an act of God, public emergency or any cause beyond the control of Competition Dogs of the Ozarks or the show committee.
- No dogs under 8 weeks of age are allowed on the trial site premises.

MOVE UPS

Dogs finishing a title on Saturday may move up to the next higher class on Sunday. Move ups between trials will be accommodated if possible. A move up form will be available at the trial. Must be turned in ASAP.

HURDLE HEIGHT DIVISIONS

- Division Toy (4") – Dogs up to and including 10" at the withers.
- Division 1 (8") – Dogs over 10" & up to & including 14" at the withers.
- Division 2 (14") Dogs over 14" & up to & including 20" at the withers.
- Division 3 (20") – Dogs over 20" at the withers.

Minimum Jump Height. Handlers have the option to enter their dogs in either the Standard or Minimum Jump 8 UKC® AGILITY Height. Any dog may jump the Minimum Jump Height, regardless of age. Dogs jumping the Minimum Jump Height will be awarded placements within their actual divisions - for example, a 22" dog jumping the Minimum Jump Height of 14" will be considered for placements with the Division 3 dogs. Dogs jumping the Minimum Jump Height will have an extra 5 seconds added to their course time.

AWARDS

- Ribbons will be presented for all qualifying scores. Ribbons will be presented to top four placements in each Division. Ribbons will not be mailed.
- High Scoring Dog each trial
- High Scoring Junior Handler each trial
- Rosettes for new titles, UACH, UACHX and UGRACH. and a special embroidered UACH, UACHX and UGRACH award for your Dog!

1. All entries must be submitted on the current "Official United Kennel Club Performance Entry Form". You may use one entry form to enter the same dog in more than one activity on the same weekend.
2. Use a separate entry form for each dog entered in a club's event.
3. Mail all completed entry forms to the Event Secretary listed under the event, unless otherwise specified. Make checks payable to host club.
4. All UKC Performance events are open to any UKC registered dogs and dogs with a valid Performance Listing/Limited Privilege number, with the exception of Lure Coursing and Drag Racing. Please see the rules for each event regarding eligibility.
5. **We want you to keep the points earned at UKC Licensed events.**

Important things to remember:

- Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at www.ukcdogs.com/tl-numbers. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
- **All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/ Limited Privilege number.**
- All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.

6. The United Kennel Club complies with the Americans with Disabilities Act. If you require an accommodation, please contact the Event Chair or Secretary for this club's event.
